On behalf of the Gender Equity Office in the Ministry of Finance, I am writing to request your support for government's work to adopt the Gender-Based Analysis Plus (GBA+) analytics tool. GBA+ has been approved by the Minister of Finance to be used as part of the Budget submission process for Budget 2019 and will be reflected in the Budget Instructions template that ministries will receive later this summer.

As recently discussed at DMC, gender-based analysis is used by the Federal and a majority of provincial governments as a means of assessing how diverse groups of women, men and gender-diverse people may experience policies, programs, and initiatives.

As a first step of GBA+ implementation we are compiling an inventory of data sets that could be used for evaluating diversity and gender-based impacts of policies, programs and initiatives. This inventory will be made available across government as a tool in support of GBA+ moving forward.

Each ministry is requested, via EFO (as the executive responsible for information), to completed and return the attached inventory template no later than August 10th.

A detailed instruction sheet has been included in the attached to assist.

BACKGROUND INFORMATION =====

BC Games has reported incidents of inappropriate conduct by some young men towards about 30 female athletes at a BC Summer Games athletes' dance on the evening of Saturday July 21st.

On being informed of the incident, BC Games immediately invoked its harassment policy and procedures, and is offering support to the young women affected.

BC Games has contacted parents. (Letter went out to about 30 parents yesterday.)

BC Games is also reviewing policy and practices related to athlete special events to ensure this situation does not occur again

3. The Minister was interested in a News Release (NR) for the MLA Beggs review (Bill C-45). After getting some details of what the review is about and speaking to others on the foreseeable issues that could arise, I am going

5. WorkSafeBC's Certificate of Recognition program is bringing more vigor to the health and safety audit's baseline standard that employers need to meet in order to receive a financial benefit. This added vigor or strengthening of the baseline requirements means that some employers who were previously eligible may no longer be eligible.

 - *The safety standards certification by this program is often a pre-qualification used by many contractors in the Oil and Gas sector needed to bid for work*

We are writing to inform you that the Integrated Data Division (IDD) is transferred from the Ministry of Jobs, Trade and Technology (JTT) to the Ministry of Citizens' Services (CITZ) effective immediately. The IDD will be moved under the Office of the Chief Information Officer (OCIO), and Hayden Lansdell (with his team) will report to CJ Ritchie. The BC Stats Branch will remain in JTT under the leadership of Christine Little.

CITZ has a mandate to build corporate solutions and will provide the IDD a platform for furthering its important work across government.

JTT has a mandate to build a strong, sustainable and innovative economy. This decision enables JTT to freely deliver its mandate of tech sector development while ensuring that the IDD can concentrate on the important work of providing trusted data services to government agencies.

While the BC Stats Branch will remain in JTT, it is our expectation that it will continue to work closely with the IDD both through the continued use of the Statistics Act as an enabler of integrated cross-government data as well as on project teams addressing key government priorities.

Finally, we want to take a moment to thank Hayden Lansdell for the leadership he has provided to the IDD. There is much more to do, but Hayden has put in place the foundations for a cross-government data service that will support a more citizen-centred view of complex policy challenges.
