Request

Reporter would like to know how is the Minister advising post-secondary institutions as they develop policy for the use of legal recreational cannabis. How is the material being developed and can he see the material. What are the key issues that universities and colleges grapple with? Is it health & safety, personal rights and freedom, others?

Background

Recommendation

The legalization of Cannabis is an important issue for post-secondary institutions. B.C. universities, colleges and institutes are actively reviewing potential policy implications of the impending legislation.

Our public colleges and universities are autonomous institutions and each administration will make choices for cannabis policies that best suits their needs – exactly as they have done with alcohol. Developing cannabis policies will also affect policies in other areas such as human resources and health and safety. Just as B.C.'s legislation reflects the Province's goal of prioritizing public health and safety, we expect cannabis policies on B.C. campuses to put the health and safety of students, faculty and staff first. Each Post Secondary Institution

(PSI) will also need to be in full compliance with ~~federal, provincial and municipal~~ regulatory frameworks: ~~federal, provincial and municipal~~.

We are encouraging collaboration between Public PSIs to share best practices.

While the drafting of on-campus policies for cannabis use are the responsibility of each individual institution, the Province and the federal government are creating multiple public education resources on cannabis use, many of which will apply to B.C. campuses.

The Government of Canada is currently leading national cannabis public education and awareness efforts. To complement the federal campaigns, B.C. is developing its own provincial public education and awareness initiatives to ensure British Columbians are familiar with provincial laws and regulations, raise awareness amongst youth and parents about the health and safety risks of cannabis use, and increase awareness about the risks and consequences of drug-impaired driving. The B.C. website and information campaign is scheduled to begin in late September.

Examples of some of the federal resources applicable to B.C. Public Post-Secondary Institutions:

- The nationwide Don't Drive High campaign, which aims to educate Canadians about the safety and legal risks of drug-impaired driving.
- The federal web portal is a one-stop shop for all Canadians looking for evidence-based cannabis information about health and safety facts, talking with teens about drugs and up-to-date information about the proposed legislation. www.canada.ca/cannabis.

I wanted to inquire about whether or not the BC NDP has plans to regulate overseas agents who recruit international students, along with international student tuition fees. Will there be a cap for international tuition costs under this current government?

Background

Recommendation

Provide background:

Our government is engaging with the education sector, students and other partners to develop a balanced and strategic approach to international education that centres on a positive and quality student experience, values diversity, and considers long-term sustainability. We want to make sure the province continues to deliver the quality education experience students expect and deserve.

Recruiting agents are an important way for post-secondary institutions to attract international students. Under the BC Education Quality Assurance designation, post-secondary institutions are responsible for ensuring current and accurate information is provided to students, including advertising and recruiting by agents. There are processes in place at every post-secondary institution for any student who feels they were treated inappropriately to come forward.

Operating grants and targeted funding from the Province, as well as other institution revenues, offset the cost of post-secondary education for domestic students. On average, domestic students pay about one-third of the cost of post-secondary education.

International students are expected to pay the full cost of their education, including program delivery and support services. Government does not provide funding for international students. Public post-secondary institution boards in British Columbia have the autonomy to set international tuition fees.

And whereas many open-net fish farms have been established in Indigenous territories in the absence of adequate consultation with Indigenous governments, undermining the shared objective of reconciliation and respectful relations between Indigenous and non-Indigenous governments:

Therefore be it resolved that the Province of British Columbia consult First Nations governments, local governments, conservation organizations and industry on a transition plan to closed-containment aquaculture, including a just transition for affected workers.

Background

- **The T̓silhqot'in Nation and Province signed a moose co-management agreement on Friday that will see us work together to ensure a sustainable moose population and harvest in the T̓silhqot'in territory.**
- **This agreement accelerates our commitments under a 2016 Accord, which is a five-year road map that defines our shared priorities for economic and social improvements with the T̓silhqot'in Nation and land use certainty in the region, [s.13](#)**
- **We recognize moose are a critical source of food, social and ceremonial hunting for T̓silhqot'in communities and it's understandable that they want a stronger voice in how moose are managed.**
- **The new agreement sets a path forward for an innovative approach to shared decision-making for moose management.**
- **It accelerates work already underway for a comprehensive and lasting reconciliation between the T̓silhqot'in Nation and the Province, and reducing conflicts over lands and resources and developing strategies for consensus-building.**
- **The Province will continue to work with all First Nations across the Cariboo-Chilcotin region to ensure open, productive dialogue on moose management.**
