Background:

- A CBC article dated April 6 suggests the province has no plan to replace the service provided by Greyhound in Northern BC once the company stops service on the routes as of June 1.

Message:

- Greyhound's decision to cut service in northern and interior British Columbia is a disappointing one.
- Eliminating and reducing service along these routes will leave people vulnerable, particularly Indigenous communities, women, seniors, children and those living with disabilities.
- Minister Trevena has been sitting down with partners, stakeholders and community leaders in the communities of Prince George, Smithers, Dawson Creek, Fort St John to find safe, reliable and affordable ground transportation- to ensure continued transportation service remains in place for those who depend on it.
- Although the Passenger Transportation Board's decision requires Greyhound to continue service on most of their routes until at least May 31, it is critical we get moving on an immediate solution.

Background:

- The Child Care Fee Reduction Initiative came into effect on April 1.
- Media stories and an opposition news release have suggested issues with the rollout of the initiative.
- As of end of day Friday, April 6:
 - Of the 3,300 eligible facilities in the province, 1,689 (51%) facilities have applied to opt in.

Message:

- Everywhere I go in this province, I hear stories from parents who urgently need help with the cost of child care.
- This initiative will put money back in the pockets of tens of thousands of families to help them get ahead.
- This kind of major initiative will always generate questions and challenges.
- We're speaking with providers, addressing those questions and moving forward on this historic program.

How many providers have opted in at this point?

- We have been working diligently to help licensed child care providers opt in and pass savings on to parents, while also receiving a boost to their CCOF grant funding.
- Staff are working aggressively to adjudicate and process contracts.
- We are tracking it closely and the numbers are strong.

- Our government supports rural economies including in the tourism sector.
- In October 2017, we provided a \$612,000 grant to the district of Tumbler Ridge from BC Rural Dividend Program to support for tourism development in Tumbler Ridge.
- Approximately half of these funds were provided to the Tumbler Ridge GeoPark Society to support the community's cultural and economic development of their dinosaur and geological resources. The balance went to the District for tourism development projects such as an interpretive trail at the Visitor Centre.

- I am aware that two unions- Teamsters and IBEW – have issued 72-hour strike notices to CP Rail, effective Saturday, April 21st.

- If work stoppage or a strike were to take place, it would result in large increases to shipping times in B.C. for flow of goods moved by rail, including grain, containers, and other commodities – which sometimes last well beyond the end of the strike.

- Negotiations are currently underway and federal negotiators have been brought in.

- My staff are in touch with CP Rail and we will continue to monitor the situation closely.

April opt-in numbers are not complete – the numbers that have been provided do not reflect the current landscape.

More than half of eligible child care centres have signed up: of the 3,300 eligible facilities in the province, 2,027 facilities applied to opt in – representing 33,000 spaces out of a total 50,000 eligible spaces.

1,431 of those facilities have already been approved – representing 22,072 spaces.

Meanwhile, the Ministry is working with 523 other facilities in the approvals process to obtain more information – representing 10,153 spaces.

These may soon be included in the official approvals number.

In addition, 490 returned contracts have yet to be processed and we have not confirmed whether they have applied to opt in.

The approvals process takes some time and it's not accurate to say less than half have signed on.

On March 18 we said we sent out over 3,400 contracts, that includes providers who would be eligible for this program and providers who would not be eligible, such as before and after school care

The number of organizations that are estimated to be eligible are 2,850, which represents 3,300 child care centres, with a total of 50,000 spaces

We have approved 1,109 organizations representing 1,431 facilities and 22,072 spaces. That's 71% of facilities approved

At this time, we were unable to approve 56 organizations, representing 68 facilities and a total of 1,466 spaces. *These organizations have the option of sending us new information if they feel that the Ministry's assessment is not accurate.*

We are still working on reviewing 429 contracts representing 528 facilities, which translates into 10,258 spaces.

We also over 490 contracts recently received that we have not yet looked at, some of which will have opted in.

What we can definitely say is, as of today, 22,000 kids and their families are going to benefit from the parent reduction fee in the very first month of the program and that fee reduction applies for the entire month of April.

And that doesn't include the 10,258 spaces that we're just waiting for more information from.

VICTORIA - The British Columbia government is extending the deadline for child-care providers to opt into the new child-care fee reduction, to allow more providers to pass on savings to parents for their April child-care fees, Katrina Chen, Minister of State for Child Care, announced today.

"After waiting so many years for action on child care, we're going to make sure parents can start saving immediately," said Chen. "At the same time, we're listening to providers and assisting those who want to come on board, but who want more information to complete the process of opting in."

The British Columbia government introduced its child-care strategy in February's budget, including a \$1-billion investment over the next three years. As part of this strategy, many parents of kids in licensed care will have their fees reduced through direct payments from government to providers.

"Having government invest in families and child care is brand-new territory for providers and parents, so it's understandable that questions have come up about how it will work," said Chen. "We are going to work with providers to bring fees down and make life more affordable for parents, and we want to make sure those providers have the information and time they need."

Chen said the initial response from child-care providers to the fee reduction program has been overwhelmingly positive, with an 85% opt-in rate from the 765 providers whose contracts have been processed, as of March 24, 2018. The deadline for opting in has been extended to April 20, 2018, to give providers more time, particularly because the startup is occurring over spring break when many providers are away.

Effective April 1, 2018, parents at participating facilities will see savings of up to:

- * \$350 per month for group infant and toddler care.
- * \$200 per month for family infant and toddler care.
- * \$100 per month for group care for children aged three years to kindergarten.
- * \$60 per month for family care for children aged three years to kindergarten.

All licensed child-care providers, who pass along fee reductions to parents, will also receive a 10% funding boost for any spaces that government funds through the new initiative.

"At the Association of Neighbourhood Houses of BC, we will certainly opt in to the child-care fee reduction initiative," said Deb Bryant, CEO of ANHBC. "We're glad to be part of an initiative that provides some financial relief to the families we serve."

ANHBC is a non-profit organization that provides child care to hundreds of families across the Lower Mainland through its community-based programs. ANHBC has more than 1,000 licensed spaces in all.

"It is so good to finally see some recognition of the importance of child care to the well-being of families and neighbourhoods, not to mention the health of our economy," said Bryant. "We expect that this is the first of many steps toward building an affordable, accessible, quality child-care system in B.C., and we are ready and willing to participate."

Quick Facts:

* Under Budget 2018, the Province is investing more than \$1 billion into child care over the next three years to help lay the foundation for a universal child-care system that will provide access to affordable, quality child care for anyone in B.C. who wants or needs it.

* The provincial investment in early care and learning is supplemented by approximately \$153 million in federal funding over three years, beginning in 2017-18, through a bilateral early-learning and child-care (ELCC) framework agreement.

* In 2018-19, the Province will focus on creating more infant and toddler child-care spaces throughout the province, as well as reducing monthly child-care costs for B.C. families.

* In addition to the child-care fee reduction initiative, another affordability measure will be introduced in September 2018. The new affordable child-care benefit will help reduce child-care costs for lower-income families by up to \$1,250 per month, and will support 86,000 B.C. families a year by 2020-21.

Our legislation is designed to protect British Columbians when offences happen in B.C. so most appropriate that the feds are investigating this one. The legislation – FOIPPA and PIPA are under CITZ. The Privacy Act is under the AG so any questions or info about that act is best directed there. I understand the case in the U.S. is a class action suit as this situation does fall in a grey area re: data kept off-shore. Red Light Cameras

Background:

- On March 8th, the provincial government announced it will upgrading the existing red-light camera program to identify and ticket the fastest vehicles at intersections with a high number of speed-related crashes.
- In the coming months, analysis of crash and speed data will inform decisions about activating ISC cameras for speed enforcement.
- New signs will warn approaching drivers about this enhanced intersection enforcement.

Message:

- This is about slowing down the fastest drivers at intersections where we know that speed is a factor in causing accidents, so everyone on these busy corridors will be safer.
- There is very little public sympathy for those who flout the law and speed excessively through known, high-crash intersections.
- There will be signs to warn drivers, and those who ignore them will be ticketed.

Is this just a new kind of photo radar?

- This is about safety and is more transparent than the photo radar program which ended in 2001.
- This action will help slow down the fastest drivers at intersections where we know that speed is a factor in causing accidents.

J.P. Case (Children and Family Development)

Background:

- JP commenced litigation arising from the removal of her children and her subsequent involvement with MCFD.
- After a lengthy trial, on July 14, 2015 Justice Walker issued a decision on liability only, which found negligence, misfeasance and breach of duty.

- On Aug. 31, 2017, that ruling was overturned by the Court of Appeal. The three-judge panel found the lower court justice relied on unqualified expert evidence, so the judgment has been set aside and a new trial ordered.
- Government received notice of JP's application for leave to appeal to the SCC on Monday, October 30.
- On March 8, 2018 the Supreme Court denied her leave to appeal.

If asked about previous comments made while in opposition:

- We want to acknowledge the stress that difficult situations like these can cause to the children, families, social workers and others involved.
- Any public comments made on this case had their basis in a court decision and in the best information available at the time.
- The Court of Appeal judgement provides greater clarity.
- Ultimately, we rely on the courts for guidance.

Legacy Council/Chinese Museum

Background:

- Chinese news media reported that the Premier committed to continuing the Legacy Initiatives Advisory Council's work to preserve Chinese Canadian history.
- The council's work has been extended until March 31, 2018 to complete the remaining legacy projects. Ministry staff contacted LIAC members directly prior to the December 31 deadline, and the extension was processed in January 2018.
- There are 3 projects to be completed:
 - Commemorative plaques in Lytton and Yale (basically complete, unveiling to take place with communities in Spring or Summer when convenient for the communities).
 - Province is in ongoing talks with the City of Vancouver to plan a commemorative monument.
- Once these projects are finished, the Legacy Council's work will be complete.
- A celebration event to unveil the Celebration Book was scheduled for last Friday, February 23 in Vancouver.
- The event was cancelled due to a severe winter storm.
- Tourism, Arts and Culture is currently working to reschedule a celebration event with the members of the council and the community.

Message:

- Our government is committed to continuing the work on the Chinese apology and the protection of Chinese Canadian history.
- The tremendous contribution of Chinese Canadians to British Columbia history has not been catalogued and recognised to the extent it should be.
- This is important work and we appreciate the efforts of those on the Legacy Initiative Advisory Council to shine a light on the contributions of Chinese British Columbians to our society.

- The Council was engaged to provide the government with advice to ensure successful implementation of the legacy projects.
- They have worked incredibly hard on these projects, including providing recommendations of plaques and content for the Celebration book.

Winter maintenance contract changes

- BC's road maintenance program is executed by our road maintenance contractors, with specifications set by the ministry contract. The program has some of the highest safety standards in North America.
- 26 of the 28 maintenance contracts in the province will be tendered and awarded in 2018 and 2019 through an open bidding process. Those contracts will go into effect when the existing contracts expire.
- Service Area 11 (Cranbrook/Fernie area) is the first under the new contract, which Mainroad East Kootenay began executing in fall 2016.
- The new maintenance contract requires even higher standards and a more proactive approach when a winter weather event occurs.
