What (if anything) can you tell me about Rich Coleman's role in getting the BC Investment Management Corporation involved with financing Timberwest starting in or around 2008 (when Coleman was minister responsible for forests)?

More generally, is there a general description of what the minister responsible for forests' relationship with companies in the industry should be?

Is it oversight an oversight role, or one of helping, or some kind of combination? This may be a more philosophical question appropriate for the minister's office

The reporter's request is linked to a court case involving Ted Leroy Trucking v. Timberwest. They filed an application to get Rich Coleman to testify. An email appears to indicate that Rich Coleman, as Minister at the time (2008), was the go-between to get financing for Timberwest from B.C. Investment Management Corporation.

Former youth in care uses martial arts to explore his feelings and his future

NANAIMO - Even though Trent Jack, 19, is able to look after himself, it's nice to know that Shane Jung, a WMMAL featherweight champion and Battlefield Fight League bantamweight champion, has his back as a mentor and friend.

Trent has been in government care on and off since he was three years old, so it helps to have a mentor who's capable and tough.

June 4-10, 2018, marks B.C. Child and Youth in Care Week, a tradition that originated eight years ago because of advocacy by youth in and from care. It's an opportunity to celebrate young people like Trent for their diverse talents, accomplishments and resiliency, and show them that there is a community that supports and stands with them.

Trent began his training in Ladysmith at Shaku Martial Arts when he was 13. He was being bullied in elementary school. At that time, he said he did not know how to stand up for himself.

Like many kids in care, Trent needed every ounce of resilience he could muster. His memory of the day when police came to his house, and removed him from his parents' care, is particularly scarring.

For some time, Trent was in and out of his parents' home. When he was nine, he went to live with his grandparents permanently. By the time he was 17, he said his own immaturity led to conflict with his grandmother. He was on the streets, involved with drugs and alcohol. One day, he ran into his sister, and soon

afterward, his grandfather.

"It was their disappointment in me, when they saw the condition I was in. That was the beginning of me getting things together," Trent explained.

He also credits Jung with being a part of that shift as well. "He knew what I was going through, because he'd lost his best friend to drugs."

Trent becomes animated when he refers to his participation in an annual canoe trip, Travel Journeys, which he has done before. This summer, he'll journey to Tacoma, Wash., on a Tribal Journey with the Kw'mut Lelum Child and Family Services Society.

Born in Duncan, Trent is a member of the Stz'uminus First Nation. He sits on the Nanaimo Youth Council where, along with other youth, he focuses on advocacy and issues of poverty reduction, mental health, career exploration and helping other young people explore interests through hobbies.

He works at a local restaurant and takes courses through Vancouver Island University, to complete his adult high school diploma. He then intends to enroll in a carpentry course. Social work is also in the back of his mind, for the future.

Trent said that in high school, it hurt to hear other kids talking about vacationing with their parents, having family dinners, going shopping, and all the stuff most kids take for granted, and that many foster kids have never known. "I'm used to burying my feelings as deeply as possible," he said.

He said he wants every foster kid to know that they are not alone, although he recognizes from experience that "at some point in time, they will indeed feel absolutely alone."

That's why being involved in advocacy really matters to him. "I can give my two cents, and I get to see how happy everyone is to be a part of it, to be there and know that we fit in. It's had a really positive impact," he said, adding that advocacy work keeps him busy.

Trent imagines one day having some of his own kids, saying that he "wants to be the kind of parent to them that he never had."

He said he's "definitely going to enroll them in kickboxing," so that , like him, they can build self-discipline and self-esteem.



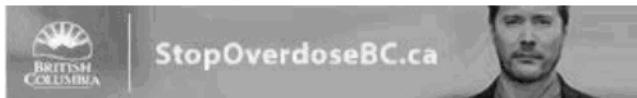



1. Be brief – **under 400 words** maximizes your chance of media pick-up. **One page is ideal.** <<Rare has been the NR coming thru that is one page – pls make it something you strive for, whenever possible.>>
2. NOTE: If more than three different quote sources are used in the release (e.g. two ministers and two stakeholders), **PLEASE USE** the legacy NR template (see note below) with the separate quotes section. <<Emphasis is mine – far too often lately we are seeing NRs with four different quotes embedded throughout the NRs – let's pls try to stick to "three or more – put them separated out at the bottom of the release". I chatted with Grant Kerr and the only reason they haven't been consistently pulling them down into this format is because of time constraints – so thx for your attention to this.>>
3. **Quick Facts:** Lesser benefits can be described further on in the release, along with more detail on the problem and solution. Bullets are preferable. << These Quick Fact sections are also getting long in some releases – pls **ONLY** include benefits/details that are specific to the subject matter which is the focus of the NR (as opposed to random links to orgs that are ministry stakeholders etc.>>
