We conducted four interviews in Vancouver yesterday with Minister Ralston. Three Korean outlets and BIV. Some suggestions from MBR:

1. The minister encourages us to add the capacity to monitor the Korean news in BC.
2. He believes we should have a public engagement strategy for several communities (not just Chinese and South Asian)
3. He also thinks an engagement strategy should include advertising. Case in point, when we were at the Vancouver Korean News office, their current issue was on display with a full page ad from the BC Liberal party wishing the Korean community a Happy Chuseok (Korean Thanksgiving).

I realize these items have probably already been considered. They might be raised again. In the meantime I will confirm if the Korean outlets are on the editors distribution list.

Here are the details:

Room setup:

- Room sets will all be theatre style seating to maximum capacity, with space for wheel chairs and scooters near the back.
- Seating capacity ranges from 140 to 250.
- Head tables will be set for the number of Ministers plus the Chair of the session (see below for names)
- There will be one table mic per Minister.
- There will be one or two floor mics for delegates, plus a wireless mic for the larger rooms.

Panel format

- Executive members will chair the session.
 - Building a Better BC (introduce and moderate) Councillor Singh
 - Building a Better BC (thank) Chair Kaehn
 - Growing Prosperity (introduce and moderate) Mayor Tait
 - Growing Prosperity (thank) Director Marcotte
 - Investing in People (introduce and moderate) Mayor Gaetz
 - Investing in People(thank) Councillor Eliason
 - Safe Communities (introduce and moderate) Mayor Baldwin
 - Safe Communities (thank) Chair Gay
- Chair welcomes and introduces each Minister and each Minister has 2 minutes to review portfolio responsibilities and priorities within their ministry.
- Chair will open the floor to questions. Delegates will line up at floor microphones.
- Chairs will moderate this portion to ensure things keep moving along.
- Only elected officials ask questions.
- The session is open to media (as are all sessions) but media do not get to ask questions.

Hi Sarah,

Everyone in the press gallery receives the TNO Morning Report free of charge. It is the same report that you receive. It went out this morning at around 06:21am.

That report includes key selections from the VS, Prov, TC, G&M and NP. It also includes all the talk and TV summaries and transcripts from the night before. What it does not include are any transcripts from media conference calls, Legislature hallway scrums, press theatre events, events in and around the Legislature - any and all live events TNO is tasked with monitoring and transcribing.

Those all can be added with a single click of a button. Please note, not selectively, it is all or nothing.

Should we decide to add that content to the report there will be two short-term results - more clients will ask TNO to transcribe content but not post it on TNO so it is omitted from the report and the press gallery will soon begin pushing for direct access to TNO so they can get the transcripts asap rather than the following morning when the report is deadlined to be sent out.

Another aspect for consideration is the press gallery currently pays nothing for TNO report access. Our normal rates are:

TNO Direct User - \$4,287 per person per year prorated
TNO Indirect User - \$221 per person per year flat fee

The gallery has asked for access to TNO in the past. It has never come to fruition because it either balked at the cost or the executive declined the request.
