Boundary-Similkameen MLA Linda Larson is joining the calls on the federal government to hold a referendum on a proposed South Okanagan national park reserve.

Larson has wrote to Osoyoos town council, urging them to follow the lead of Oliver, which made a formal request for a referendum last week.

"My office has been deluged with phone calls and emails and I have been approached by many constituents asking for a referendum," she writes. "As MLA for the Boundary-Similkameen representing our mutual constituents in the Legislative Assembly of BC, I am writing to ask your Mayor and Council to also request the Federal Government and Parks Canada hold a referendum during the next Federal Election in October of 2019."

"I strongly feel that it is in the best interests of the people that reside in the South Okanagan-Similkameen," she continued.

Larson has been a long-standing and vocal opponent of a national park in the South Okanagan.

A poll released in January found that 76 per cent of Oliver, Osoyoos, Cawston and Keremeos residents want a referendum to be held on the proposed park.

Opponents of the park are worried about a loss in access to the backcountry as well as hunting and grazing rights.

Parks Canada is accepting public comment on the concept until March 15.

- In the fall of 2016, BC Hydro identified Alternative 2: to Nicola Substation as the leading alternative for the transmission project.
- A decision on the preferred alternative was expected to be made in early 2019.
- The project timeline has been updated. The earliest target in-service date (ISD) has moved to 2025 from 2022. This change takes into account the time required to acquire regulatory permits, approvals and authorizations, and the time required to complete field studies and construction. The schedule will continue to be updated as the project progresses.

Regarding the water shortage on Vancouver Island:

As mentioned, no IN as of yet on the Van Island water shortage. However, BC Hydro spokesperson Stephen Watson has done a lot of media over the past week or so on the situation. I have reduced an article from a CP story in which he was quoted to the following KMs:

- BC Hydro is warning that nearly two months of unusually dry and cold weather has created drought-like conditions in watersheds serving the Sooke, Port Alberni, Comox Valley and Campbell River regions.
- Hydrologists say the water supply forecast for this time of year has reached a record-breaking 50-year low.
- Vancouver Island needs several significant rain storms in the coming weeks in order to bring water levels back up before the snow pack melts.
- BC Hydro's water supply forecasts for a lot of their systems on the Island are only showing 75 per cent of normal for water inflow looking (toward) the summer.
- BC Hydro is looking ahead and preparing in case the weather stays dry through the next few months.
- BC Hydro will manage through it, working with local governments and regional districts, Fisheries and Oceans Canada, and others.
- BC Hydro will continue to inform and update the public and work together with stakeholders to manage through the dry conditions.
- BC Hydro will conserve as much water as possible going into the spring and summer, and in case of a very dry summer, the utility will have water in reserve to pump into salmon spawning streams in the fall.

Regarding the biomass energy strategy coming out of phase 1 of the BC Hydro review:

Catalyst's Crofton pulp and paper mill does **not** have a biomass energy EPA with BC Hydro.

Catalyst's Powell River mill has a biomass EPA that is due to expire in 2021. Nanaimo Forest Products' mill in Nanaimo has a biomass energy EPAs that is due to expire in 2028.

I have attached BC Hydro's house note on the biomass energy strategy.

The following KMs are from our NR:

- Acting on phase 1 of the BC Hydro review, to keep rates affordable, BC Hydro will minimize energy costs related to biomass energy by acquiring biomass energy from facilities with existing electricity purchase agreements due to expire prior to March 31, 2022, but at a lower volume than has been historically delivered and at a lower price than current contract terms.
- BC Hydro will procure this energy through a combination of load offset and/or energy purchases. Load offset is energy generated by a BC Hydro customer that offsets the energy the customer currently purchases from BC Hydro to serve its own needs.
- Most biomass energy generators are in the pulp and paper sector. The holders of these expiring biomass agreements are largely forest companies that are important economic anchors and play an important role in the environmentally sound disposal of wood waste from sawmilling operations and other sources.
- As a separate initiative, government will work with industry to develop to transition over time to production of renewable energy products, such as renewable natural gas and biocrude, from wood waste to develop longer-term economic opportunities and contribute to achievement of CleanBC climate action targets.

Gas Prices

Background:

- Over the weekend of March 16-17, gas prices in Metro Vancouver rose to an average of \$1.51 per litre.
- Gas prices are now the highest they've been in the region since October 2018.
- Media have focused on commentary from Dan McTeague, a self-described senior petroleum analyst for GasBuddy.com, who says prices could climb 10 cents per litre over the spring.
- Dan McTeague has also said the "new normal" for gas prices over the summer could be around \$1.60 per litre.
- The Opposition has previously claimed rising gas prices are connected to government's carbon tax, which is scheduled to increase on April 1.
- Each \$5 increase to the Carbon Tax is equivalent to about 1 cent/litre on gas prices.

Message:

- I understand people's frustration, and want to be absolutely clear - gas prices are impacted by a low Canadian dollar, refinery maintenance and other market forces.
- While we don't control the market, we are committed to working hard every day to make life more affordable for people.
- We're eliminating MSP fees and bridge tolls while making historic investments in affordable housing and childcare.
- We're also increasing the climate action credit for families - this year a family of 4 will receive up to \$400.
