Hi Kim,

Just following up on our conversation last week. I think we have a bit of a timing issue.

If you're releasing the info embargoed to some media, that probably means the info should be good to go - ie, that the OICs have been signed, which they are not yet.

We do have hold capacity before the LG signs but very little after she signs. So if you want to release the info early in the week, that means the OICs need to be signed and then will be public within 48 hours max. Which then kinda ruins your general release date of Saturday.

So maybe think about the timing and closing the gap by delaying the embargo release time. At the very least, you'll have to hold till the OICs are signed.
