Should media ask us about PED, or if more incidents are found, we have the below KM. Jane's comments are included, please let me know if you have any others to add as well.

Response to Alberta Finding

- B.C.'s Chief Veterinary Officer notified BC pork producers and processors following the confirmation of a PED finding in a commercial pig in Alberta on January 8.
- She also asked all pork producers and processors to apply and enforce strict biosecurity measures on all farms with any swine and at all plants where any swine are processed to prevent the entry of PED into BC.

Helping BC pork sector prepare

- In 2014 and 2015 B.C. pork producers and processors obtained biosecurity equipment and developed protocols to reduce the risk of PED entering their operations.
- As the disease is commonly spread by transport vehicles, the B.C. government supported the
 upgrading of truck-washing facilities at the two main hog processing plants in the province (both in the
 Fraser Valley) and invested in on-farm equipment for each registered producer in B.C. to disinfect their
 transport vehicles after each use. Funding also supported the development of response and
 containment plans at each pork farm in the province. (Background below)
- The B.C. Ministry of Agriculture will continue to work with national and provincial governments, and B.C. and Canadian industry groups to monitor and be prepared for any diagnosis of Porcine Epidemic Diarrhea
- the BC Ministry of Agriculture's Animal Health Centre is able to test for the disease's presence with a 24 hour turnaround time on diagnostic samples. (fee is \$35) Producers should contact the Ministry's Animal Health Centre In Abbotsford to arrange for samples to be tested.

PED

- Porcine Epidemic Diarrhea is a very contagious and serious disease of swine.
- PED is usually fatal to piglets, while older animals tend to survive with treatment.
- This disease can be carried on clothing, boots, transport vehicles, and hands as well as feed, manure and animals.
- No cases of PED have been diagnosed in B.C.
- It is important to remember that there is no risk to people or to the health of other species.

Background

Under the federal-provincially funded Growing Forward 2 framework, over \$600,000 was invested to implement controls at B.C.'s (two) pork processing facilities and the development of response and containment plans at each pork farm in the province. (2014)
