- The BCPS did approve a charge against one of the 14 people for assaulting a police officer with a weapon.
- In coming to this decision, the BCPS said given the "dynamic" nature of the situation in which the arrests occurred, that there was a question of whether proper notice of the terms of the injunction order had been provided, as required, to the accused in advance of their arrests.
- In the courtroom, counsel for Coastal GasLink said the company will not be proceeding with charges of civil contempt.

Cheslatta Carrier Nation and BC sign agreement

Background:

- On April 17, BC and the Cheslatta Carrier Nation announced they'd signed an agreement to provide restitution and redress for the impacts suffered by their community and their peoples.
- In 1952, the Cheslatta Nation peoples were evicted from their homes on two weeks' notice and forcibly resettled outside their traditional lands.
- Their lands, villages, cultural and spiritual sites were then flooded as the newly built Kenney Dam filled what is now known as the Nechako Reservoir.
- During the past 67 years, Cheslatta regularly recover skeletal remains of their ancestors on the shore of Cheslatta Lake following spring freshet discharges from the Nechako Reservoir and estimate that more than 60 Cheslatta graves have been destroyed.
- Under the terms of the Settlement Agreement, Cheslatta will propose certain lands for transfer and tenures. A period of extensive engagement with neighbouring First Nations and stakeholders will proceed before final land parcels can be determined.

Cheslatta Carrier Nation and BC sign agreement

Background:

- On April 17, BC and the Cheslatta Carrier Nation announced they'd signed an agreement to provide restitution and redress for the impacts suffered by their community and their peoples.
- In 1952, the Cheslatta Nation peoples were evicted from their homes on two weeks' notice and forcibly resettled outside their traditional lands.
- Their lands, villages, cultural and spiritual sites were then flooded as the newly built Kenney Dam filled what is now known as the Nechako Reservoir.
- During the past 67 years, Cheslatta regularly recover skeletal remains of their ancestors on the shore of Cheslatta Lake following spring freshet discharges from the Nechako Reservoir and estimate that more than 60 Cheslatta graves have been destroyed.
- Under the terms of the Settlement Agreement, Cheslatta will propose certain lands for transfer and tenures. A period of extensive engagement with neighbouring First Nations and stakeholders will proceed before final land parcels can be determined.
