- With regard to new cannabis legislation, we continue to focus on education, health and safety of students.
- In B.C., cannabis is still illegal for youth under 19 to buy, possess or use. It's a controlled substance, like alcohol.
- The new Cannabis Act has several measures that help prevent youth from accessing cannabis.
- It is still against the law to consume cannabis on school properties or any adjacent sidewalks or boulevards, along with tobacco smoking and vaping.
- Smoking or vaping cannabis (or tobacco) is also illegal in other areas where children and youth frequently hang out and play, including playgrounds, sports fields and skate parks.
- B.C. is working closely with the federal government to ensure British Columbians are informed about non-medical cannabis use.
- The Province has a public education and awareness campaign to supplement what the federal government is doing.
- A *Cannabis Public Information Guide for Schools*, created by The Ministry of Health and CISUR, the Canadian Institute for Substance Use Research, will be available shortly.
- Our soon-to-be-released new E.R.A.S.E. site will have resources for students, parents and educators.
- The Province's new website [cannabisclarity.ca](http://cannabisclarity.ca) has cannabis information and resources for parents and youth.
- B.C.'s curriculum offers a variety of opportunities for teachers to discuss substance use with students from kindergarten to Grade 10 through BC's Physical Health Education curriculum. Topics include:
  - preventing personal harm
  - reasons people use drugs
  - physical, social and emotional aspects of substance use
  - addiction and addictive behaviours

**Please see this information regarding the CNCP in BC's schools:**

A total of \$5 million is provided annually through the Carbon Neutral Capital Program, so school districts can undertake electrical and mechanical improvements to their schools that will lower carbon emissions.

Much of this funding has helped districts replace boilers with more energy efficient models and has been applied to innovative strategies such as heat recovery projects, heat pumps, renewable energy and digital building controls.

For example, Penticton Secondary school used its funding to install a solar panel system. The new system will provide sustainable energy and savings for years ahead.

The Ministry has funded over \$300,000 for solar installation projects for 2018-2019 through the Carbon Neutral Capital Program (CNCP).

School districts will use the money to fund projects that cut greenhouse gas emissions. These upgrades benefit schools by saving them money on electricity, natural gas and maintenance. Schools can put the money that is saved back into classrooms.

Projects are based on the specific needs of each district, how well they would save money by boosting energy efficiency, and the school district and energy service provider contributions.

My advice below:

- I believe we can all agree that the highest and best use for agricultural land is for farming and ranching.
- As we work to protect the ALR, we want to ensure that we are also supporting farming families.
- We know how important multi-generational farming families are to our vibrant farming sector.
- I also know some of them may need houses larger than 5,400 sq. ft. to accommodate their families and support their farming operations.
- We are a government who listens.
- The Surrey MLAs brought a number of concerns to my attention. This amendment is in response to those concerns to ensure fairness for people.
- This amendment will mean that people who have their permits and authorizations in place when the regulations are approved in the new year will be grandfathered under the old system.
- They will no longer also be required to have substantially started construction of the foundation.
- Regardless of this amendment, it is also important to emphasize that farming families – no matter what stage of application or planning they're at – will be fine.
- We've ensured that all farming families who need the extra space to farm have a path forward at the ALC for them to build a house larger than 5,400 sq. ft.
- That is in the legislation.
- In response to concerns I've heard from my colleagues, I spoke to the Chair of the ALC. She told me those applications for houses larger than 5,400 sq. ft. will be decided quickly - less than 90 days on average.
- The ALC will treat people fairly, transparently and will make decisions in a timely manner based on straightforward criteria.
- We're working on those criteria right now to come in the new year through regulations.
- We're looking at including things like the importance of multi-generational housing, good-faith investments that have been made, and applications and permits in process.
- Most importantly, the criteria will be specific, and will be designed to ensure there is a path forward for farming families needing extra space to support their farming work.
- We are committed to making sure this process works for multigenerational farming families who need the extra space. We're going to continue to listen to people.
