# DIRTY MONEY — PART 2

An Independent Review for the Attorney General of B.C. Peter German & Assocs. Inc.

# TRANSNATIONAL MONEY LAUNDERING

- Transnational organized crime benefits from the unique environment of British Columbia.
- It has leveraged gaps in the Canadian criminal justice system.
- In BC, alliances have been seen between Mainland Chinese, Iranian and Mexican OC, and domestic outlaw bikers and other gangs.
- Illicit money flows into Vancouver from China, Iran, Mexico and other countries, coalescing with the proceeds of domestic drug trafficking and other crimes.

# PRIVATE MORTGAGE LENDERS

- Private mortgage lenders are a growing segment of the market and vulnerable to money laundering.
- They are not reporting entities to FinTRAC and there is little visibility of their beneficial owners, source of funds or lending practices.
- Currently 90,000, or 9% of residential mortgages, are held by 18,570 private lenders, with 80% of the lenders being corporate entities.
- Although foreign banks are not permitted to engage in mortgage lending, unregulated lenders from outside Canada can register mortgages against BC property.

# NOMINEES

- The use of nominees, or straw buyers, in real estate transactions is commonplace and is exploited by beneficial owners, including criminals engaged in money laundering.
- 3% of B.C. titles (33,292 in 20 years) are held by persons whose occupation is listed as student, homemaker, or unemployed
- Approximately 25% had clear title. These tend to be expensive houses, with 88 houses over \$10 million.

# **OVERSEAS OWNERS**

- 13,678 residential properties, with an aggregate value of \$16.12 billion, are owned by individuals or entities with service addresses outside Canada, a fifth of which are in high-risk jurisdictions for money laundering.
- A total of 25 properties with an aggregate value of \$34.5 million have owners with addresses in countries subject to trade sanctions.
- 20 properties registered in the British Virgin Islands are owned by shell companies, with full anonymity of directors and beneficial owners.
- Opaque service addresses, including post office boxes (71,000) and lawyer offices (2,000), are common as there is no requirement in BC for owners to list their principal or work address, as a service address

# THE RISK IN REAL ESTATE

- The combination of opaque ownership structures and all-cash purchases increases the ML risk considerably, particularly when a nominee or offshore buyer is involved.
- Purchases of residences without financing account for 29%-38% of purchases by companies, 58% of purchases by registered trusts, 20%-28% of purchases by nominees, and 32%-40% by offshore buyers.

# REGULATORY GAPS

- Reporting of suspicious transactions to FinTRAC, by realtors has been dismal for years.
- The use of Geographic Targeting Orders in the U.S. has assisted greatly with ensuring greater transparency in real estate developments and purchases.
- The absence of standardized data fields and prompts make LTSA data difficult to use for analytical purposes. It currently includes properties registered to "superdad, 'funemployed, 'wannabe ski bum', 'domestic diva', 'trophy wife', and 'launderer'.

# MISUSE OF LEGAL CHARGES

- Private mortgages can be used as a debt enforcement tool by organized crime, seeking to leverage the legal system for its own purposes.
- Builders liens are particularly vulnerable because a creditor can register a lien without the consent of the titleholder.

# LAWYERS AND ML

- Lawyers are the 'black hole' of real estate and of money movement generally.
- With no visibility by law enforcement on what enters and leaves a lawyer's trust account, many investigations are stymied.
- Lawyers acting in real estate transactions are particularly vulnerable to being used as conduits for dirty money and must enquire into the source of funds when closing funds are wired into their trust accounts from foreign destinations.

- Exempted by SCC Federation decision from reporting to FinTRAC
- Canada criticized by FATF and others
- SCC did not close the door on reporting
- Waiting for Ottawa to develop a remedy
- Workarounds / blinds used in other common law countries
- Reporting of basic financial information imperative
- Lawyers as realtors
- Lawyers vs. Notaries (who do report)

# A HOLISTIC SOLUTION

 Universal cash reporting over a certain threshold avoids the need to constantly reassess sectors and effectively prevents OC and the underground economy from seeking the unregulated path of least resistance.

 As a supplement to universal cash reporting, Geographic Tracking Orders allow authorities to target a certain sector, in a specific geographic area, such as Greater Vancouver.

# FINANCIAL COMPLIANCE

- The federal government has created an AML bureaucracy which is focused on compliance. It has not infused equivalent resources into enforcement and prosecution.
- FinTRAC is an outlier among international FIUs because it is not a law enforcement agency and does not permit police to work in its offices, due to privacy concerns.
- Many reporting entities are critical of FinTRAC due to the absence of tangible results for the hundreds of thousands of reports it houses.
- Unless its intel is readily available to law enforcement and security agencies, FinTRAC becomes simply a collector of information.

Hi All,

Just wanted to flag a few things for all of you and your consideration for Tuesday and Thursday. Some of this may be obvious, but I figured it was better to be sure. We can also discuss in person Monday morning.

#### TUESDAY:

My understanding is that Tuesday's event will just be Minister Eby, in the Hall of Honour, with a podium and maybe a flatscreen at 11am. He will speak and be joined by no one. Please let me know if any of that is wrong.

#### THURSDAY:

For Thursday, I want to make sure I understand the plan is for there to be a technical briefing with Mr German and Ms Maloney, one after another, followed by the two ministers doing a presser with Q&A, all of this in the Press Theatre.

TIMING: I'm told the plan is for this whole thing to be done by QP because to do otherwise would be problematic for the media. I understand that we should plan for near to 30 minutes each for presentation and Q&A from German and Maloney, meaning they should start at 8:15 AM or so, and there will be a bit of a break before the Ministers start at 9:15 AM. Just wanted to flag that this is tremendously early for the press gallery. If the plan to not interfere with QP is solely to not annoy media, just wanted to flag that this start time will as well, and so we might want to re-evaluate the timing and the reasoning behind which timing we choose.

My other questions/assumptions for thoughts and corrections:

- The basic sequence is
  - German presentation,
  - o German Q&A,
  - Maloney Presentation,
  - Maloney Q&A,
  - Ministers enter and make statement,
  - Ministers Q&A

- The German and Maloney portions are a full on technical briefing, with a connection to a secondary tech
  briefing room in Vancouver, and no other ability to join. One must be in the Press Theatre or the room in
  Vancouver to hear/see the German and Maloney portions or to ask German or Maloney a question. No other
  phone participation.
- Both German and Maloney will have a PPT presentation. Will these presentations be done with the same graphic design? (They should be), and I assume that someone in graphics will work on them.
- Will there be paper copies of the reports on hand? Unless they are quite nice, this seems unnecessary given the size.
- REHEARSAL: will German and Maloney rehearse in person with Q&A from staff substituting as media? (they absolutely should). I'd suggest rehearsing in the theatre itself if that is possible, but that means doing so at around 6:00 or 6:30 PM, as the media has offices in the press theatre and we need to wait for them to leave. We could do that Wednesday evening. I think doing this is mandatory, given the scrutiny here. If we cannot wait until after 630pm on Wednesday, then in person in a boardroom or something could work as a replacement. In person is also important. Really, really want to stress that this should happen.
- WEDNESDAY ARRIVAL: And this is perhaps obvious given what I've just said, <u>but they should be here</u>
   <u>Wednesday!!</u> This all happening as planned should not be subject to the wind speed on Thursday morning.
- The Ministers will not have a PPT presentation to go through, they will just deliver remarks one after another and take questions.

I'll leave it there and we can discuss as needed. Thanks Rick

### Money laundering in B.C.'s post-secondary sector

- 3. What did you discover about the state of policies among institutions in BC?
- It's too early to make any observations about the information received?
- Ministry staff will use the next few months to evaluate the data gathered and then determine what, if any, actions are required.

# 6. Will you report out on the results from your letter? Will you disclose what policies are currently in place and what changes you require?

- My responsibility is to ensure BC's post-secondary system is not enabling money laundering.
- We will respect the confidentiality of each institution's financial policy.
- My Ministry will be discussing any potential vulnerabilities with respective institutions on a one-by-one basis.
- If there are any potential vulnerabilities, we will be expecting those institutions to take corrective action to ensure their financial policies are not a potential target for money laundering.

#### 7. Why did you write to all the public and private post-secondary institutions?

- Dirty money is making life more expensive and hurting all of us in B.C.
- The second German report highlighted public and private post-secondary institutions as one of several vulnerable sectors for money laundering.
- We're doing our part to detect, deter and prevent the ability to launder money in B.C.'s post-secondary system.
- We must raise awareness and take action to detect, deter and prevent the ability to launder money throughout the post-secondary system.
- B.C.'s post-secondary institutions have an excellent reputation.
- While the German report did not focus on the education sector, it is our collective responsibility to ensure that we address any vulnerabilities that may exist.

# 8. What did you ask post-secondary sector to do in the letter?

- I've asked all post-secondary institutions to examine their current practices and take steps to eliminating opportunities for money laundering.
- I've asked each institution for a copy of the policies on accepting cash, providing refunds and what steps they're taking to deter money laundering.

# 9. Are public or private institutions laundering money?

- It's important to note that these are allegations.
- Several sectors in B.C. were identified as being vulnerable to money laundering including public and private post-secondary institutions.

- Other vulnerable sectors: watercraft, auction houses, fisheries quotas cryptocurrency and foreign credit cards.
- There's no suggestion that institutions knowingly accepted proceeds of crime.

### 10. How do you define "large cash payments"?

Payments in the thousands of dollars.

# 11. Why not ban large cash payments altogether?

 It is important to balance the need for institutions to accept some cash payments from students, while not becoming a target for money laundering

### 12. Why not ban cash payments for tuition from international students?

• It would not be fair or realistic to single out just one group of students.

# 13. Are you prepared to ban cash payments entirely if it appears there are serious vulnerabilities?

- It is premature to draw conclusions at this time.
- It's also important to balance the need for institutions to accept some cash payments from students, while not becoming a target for money laundering

# 14. Are post-secondary institutions in B.C. required to report large cash payments to FinTrac?

 Only financial institutions and designated businesses such as money service businesses or securities firms are required to report under FinTrac for large cash deposits.

# 15. The examples in the German report were under \$10,000, which is the FINTRAC reporting threshold. What threshold for "large cash" payments do you have in mind? Isn't your letter an over-reaction?

- Public and private post-secondary institutions are responsible for managing their activities, including collecting student tuition and other fees.
- The day-to-day handling of money is carried out by the individual institution.
- I have asked post-secondary institutions to review their policies following the German report.
- I can't stress enough that it is our collective responsibility to ensure that we address any vulnerabilities that may exist.

# 16. What are the current policies around accepting cash payments?

- There's no single policy.
- Public and private post-secondary institutions are responsible for managing their activities, including collecting student tuition and other fees.
- The day-to-day handling of money is carried out by the individual institution.
- Nevertheless, I have asked all post-secondary institutions to review their policies following the German report.

### 17. How many post-secondary institutions are there?

• 25 public and about 350 private post-secondary institutions.

### 18. When did you first become aware of the allegations?

The same time as the rest of my cabinet colleagues.

# 19. Are you going to investigate the extent of money laundering in the postsecondary sector to get a full picture?

- Gov't accepted the recommendations and findings of the report.
- In response, Premier Horgan announced a public inquiry.

# 20. Will post-secondary institutions be included in the public inquiry?

- That's not up to me as minister.
- A public inquiry into money laundering was announced on May 15 by Premier John Horgan.
- B.C. Supreme Court Justice Austin Cullen will head the inquiry. He's been given the power to compel witnesses and order documents to be disclosed.

# 18. There are suggestions some casinos turned a blind eye to money-launderingdo you think that's a problem in the post-secondary sector?

- Several sectors in B.C. were identified as being potentially vulnerable to money laundering, including public and private post-secondary institutions.
- It's important to note that these are allegations.
- There's no suggestion that institutions acted inappropriately or knowingly accepted proceeds of crime.

# 19. There have long been concerns about the apparent wealth of students in BC post-secondaries (expensive cars, expensive houses). Should institutions be

# expected to inquire into and report on the sources of students' funding like banks and casinos do?

- I've asked all post-secondary institutions to examine their current practices including refund policies and take steps to eliminating opportunities for money laundering.
- I've asked for a copy of the policies on accepting cash, providing refunds and what steps they're taking to deter money laundering.

# 20. The German report mentioned PSIs in passing as anecdotes, yet you speak of this like it's a crisis. Why is your letter so gentle and not more directive? Why not pass a regulation, rather than ask nicely?

- Several sectors in B.C. were identified as being potentially vulnerable to money laundering including public and private post-secondary institutions.
- There's no suggestion that institutions knowingly accepted proceeds of crime.
- We must take action to deter the ability to launder money throughout the British Columbia post-secondary system.

### 21. What if institutions don't comply? What's your next step?

- Dirty money is making life more expensive and hurting all of us in B.C.
- We must take action to deter the ability to launder money throughout the British Columbia post-secondary system.

#### 22. How much is tuition?

- Undergraduate tuition fees in B.C. were an average of \$5,792 in 2018-19.
- Three to four times that for an international student.
