Subject: Consultation under CASA re legislation to repeal MSP premiums

Good afternoon, the Ministry of Health is nearing completion of the drafting of legislation to effect the repeal of MSP premiums. Amendments are being made to the *Medicare Protection Act* and one section of the *Financial Administration Act*. The Request for Legislation, which was prepared in late summer, 2018, specified that consultation under CASA would be required, given s.3 of the agreement specifies elimination of MSP premiums as a matter on which consultation is required. As well, the RFL specified that the BC government would gauge support from the BC Green Caucus through a Consultation Committee before introduction.

Given that drafting is nearing completion, and the proposed legislation is being prepared for review by the Legislative Review Committee in advance of introduction during the Spring 2019 session, I am wondering if you can advise on how we should now proceed?
