- •Public and stakeholder concerns have been raised increasingly about lifestyle estates that include things such as swimming pools, tennis courts, helicopter landing pads and multi-car garages •The changes to the Act include new regulation-making powers that allow the government to establish size, siting and use rules for other residential structures (such as those listed above) in the ALR in the future.
