Hi Katie – Jamie & I “listened live” to the Premier’s interview with CFX 1070 this AM. The first part was (of course) related to the pipeline and the federal govt buying it, but the second half was related to the Malahat closure. Here are the quick point form notes I took on what was said...(Jamie jump in if I missed anything)

“Al – you & I have talked about the Malahat for over a decade now... I have always wanted to raise awareness on this route...when I was in opposition and now as Premier... The local fire chief (Rob Patterson), who now sadly has passed away, was always a strong advocate of getting the median barriers up on the whole stretch of the Malahat... The previous government committed to doing that and had started on it...and I am going to follow through with this plan... Now, regarding the tanker truck accident which closed down the Malahat... The challenge with this... that is where the road goes through a provincial park...that is very complex and there are challenges... In 2007, a review was done...looking at a range of options...including a bridge...I don’t want people to get all excited thinking that a bridge will get built... What I am asking the Minister of Transportation to do is to “dust off” that review...and look at options...

Re: the E&N corridor...train is not happening...and, the tracks actually stop at Vic West...they don't go all the way into town

In study after study, it's proven that if people need to transfer more than once they will just stay in their cars...

We need to use this corridor for the best possible outcome...it's a waste otherwise...

We want to look into a bus corridor...from Langford into town...you can get over the Johnson street bridge on a bus (you can't on a train)...

More practical...working with First Nations and communities..."

Major media including CTV and Global are reporting that a toddler has died after wandering away from a daycare in Mission.

According to media reports, the girl was found unresponsive in a backyard swimming pool nearby and was airlifted to hospital. RCMP and BC Coroners Services are investigating.

Media are also reporting that the daycare centre, Melissa's Bright Beginnings Childcare Centre, was the subject of a surprise inspection by Fraser Health back in January, and was found to be caring for too many young children.

The licensed home multi-age child care centre was found to have 5 kids under the age of 36 months but its license only allows for 3 kids under the age of 36 months.

Following on recommendations made by the former Information and Privacy Commissioner, the BC Government has developed information management training that addresses employees' key responsibilities across records management, access to information, and protection of privacy. The training is delivered by career public servants who are subject matter experts in information management. Given the importance of demonstrating accountability in this space, all government employees are required to take this training, with ministerial staff additionally being required to sign attestations to the fact that they took the training, understood the training and are aware of resources available upon request. Printed resources are also provided to all ministerial staff to allow quick reference to key issues encountered as a part of their role. Finally, completion of information management training is routinely monitored by ministry employees to ensure a high level of compliance with this training requirement is maintained.

The Corporate Records and Information Management Office (CIRMO), located within the Ministry of Citizens' Services, can provide a range of materials regarding the above training initiatives, including curriculum content, supplementary resources as well as training statistics. CIRMO has indicated that they are available to assist you in the event that these corporate training records are of interest to you.

As requested, here is an overview.

General Messaging:

- The Province and the Regional District of Kootenay Boundary are still in active response to flooding in Grand Forks.
- In anticipation of needs throughout B.C., the Province is standing up the Recovery Branch which supports communities starting with re-entry through to long-term recovery.
- The Province is working with key ministries and B.C. communities to identify needs and services available.
- Town Hall meetings were held in Rock Creek and Grand Forks last week. Provincial staff attended to provide information on Disaster Financial Assistance (DFA) and short-term recovery. Service BC is also providing access to computers for residents to complete DFA claims.
- Currently, rapid damage assessments of properties are being completed in the Regional District of Kootenay Boundary.

Industries impacted:

- Interfor - evacuated May 10 at 9:00 a.m. rescind to alert May 19th at 8:00 pm (shut down for 11 days)

- Rockwool / remainder of industrial park - evacuated May 10 at 9:00 a.m. Rescinded May 21 at 3:00 pm (shut down for 11 days)

Families impacted:

- At the height of the flooding, we had over 1,600 addresses, and 3,200 people evacuated from their homes in the Regional District of Kootenay Boundary.

Colour Placards on properties:

As part of the response to the emergency, notices (placards) have been placed on buildings in and around the risk area. The placards indicate that a basic safety assessment had been carried out and as a result, structures were classified as red, yellow or green.

- RED – Do not enter the building because it is unsafe.
- YELLOW – Buildings are considered either suitable for restricted access until issues are resolved, or use may be possible in those parts of the building that have not been damaged.
- GREEN – The building has been assessed and while no apparent structural or other safety hazards are found, a more comprehensive inspection may reveal safety hazards.

- The province's cannabis legislation (Cannabis Distribution Act, Cannabis Control and Licensing Act, and Motor Vehicle Act amendments) all passed third reading as of last week.
- The Motor Vehicle Act amendments have already received royal assent, with royal assent for the other two expected next Thursday (May 31).
- There are still questions around the timeline for legalization, as well as how exactly roadside testing will work.
- Minister Farnworth has said that we're waiting on the federal government for details on the federal standard for roadside testing for cannabis impairment, including what devices will be used as breathalyser equivalents during roadside stops.
- The legalization bill C-45 is in the Canadian Senate right now.

DAILY UPDATE REPORT FOLLOWS BELOW

ADVICE AND RECOMMENDED RESPONSE:

General Messaging:

- We must all work together to prepare for and respond to flooding and other disasters.
- During this trying time, we want British Columbians to know we will be here to help.
- Our government will assist them in any way we can.
- We continue to plan and prepare. This includes shipping flood mitigation equipment and millions of sandbags to the interior.
- We continue to work with the federal and local governments to protect communities and are monitoring the situation closely.
- The Province has announced several major flood prevention and emergency preparedness projects this year, including funding for the National Disaster Mitigation Program, the Community Emergency Preparedness Fund, and several other structural and non-structural flood mitigation projects throughout B.C.

Matching Red Cross contribution:

- The B.C. government is matching contributions to the Canadian Red Cross and will match donations up to \$20 million to help those impacted by the recent devastating floods.
- We're seeing incredible strength and resilience in communities affected by flooding – and British Columbians from all corners of the province want to provide a helping hand. Donations to the Canadian Red Cross will provide vital help in a time of greatest need for so many people and communities.

Federal Flood Support:

- Public safety is our top priority.
- We remain committed to stand with British Columbians through this challenging flood season.
- Up until this point, the province has been able to provide the necessary support for communities in need. Now that this event has significantly challenged provincial capacity, the Province has requested Federal assistance.
- We thank and commend the federal government for partnering with us to provide more support and resources to help B.C. communities struggling with the impacts of flooding.
- The Canadian Armed Forces (CAF) have deployed personnel to work with the province.

- The Military is providing flood mitigation work in the Regional District of Okanagan Similkameen, the Regional District of Central Okanagan, and the Regional District of Kootenay Boundary (Grand Forks).
- The Canadian Armed Forces and Canadian Coast Guard have also deployed small boats in the Fraser Valley.
- The Province is always in communications with the Federal government, and representatives from the Canadian Armed Forces, Environment Canada and Public Safety Canada have been stationed at our Provincial Emergency Coordination Centre for weeks.
- This additional support will help us provide the resources needed to better protect B.C. communities and public safety.

General Federal RFA Messaging:

- If a local government needs support of any kind in an emergency beyond what they have available, that request is elevated to the Provincial Regional Operations Centre (PREOC) in the area.
- The PREOC then looks to source support from the region. If regional support is not readily available, the request is elevated to the Provincial Emergency Coordination Centre (PECC) in Victoria who will look for support in unaffected regions of the province.
- When the capacity of the province is no longer able to meet the needs of communities, a request for federal assistance is made. Requests are not made for military assistance specifically – the federal government will fill the need with their available resources from their various program areas.

Fraser River Flooding

- Persistent warmer than normal temperatures across British Columbia for the past three weeks has led to a much earlier than normal runoff period for the Fraser River.
- The Lower Fraser River is currently experiencing high-flow rates.
- The Fraser River Basin has not seen a combination of weather conditions, including high temperatures, snow melt and river-flow of this nature in many years.
- Over the last few weeks, regions that contribute to the Fraser River have experienced temperatures of five degrees above normal.
- This means a potential for flooding in communities in the Lower Mainland along the Lower Fraser.
- With hot weather forecast to continue over the Fraser River watershed through this week, additional rises on the lower Fraser River are expected this coming weekend.
- The higher temperatures will increase snowmelt and contribute to higher flows.
- Weather will be the key factor in how the situation progresses, as we go forward. As snowpacks become diminished, rainfall will become the key risk for the potential for flooding in the coming week or two.

Current Actions

- The River Forecast Centre continues to monitor river flow levels and provide guidance.
- Southwest PREOC is working closely with First Nations and local governments, supporting them and identifying areas at risk.
- Emergency Management BC is working with First Nations and local governments to determine what support is needed and how the province can help.
- EMBC continues to prepare for an increased need for Emergency Social Services, critical infrastructure assessments and evacuation support.

Provincial Flood Support and Investments

Emergency Management BC is assisting local governments in flood response. As of May 22, the province has:

- Activated the Provincial Emergency Coordination Centre (PECC) to support the Central (CTL), Southeast (SEA) and Northeast (NEA) Provincial Regional Operation Centres (PREOCS).
- Activated PREOCS in Kamloops, Prince George, Surrey and Nelson to provide assistance to local governments.
- Deployed over 3.56 million sandbags to local governments to protect homes and public infrastructure.
- Provided 12 sandbag machines to Cache Creek, Oliver, Vernon (2), Willowbrook, Kelowna (2) and Prince George staging area (3), Enderby (1).
- Six sandbag machines are on loan from Saskatchewan.

- Currently deployed 331 BC Wildfire Service fire fighters to Kelowna, Lower Nicola Indian Band, Okanagan, Grand Forks, Oliver, Osoyoos to assist with sandbagging.
- Shipped 3.316 km of Gabions and 14.3 km of tiger dams to the interior.
- FLNRD's River Forecast Centre and Water Stewardship Branches are providing water flow expertise, as well as geotechnical specialists and engineers.
- **EMBC has additional flood response resources ready to deploy:**
 - Prince George:
 - 144000 sandbags
 - 3116 metres of Gabions
 - 2,000 metres of tiger dams
 - 1 sandbagging machines
 - Kelowna:
 - 81,000 burlap sandbags
 - 42,000 plastic sandbags
 - 960 metres of gabion
 - Chilliwack:
 - 28,000 burlap sandbags
 - 1,982,000 bio degradable sandbags
 - 11,925 metres of tiger dam
 - 5,142 metres of gabions
 - 6 sandbag machines
- **Disaster Financial Assistance (DFA) is also available for eligible British Columbians who may have been impacted by overland flooding or landslides from heavy rains.**
- **This DFA is available in the geographic areas within the Regional Districts of Kootenay Boundary, Okanagan Similkameen, Central Okanagan, Columbia Shuswap and North Okanagan (including electoral areas, municipalities and First Nations communities).**
- **DFA is available to eligible homeowners, residential tenants, small business owners, farmers, charitable organizations and local government bodies that were unable to obtain insurance to cover disaster-related losses.**
- **British Columbians can access the DFA application at: <http://www.gov.bc.ca/disasterfinancialassistance>**
- **While we're prepared to respond to flooding to protect public safety, anything we can do to understand and prepare for flood risk is a step in the right direction.**
- **That is why the Province funds programs such as National Disaster Mitigation Program and the Community Emergency Preparedness Fund for local governments.**
- **The National Disaster Mitigation Program and Community Emergency Preparedness Fund enable communities to develop flood risk assessments, maps and mitigation plans in addition to constructing flood protection infrastructure. A full list of potential funding programs can be found at Emergency Management British Columbia's Disaster Mitigation Branch webpage.**
- **We are committed to working collaboratively to improve public safety and disaster preparedness for all British Columbians.**

If asked about recent investments in mitigation:

- EMBC is committed to improving the public safety of all British Columbians; that is why we are investing heavily in flood prevention and protection.

- In April, 2018, the Province announced \$6.5 million in disaster-mitigation projects throughout the province. Funding highlights include:
 - \$2.6 million to plan and undertake structural and non-structural flood-mitigation projects in various locations throughout B.C.;
 - \$1.75 million to further assess earthquake-related hazards in the Metro Vancouver area;
 - \$1.5 million to the Union of British Columbia Municipalities (UBCM) for the Community Emergency Preparedness Fund;
 - \$450,000 to the Fire Chiefs Association of British Columbia to support road rescue, fire safety and prevention; and
 - \$130,000 to Avalanche Canada and the District of Stewart to support avalanche reporting and mapping.

National Disaster Mitigation Program:

- On Feb. 2, 2018, the Governments of Canada and B.C. announced funding for 30 projects, valued at approximately \$12.1M (including investments from local governments and NGOs) through the National Disaster Mitigation Program.
 - B.C. government contribution: approximately \$5 million.

April 2018 Mitigation Funding:

- \$2.5 million to plan and undertake structural and non-structural flood-mitigation projects in various locations throughout B.C., including:
 - \$1.5 million to support local government flood-mitigation projects through the UBCM Community Emergency Preparedness Fund.
 - \$1.45 million for the Okanagan Water Basin Board to obtain aerial photos and surface topography for the entire Okanagan watershed during the current spring freshet.
 - \$500,000 for the Central Coast Regional District to develop a flood risk assessment and to model several flood scenarios in the Bella Coola Valley.
- Previous investments:
 - In March 2017, EMBC announced the investment of \$60 million for flood mitigation projects in B.C. communities.
 - This followed the announcement in 2016 of \$50 million of funding earmarked for 15 community hazard mitigation projects including upgrades to dikes.

If asked about Disaster Financial Assistance (DFA):

- Disaster Financial Assistance is a provincial program to help individuals and local governments recover from uninsurable disasters. The program is administered by Emergency Management BC.
- The purpose of DFA is to provide a helping hand to get people and local governments back on their feet after an uninsurable disaster.
- The eligibility criteria for DFA, which has been consistently and fairly applied since 1995, is defined according to the Emergency Program Act and Disaster Financial Assistance Regulation.
- DFA is available in the event of a disaster in respect of which the minister, or designate, has determined that disaster financial assistance may be provided.
- When this determination is made, Emergency Management BC defines the eligible dates and geographic locations, notifies affected local governments, posts this information on its website, publishes information in local papers, and attends community meetings if requested.
- For flooding disasters, DFA is available to qualifying home owners, residential tenants, small business owners, farm owners, and charitable organizations. Applicants should be aware of the following:
 - Financial assistance is provided for each accepted claim at 80% of the amount of total eligible damage that exceeds \$1,000, to a maximum claim of \$300,000.
 - Claims may be made in more than one category (e.g., home owner and farm owner).
 - A home owner or residential tenant must show that the home is the applicant's principal residence.
 - Seasonal or recreational properties, hot tubs, patios, pools, garden tools, landscaping, luxury items (like jewelry, fur coats and collectibles), and recreational items (like bicycles) are not eligible for assistance.
 - Small business owners and farm owners must demonstrate the business or farm is the applicant's primary source of income.
 - Charitable organizations must provide a benefit of service to the community at large.

- Assistance is also available to local governments for essential materials and to rebuild or replace essential public infrastructures to the condition it was in before the disaster. Assistance is provided for each accepted recovery claim at 80% of the amount of total eligible damage that exceeds \$1,000. There is no maximum claim.

If asked about the impact of overland flood insurance on DFA assessments:

- Until recently, overland flood insurance was only available for commercial buildings. The B.C. Government expects that within two years DFA will be available to family residences throughout B.C. Overland flood insurance is now available in certain municipalities throughout B.C.
- Disaster Financial Assistance is not applicable where flood insurance is readily and reasonably available. In communities where flood insurance has not yet been introduced, DFA is applied according to the eligibility criteria established since 1995.
- All residents or tenants who make a DFA application will be treated on a case-by-case basis and, as is normal practice, will be given a form to fill out and then present to their insurance agent or broker to determine whether the resident was offered the flood insurance option.

If asked about support provided for the 2017 freshet:

- EMBC supported evacuees through Emergency Social Services.
- During the 2017 freshet, EMBC coordinated the deployment of hundreds of personnel to assist communities—including technical experts from several fields and ministries. For example:
- EMBC deployed flood mitigation resources to support local authorities, including:
 - Approximately 4.4 million sandbags
 - 7.5 km of gabions (wall-like structures filled with sand)
 - 6.7 km of Tiger Dams (stackable orange tubes filled with water)
 - 9 sandbag filling machines, used in communities throughout the flood season

Community Emergency Preparedness Fund

The Community Emergency Preparedness Fund (CEPF) is a suite of programs designed to enhance the resiliency of local governments and their residents. The Province provides the funding, which is administered by UBCM. In March 2017, the Ministry of Transportation & Infrastructure launched CEPF as part of an \$80 million announcement for emergency preparedness. In April, the government provided \$1.5 million to the CEPF to support local government flood mitigation projects throughout the province.

Funding streams:

- Flood Risk Assessment, Flood Mapping & Flood Mitigation Planning
- Emergency Social Services
- Emergency Operations Centres & Training
- Structural Flood Mitigation

Flooding Safety Preparedness:

British Columbia has geared up for the busy spring flooding season, also known as freshet.

The Provincial Emergency Coordination Centre has been activated to support emergency operation centres and affected communities as they prepare for localized flooding.

Steps you can take to help protect your home, property and family:

- Create a [household emergency plan](#), put together your [grab-and-go bag](#), and [connect with your neighbours](#)
- Move equipment and other assets to higher ground
- Clear perimeter drains, eavestroughs and gutters. Maintain your sump pumps
- Move electrical appliances to upper floors and make sure to anchor fuel supplies

- Park vehicles away from streams and waterways

If you are placed under Evacuation Alert:

- This is the time to get prepared to leave your home on short notice.
- Get your grab-and-go bags ready (which should include several days of clothing, toiletries and medications), your emergency plan, copies of important documents and important mementos.
- Listen to local emergency officials for further information on the situation.

If you are placed under Evacuation Order:

- Leave the area immediately.
- Follow the directions of local emergency officials and evacuate using the route(s) they've identified.
- Do not return home until you've been advised that the Evacuation Order has been rescinded.
- For those needing additional support, an Emergency Social Services Reception Centre may be opened.

Tips for staying safe around flood waters:

- Never drive or walk through flooded streets. Water can be deeper than it appears, and levels can rise very quickly
- Keep clear of eroded banks, as they may result in unstable ground. Most importantly, keep children and pets away from stream banks
- Stay alert for changing conditions, particularly if you live in low-lying areas or near waterways
- Listen to local officials and follow their instructions if asked to evacuate

DAILY UPDATE REPORT (NEW INFORMATION IN RED):

EMBC UPDATE – May 22, 2018 AS OF 0700 HRS – ASSESSMENT

The PECC will remain activated today at level 2 in support of the CTL, SEA, NEA/NWE, and SWE PREOCs.

The Provincial situation continues to stabilize. There are still areas of concern with the Lower Fraser River and Okanagan Lake continued to forecast to rise. Significant rainfall and high temperatures remain strong influences driving rapid snowpack melt into high river flowrates. The water levels in lakes and rivers across the province continue to react to influences from snowmelt compounded by weather patterns.

The updated Regional summaries are below.

PROVINCIAL WEATHER

The warm weather continues today as a ridge of high pressure establishes itself today from about Prince George southwards. Valley bottom temperatures close to 30 degrees are expected over the Fraser Canyon, Thompson, Okanagan, West Columbia and Boundary; about 8 to 10 degrees above average highs for late May. A broad dome of warm air with freezing levels greater than 3600 metres will develop south of Prince George and east of Tofino.

The ridge shifts slightly to the east but the warm air holds for Wednesday and Thursday, supporting melting of the remaining of high elevation snowpack. The weather charts are also showing increasing instability and the possibility of thunderstorms for late Wednesday and Thursday. It's too early to tell exactly where these showers or thunderstorms will be, but some localized rainfall can be expected. The forecast location and amounts from these thunderstorms by the models will be watched closely.

Longer term the upper ridge of high pressure will shift further eastwards and an upper trough of low pressure will begin to push in from the Pacific on Friday and Saturday. Lowering freezing levels are expected as we move into the weekend with initial computer model estimates showing 3000 metre freezing levels over the south coast and Okanagan, and 2500 metre freezing level over the Cariboo and central interior including Prince George.

- List of Indigenous psychologists who do PCAs in child-protection cases in B.C. — if any.
- Number of parental capacity assessments requested by the ministry (or Director's counsel) in child-protection cases — either per year, so far this year, or in whatever timeframe you may have on hand.

If it's true that there are no Indigenous psychologists currently conducting PCAs in B.C., then I'd also like to know whether the Ministry views this as a problem, and if so, what's being done to address it.

In my upcoming story, I'll also be writing about the assessment tool Hulitan Family Services has been developing in response to their concerns around PCAs. I understand they've been working closely with the ministry on this. Could I get an interview early next week with the ministry staffer who is collaborating with Hulitan on this project?

Background

Recommendation

- Parental Capacity Assessments (PCAs) are conducted by contracted psychologists to establish a systematic record of the functional abilities of the parent(s). PCAs are one of many tools that social workers may use to assess a family's strengths and risks.
- While the ministry does not actively collect data on the number of PCAs that are conducted, anecdotal accounts from the field indicate they are seldom used. Instead, social workers typically rely on other forms of clinical assessment and focus on engaging families in a variety of dispute resolution processes to help improve family functioning.
- Obtaining a list of psychologists who conduct PCAs in child protection cases would require a special data pull as these contracts are managed by each individual Service Delivery Area.
- As is true throughout the public service, we cannot (and should not) compel staff or contractors to disclose their racial or ethnic heritage – though they may choose to self-identify.
- We can tell you that the percentage of MCFD staff who *have* self-identified as Indigenous is 5%, which is slightly higher than the overall percentage in the BC Public Service (3.2%).
- From that perspective, we are building from a strong foundation.
- We recognize the value of diversity and cultural awareness in our workforce.
- That's why:
 - We've launched an e-guide for hiring managers and an online cultural self-assessment tool to help staff learn about their own cultural awareness level and encourage them to learn more to increase their awareness.
 - We've added a new Manager of Indigenous Culture and Reconciliation position to the HR team to support the Indigenous recruitment and retention plan.
 - Since 2013, we've been offering staff a variety of different training opportunities ranging from cultural awareness to cultural sensitivity, cultural agility and cultural safety.
 - More than 1,160 staff at MCFD and the Delegated Aboriginal Agencies have completed an online Indigenous Cultural Safety courses (12 hours over 8 weeks)
 - More than 1,700 staff in MCFD and DAAs, as well as community partners have completed a one-day experiential learning workshops. In this course, participants explore the effects of colonization on Indigenous children, youth, families and communities, get a better understanding of traditional Indigenous practices and values, and become part of the healing.
 - All MCFD staff are also encouraged to complete the Building Capacity in Aboriginal Relations course offered through the BC Public Service Agency.

Regarding the project with Hulitan Family and Community Services:

- In 2013, a Shared Research Agenda was released that identified the priorities for research in the six service areas of MCFD in order to improve outcomes for children, youth and families in British Columbia.
- MCFD released a call for proposals through the University of Victoria's Office of Research Services to provide funds to undertake research related to the questions in the Shared Research Agenda.
- The University's Centre for Aboriginal Health Research (now the Centre for Indigenous Research and Community-Led Engagement) put forward a proposal in partnership with Hulitan Family and Community Services for funding to conduct a research project on developing a culturally appropriate Aboriginal parenting skills assessment tool.
- The research project was awarded funding, and is currently underway.

I was wondering if she will be answering any more specific questions.

Here's mine, about this recommendation:

By October 2019, the MCFD will amend the qualifying criteria for AYAs so that all young people transitioning from care or Youth Agreements are universally eligible for the program. Services and financial support provided will address unique circumstances and transition needs of the young person.

The minister has said she accepts all of the reports recommendations. Does this mean that AYA support will be extended to all youth leaving care, regardless of whether they are in school or training? (I know the program has been expanded and the amount of \$ increased, but I also know it's not automatic and many young people don't qualify.)

Background

Recommendation

- We accept the report's recommendations and are committed to working with our partners to address each one of those recommendations.
- We must do more to support young people who transition out of our care. Some of that work will require further consultation with young people themselves. Some of it may require changes to legislation.
- At this point, it's too early to provide more detail than that.
- Our task now is to meet with youth in care, youth-serving-agencies and our cross-government partners and work together to ensure the changes we make are as inclusive as possible and address the widest range of individual need.

Provided Background

March is always a busy period for the child care team as providers look to renew their operating funding. We also launched the fee reduction initiative this year, the first program of its kind in B.C. history.

This province-wide program reached thousands of providers and families in every region of B.C. We anticipated the need for additional staff and overtime to process a high volume of applications and answer questions. Allowance was made for this in the ministry's budget.

We hired 16 new members of staff specifically to work on the fee reduction initiative. We also approved just under 1,380 hours of overtime to ensure that staff were available to answer queries from child-care providers, as well as process contract renewals for child care operating funding and assess applications for the fee reduction initiative as quickly as possible.

27 staff members worked overtime through this period (Mar 26 – Apr 27), for a total cost of just under \$50,000.

We hired 16 new members of staff specifically to work on the fee reduction initiative. We also approved just under 1,380 hours of overtime to ensure that staff were available to answer queries from child-care providers, as well as process contract renewals for child care operating funding and assess applications for the fee reduction initiative as quickly as possible.

As requested, here is an overview.

General Messaging:

- The Province and the Regional District of Kootenay Boundary are still in active response to flooding in Grand Forks.
- In anticipation of needs throughout B.C., the Province is standing up the Recovery Branch which supports communities starting with re-entry through to long-term recovery.
- The Province is working with key ministries and B.C. communities to identify needs and services available.
- Town Hall meetings were held in Rock Creek and Grand Forks last week. Provincial staff attended to provide information on Disaster Financial Assistance (DFA) and short-term recovery. Service BC is also providing access to computers for residents to complete DFA claims.
- Currently, rapid damage assessments of properties are being completed in the Regional District of Kootenay Boundary.

Industries impacted:

- Interfor - evacuated May 10 at 9:00 a.m. rescind to alert May 19th at 8:00 pm (shut down for 11 days)
- Rockwool / remainder of industrial park - evacuated May 10 at 9:00 a.m. Rescinded May 21 at 3:00 pm (shut down for 11 days)

Families impacted:

- At the height of the flooding, we had over 1,600 addresses, and 3,200 people evacuated from their homes in the Regional District of Kootenay Boundary.

Colour Placards on properties:

As part of the response to the emergency, notices (placards) have been placed on buildings in and around the risk area. The placards indicate that a basic safety assessment had been carried out and as a result, structures were classified as red, yellow or green.

- RED – Do not enter the building because it is unsafe.
- YELLOW – Buildings are considered either suitable for restricted access until issues are resolved, or use may be possible in those parts of the building that have not been damaged.
- GREEN – The building has been assessed and while no apparent structural or other safety hazards are found, a more comprehensive inspection may reveal safety hazards.

- The Province has also announced several major flood prevention and emergency preparedness projects this year, including funding for the National Disaster Flood Mitigation Program, the Community Emergency Preparedness Fund, and several other structural and non-structural flood mitigation projects throughout B.C.

VICTORIA - Disaster Financial Assistance (DFA) is now available for eligible British Columbians in the northeast region who may have been impacted by the recent flooding, due to spring freshet that began on April 28, 2018.

DFA is available to home owners, residential tenants, small business owners, farmers, charitable organizations and local government bodies who were unable to obtain insurance to cover these disaster-related losses.

Applications for this DFA event in the Cariboo Regional District, the City of Quesnel, the Regional District of Fraser Fort George, Kluskus First Nation, Xatsull First Nation, Williams Lake Indian Band, Tlètinqox Government, Ulkatcho First Nation, Nazko First Nation, and ?Esdilagh, must be submitted to Emergency Management BC (EMBC) by August 1, 2018.

Facts about Disaster Financial Assistance:

DFA is available to qualifying home owners, residential tenants, small business owners, farm owners and charitable organizations. Applicants should be aware of the following:

* Financial assistance is provided for each accepted claim at 80% of the amount of total eligible damage that exceeds \$1,000, to a maximum claim of \$300,000.

* Claims may be made in more than one category (e.g., home owner and farm owner).

- * A home owner or residential tenant must show that the home is their principal residence.
- * Seasonal or recreational properties, hot tubs, patios, pools, garden tools, landscaping, luxury items (such as jewelry, fur coats and collectibles) and recreational items (such as bicycles) are not eligible for assistance.
- * Small business owners and farm owners must demonstrate that their farms and businesses are their primary source of income.
- * Charitable organizations must provide a benefit of service to the community at large.

Assistance is also available to local governments for:

- * Emergency response measures authorized by EMBC, according to response task number. These include incremental costs associated with their emergency operations centre. Financial assistance is provided for each accepted response claim at 100%. Completed response claim summaries and supporting documentation must be sent to the respective EMBC regional office.
- * Recovery measures to replace essential materials and rebuild or replace essential public infrastructures to the condition it was in before the disaster. Assistance is provided for each accepted recovery claim at 80% of the amount of total eligible damage that exceeds \$1,000.
