Please see the below replies to your questions As the topic involves employees in both the Ministries of Agriculture and Environment (as per the joint presentation you saw @ KODA), if needed, the information can be attributed to the BC government.

What constitutes a Nutrient Management Plan (NMP)?

A NMP is a planning document that guides the use of nutrient sources on the farm for the coming year. The core components of a plan include an inventory of the nutrient sources that are used on the farm and the field by field allocation of these nutrients. The plan is designed to minimize the risk of nitrogen and phosphorus loss into the environment and ensure that nutrients are applied at rates which meet but don't exceed crop needs. A plan takes into account all of the nutrient sources that are available to the crops which includes nutrients present in the soil in addition to inputs of fertilizer and manures.

Who should have a NMP?

Agricultural operations will need to have and implement a NMP if they meet all of the following conditions:

- 1. the operation is a total of five hectares or more,
- 2. nutrients are applied to the land,
- soil nitrate and phosphorus test levels are high (thresholds change over time), and
- 4. fields being land applied are in a high-risk area.

Many farms in BC will not trigger the conditions listed above and will therefore not need a NMP. The requirement to have a NMP will be phased-in over time based on location and type of operation. As of February 28, 2019, NMPs are required for the next growing season in the Hullcar Valley. An interactive map is available to help producers understand if they need a NMP, and if so, when: https://governmentofbc.maps.arcgis.com/apps/MapSeries/index.html?appid=b2eb013a0666473dabeacf89f8 1f0e89

How does one obtain a NMP?

As established above - not everyone needs a NMP. The requirement for NMPs is being phased in over a 10-year period, with the first being required in Hullcar Valley. This phase-in approach is to allow for government to develop the necessary guidance and tools to support implementation. For example, the Province is currently developing a nutrient management training program to certify qualified professionals and experienced persons in nutrient management planning. In the meantime, producers can seek help in determining how to get a NMP in their region by contacting us at AEMCoPenquiries@gov.bc.ca.

Why is having a NMP important?

NMPs are important to ensure crops receive nutrients to optimize crop growth and minimize environmental risks to water quality. NMPs assist with decisions surrounding nutrient management - the 'right' nutrient source, the 'right' rate, the 'right time', and the 'right place' - nutrients applied to land match crop needs. NMPs are an important tool for helping ensure agricultural practices are consistent with the protection of clean, safe drinking water.

What happens to the NMP once it is done?

The NMP must be implemented. If the plan was required to be prepared by a qualified professional, an operator will need to notify the Ministry of Environment. A copy of the NMP must be kept, including all relevant information that was used to create the plan, and made available upon request. Any changes to the plan must be tracked and the plan should be reviewed annually by the farm operator. A qualified professional or experienced person must review the plan at least once every 5 years or when significant changes occur to the agricultural operation.

How much might it cost?

Government is working to keep the costs down by developing a NMP training program, as well as providing tools and guidance on good environmental management practices thus helping farmers avoid the need for a NMP. For many farmers in B.C. there will be no costs involved as their operations will not trigger the need for a NMP. Similar to an irrigation plan or pest management plan, costs vary significantly depending on the size, location and type of activity. Actual costs will depend on the complexity of the situation and consultant fees.

A few more details on background Chad, attributable to the Ministry of Agriculture if need be.

1/If spring soil temperatures remain low, could that reduce the populations of emerging adult Japanese beetles?

- The spring soil temperatures are more likely to impact the timing of the emergence than the population of the beetles.
- Some larvae mortality may have occurred during the cold spell, but we do not expect the temperatures were severe enough to significantly impact the overall larvae population.

2/How do provincial entomologists describe the severity of the Japanese beetle problems in city's like Vancouver/

- The Japanese beetle poses a serious risk to plants and trees in Vancouver and surrounding areas, and a
 partnership of governments, industry and non-profit organizations are acting now to minimize that
 risk.
- The CFIA, Ministry of Agriculture, City of Vancouver, Invasive Species Council of BC and BC Landscape and Nursery Association continue to cooperate on a response that includes treatment of infested sites, controls around the movement of soil and plants, enhanced surveillance and monitoring activities, public education and outreach, and support from BC nursery growers and landscapers.
- The agencies are working together to contain and treat areas infested with the beetle and to reduce the risk it poses. Each partner is playing a role to make that happen.
- The overall goal is to eliminate the infestation, and reduce the risk the beetle and its spreading poses.
- To support the response, people can:
 - Report sightings of Japanese beetle in British Columbia to the Canadian Food Inspection Agency.
 - Not transport soil, plants or plant parts out of the regulated area without permission from the CFIA. (http://inspection.gc.ca/jb)

Thanks Chad, here's some information from our entomologists about the Japanese beetle, attributable to the Ministry of Agriculture if needed.

Japanese beetles spend the winter as grubs in the soil. There are no adult beetles present in the
winter. The cold weather will not kill the grubs since they burrow deep into the soil to spend the
winter and will go further down as temperatures get colder to avoid freezing to death. Snow also acts
as an insulator and offers some protection from extreme cold. Spring soil temperatures affect adult
emergence.

The link you sent me led to the an expired session page, so apologies I can't offer assistance there. Entomologists have their specialties though, much like everyone else, and if most of them are forest based, like the mtn pine beetle, I can connect you with colleagues of mine at the Ministry of Forests, if they are more based on agriculture crops, I'm happy to dig out the details, just let me know please.


