Hi Donna,

The Ministry of Health is working on a new OIC/Regulation under the *Community Care and Assisted Living Act* and seeking guidance on whether consultations with the BC Green Party caucus are required. It relates to policy initiatives listed under section 3 of the CASA: seniors and mental health and addictions.

The proposed OIC/Regulation would bring into force amendments made to the CCALA by Bill 16-2016 and enact a new Assisted Living Regulation. Assisted living residences accommodate adults who require regular support and services, but can make decisions on their own behalf necessary to live safely in a semi-independent environment and do not require the more intensive level of care offered in community care facilities. Assisted living residences are governed by the CCALA and registered by the assisted living registrar within the Ministry.

In March 2016, amendments to the CCALA were passed by the legislature to allow more flexibility and choice for residents of assisted living, while at the same time increasing regulatory oversight and health and safety protections. Currently, assisted living residences are only permitted under the CCALA to provide no more than two services, such as assistance with the activities of daily living, managing medication, therapeutic diets, behavior management, psychosocial supports, and safekeeping of money and personal property. As a result, seniors that require more than two services are unable to reside in assisted living, although in some cases the individuals are able to continue to live independently and safely there. Bill 16-2016 would remove this restriction, but the amendments have not been brought into force.

The proposed OIC/Regulation would also enact a new, comprehensive Assisted Living Regulation to protect the health and safety of vulnerable persons in assisted living and establish the minimum requirements that all operators, public and private, must meet. The current Assisted Living Regulation primarily deals with the registration process and annual

fees. The new regulation would establish three classes of assisted living – (1) Seniors and Persons with Disability, (2) Mental Health, and (3) Supportive Recovery – and include requirements related to registration, fees, employee hiring, resident admissions, personal service plans, health and safety standards, housing, hospitality services, assisted living services, and emergency preparedness. These regulatory requirements were largely modelled off, and will replace, the Ministry's existing standards and policies for assisted living.

In terms of timing, we are currently aiming to bring the package to Cabinet in May.

Hi Caitlin,

The Ministry of Forests, Lands, Natural Resource Operations and Rural Development is amending the *Forest Act* to reassert management control in the forest sector and address the significant concentration of milling and forest tenure holdings. Currently, major players control the market and limit the ability to smaller operators to participate in the forest sector. Changes will improve government's ability to exert more control in transfers of Crown resources and fibre markets from changes in corporate control by:

- requiring the approval of disposition of forest agreements,
- establishing the authority to refuse the approval of a disposition for reasons of public interest or market concentration; and
- provide new a notice requirement and new tools to address public interest or market concentration where there is a change of corporate control

The legislation is scheduled to be reviewed at the March 26 Legislative Review Committee and the legislation would be introduced in early April. The legislation is accompanied by a regulation change to the Transfer Regulation, scheduled just in advance of the introduction of the legislation.

Apologies for the short notice, but these amendments have moved quickly at the request of the Premier's Office. The RFL was approved March 4.

Please note, these changes are controversial and highly confidential given the impacts to industry. Advance knowledge would likely result in significant industry and market steps to avoid the impacts of the legislation undermining its intent. As a result, there has been no consultation on the proposed amendments with stakeholders, industry or First Nations, although the latter are expected to be supportive. Nonetheless, we are contacting you to determine the best approach to inform the Green Caucus of these changes, keeping in mind these concerns.

Good afternoon,

The Ministry of Health is working on an Order in Council package to bring into force Part 3 of the *Health Care (Consent) and Care Facility (Admission) Act*, and seeks guidance on whether consultations with the BC Green Party caucus are required. Broadly speaking, the initiative relates to Seniors, listed under section 3 of the CASA.

There are a few parts to the initiative. First, the OIC will bring into force some sections of the *Health Statutes Amendment Act, 2007* (Bill 26-2007) to add Part 3 to the *Health Care (Consent) and Care Facility (Admission) Act* (HCCCFAA), introducing a consent scheme for admission to care facilities in British Columbia. This will fulfil a commitment made by the Minister of Health to the Ombudsperson in February 2017 to establish requirements for operators to seek consent or substitute consent for admission to, or continued residence in, a care facility. The HCCCFAA was originally enacted in 1993, but Part 3 has never been brought into force, leaving a gap in the regulation of admissions of persons who are incapable of providing consent, upon their admission to care facilities. The original legislation was the product of considerable stakeholder consultation relating to broader initiatives around adult guardianship, and Part 3 was re-enacted in 2007, but has remained unproclaimed.

Part 3 – to be entitled “Admission to a Care Facility” – will:

- establish processes to be followed on the admission of adults to care facilities, to ensure that an adult consents to his or her admission, or substitute consent is obtained from an authorized individual where an adult is assessed as not capable to give consent;
- establish the means for appointing a substitute decision-maker when a person has been assessed by a medical practitioner or prescribed health care provider as being incapable of consenting to admission to, or continued residence in, a care facility;
- address the determination of incapability;
- outline the rights and duties of persons authorized to give substitute consent;
- outline processes to be followed on emergency admissions; and
- provide direction on the use of restraints.

Amendments are also made to some definitions and regulation making powers under the Act.

Consequential amendments are also made to the *Community Care and Assisted Living Act* (CCALA) and *Representation Agreement Act*; and certain provisions of the *Supplements Repeal Act* are brought into force and repealed in order to achieve the coming into force of Part 3.

Secondly, amendments to the Health Care Consent Regulation under the HCCCFAA will add Part 5, entitled “Care Facilities”, to:

- provide further direction on when and how to conduct an assessment of an adult’s capability for admission to, or continued residence in, a care facility; and
- provide clarity on the manner and means of use of restraints in facilities not currently covered by the existing provisions in the Residential Care Regulation under the CCALA.

Thirdly, the Residential Care Regulation (under the CCALA) is amended to:

- establish the manner and means of obtaining consent to continuing accommodation of incapable persons (i.e., persons in care who have

Evan and Claire: please see below from Melissa Sanderson / EMPR. This is related to today's Les Leyne article. Melissa would be happy to take any questions.

- The Ministry has been an active participant in this Inquiry, which began in January 2018.
- Our participation in the Inquiry and the Feb 27 procedural conference was consistent with the outcomes of Phase 1 of the BC Hydro review; government has intervened in a BCUC proceeding to ensure that the BCUC and interveners are aware of our policy position
- The policy position supporting utility participation in vehicle charging is based on evidence from other jurisdictions which we set out, and the need to greatly expand the charging network to support the ZEV mandate and transportation GHG reduction targets in CleanBC
- This inquiry was initiated by the BCUC
- As initiator of this inquiry, the BCUC has full jurisdiction to determine the matters it wishes to examine and government has not "directed" the BCUC in this regard
- Government welcomes any recommendations that the BCUC wishes to make as a result of this inquiry.
- During the procedural conference, government suggested to the BCUC that, if it intends to make recommendations to government as a result of the inquiry, it may not be the best use of the BCUC's and interveners' time to consider issues where the government has already come to its own conclusions (e.g., whether public utilities should be involved in the build-out of EV charging infrastructure necessary to achieve CleanBC ZEV sales targets and whether they should have the ability to recover costs from ratepayers (both yes)).
- During the procedural conference, Government further suggested that recommendations that would be of most value to government are recommendations on how its policy objectives could be achieved and whether there should be any limits on the extent of cost recovery.
