- 1. We have added the following meta tags in **MyFS Dev**. Note that OG:URL is pointing to the Gov website page.

  - b. <meta property="og:title" content="You might not have to pay for child care on your own" />
  - c. <meta property="og:description" content="See if you qualify for the Affordable Child Care Benefit" />
  - d. <meta property="og:image" content="http://workingforyou.gov.bc.ca/app/uploads/sites/328/2018/08/Family-reading-together-optimized-for-facebook-1200x630.jpg"/>
- 2. Where will the user be taken to, upon clicking the Facebook Post?:
  - a. The link shared by the user on Facebook will be the one user will be navigated to upon clicking the post
  - b. OG Title, Desc and Image will be taken from the OG:URL page, and not from the OG meta tags added on MyFS Salesforce portal. Hence you see a different Title, Desc and image in Facebook screenshots than the ones mentioned in Point#1 above. (Screenshots attached).
- 3. Changes to be made to the Gov web page OG tags:
  - a.
