- It is possible that the Commissioner could order that past cabinet documents be disclosed to the commission but not released to the public.
- The purpose of requiring materials to be produced to the Commissioner, despite the existence of an immunity or privilege, is to ensure that the commission has access to the widest range of materials in order to assist in its fact-finding efforts.
- Because the Commissioner cannot know in advance of reviewing a particular document whether it will be
 found to be relevant to the commission's report and findings, the Commissioner has discretion whether
 to publicly release all or a portion of the document, or not to release it at all.


