



- Ever since we closed parks, we have been working on a phased approach to reopen.
- Most provincial parks and protected areas are now open, but some of our most popular parks experience a high number of visitors, resulting in crowded facilities, packed parking lots and safety issues, such as parking along the highway.
- Managing the number of visitors in popular parks through free day-use passes is intended to help keep parks safe for everyone to enjoy.
- We need to work together to keep our parks safe and decrease the impact on the environment.

1. What are you announcing today?

- Visitors will now require a free day-use pass to access specific areas in six provincial parks.
- The day-use passes are part of a pilot program to manage the number of visitors in popular parks and provide opportunities for physical distancing in congested areas.
- · The parks include:
 - Mount Robson Park: Berg Lake Trail
 - o Stawamus Chief Park: Chief Peaks Trail
 - Cypress Park: upper mountain trails including the Howe Sound Crest Trail, Hollyburn Mountain Trails, the Black Mountain Plateau trails.
 - Mount Seymour Park: upper mountain trails including the Seymour Main Trail, Dog Mountain trails, and Mystery Lake Trail
 - o Garibaldi Park: trailheads at Diamond Head, Rubble Creek, and Cheakamus
 - Golden Ears Park: all trails and day-use areas
- Garibaldi Park will fully re-open on July 27 with the introduction of day-use passes. The park will also open to camping on July 27.

2. Why is BC Parks doing this?

- To keep our parks safe and open for everyone, we need to work together.
- Some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots and safety issues such as parking along the highway.
- Visitor safety is our priority and day-use passes allow us to safely manage the amount of people in busy parks to prevent crowding on trails, provide opportunities for physical distancing, and a much more enjoyable experience.
- Overuse of trails also leads to environmental impacts, such as trail widening, soil erosion, damaged vegetation, altered hydrology, and increased muddiness.
- While new to BC Parks, managing day-use numbers is common in other park systems where demand exceeds capacity.

3. What are the penalties if you are caught on a trail without a pass?

Under the Park Act, the potential penalties are \$115, however the focus for this pilot will be on education and helping users adjust to the new requirements.

4. If we are a family of four, do we need four passes?

 For parks where the passes are vehicle based, you can have up to eight people per vehicle pass. If the park requires individual permits then each person in the family requires their own pass. A person can book up to eight trail passes under one booking. So for a family of four, one person can book all four trail passes for the day.

5. How do you get a day-use pass?

- The day-use passes can be attained on the Discover Camping website and will be released daily at 6 am. There is no fee for the passes.
- The number of passes available each day depends on the park and the type of pass ranges from vehicle passes for the Berg Lake Trail and Golden Ears Park, to trail passes in the other parks for the morning, afternoon or full day.
- Details for the passes in each park can be found at www.bcparks.ca.
- People are encouraged to create an account on Discover Camping ahead of time to enjoy a speedier transaction.

6. Why 6 am? I will be on the road by then.

- BC Parks worked with its online service provider to give people as much time as possible to plan and reserve their passes. We recognize 6 am will be a tight turnaround for some people.
- This is a pilot program and if the feedback we receive is that the reservation times don't work for a significant number of people, BC Parks will address that concern prior to a full launch of the program.

7. How many people will be allowed to enter each day?

- This daily limit varies by park:
 - o 50 (vehicles) for Mount Robson Berg Lake Trail parking lot
 - o 500 for Cypress Howe Sound Crest Trail
 - o 300 for Cypress Hollyburn Mountain trails
 - 500 for Cypress Black Mountain Plateau trails
 - 800 for Mount Seymour upper mountain trails
 - o 250 for Garibaldi Diamond Head trailhead
 - 340 for Garibaldi Rubble Creek trailhead
 - o 150 for Garibaldi Cheakamus trailhead
 - o 400 for Stawamus Chief Chief Peaks Trail
 - o 970 (vehicles) for Golden Ears South Beach day use parking lot
 - 100 (vehicles) for Golden Ears Alouette boat launch parking lot (trailers) 190 (vehicles) for Golden Ears East/West Canyon parking lot

8. How did you arrive at these numbers?

- These numbers were calculated to allow for those with camping passes as well as the carrying capacity of the parking lots and the trails.
- One of the many things we consider when managing our parks is carrying capacity, which is determined by the maximum number of people that can use an area while still maintaining other values, such as ecological, cultural and positive visitor experience. More information

9. What happens if you don't have a day-use pass? How will this be enforced?

- If passes are fully subscribed, you will need to wait until the next day.
- Park operators will be checking passes in the park and visitors should have a printed copy available for review or downloaded onto their phone.

10. What if non day-use pass trails intersect with those requiring passes?

People in the backcountry on multi-day trips who require brief access to a trail requiring a
pass as part of their journey will not require a pass. Similar issues will be managed with staff
using discretion and focusing primarily on visitor education.

11. Does a day use pass guarantee me a parking spot?

 We have set day use pass capacities based on several factors, including the number of parking spaces available. Day use visitors should be able to get a parking space when they book a day use pass.

12. Can you provide data on this year's visitor numbers compared to a typical year?

- Garibaldi and the Chief Peaks Trail at Stawamus Chief have been closed since March.
- Mount Seymour, Golden Ears and Cypress opened for day use June 1. Use has been higher in these parks this summer since many people are staying local due to COVID-19.
- The table below shows the number of visitors in the six parks during the last four years.

13. Are you receiving complaints about overcrowding in these parks?

- Overcrowding in parks along the Sea-to-Sky corridor has been an ongoing issue for many years and we have received complaints about overcrowding in Garibaldi.
- At Stawamus Chief, we have parking issues and had to implement a Compliance Action Plan
 a few years ago to allow park operators to tow vehicles that were illegally parked and
 blocking access for emergency vehicles on a weekly basis.
- Just before we closed the Chief Peaks Trail in March, we heard concerns about the high number of people accessing the trail and their inability to physically distance because of the multiple pinch points and high-touch surfaces on the trail. This was the impetus for closing the trail before the system-wide park closure.
- At Golden Ears we have been experiencing significantly higher volumes of visitors than in
 past years, which has led to long line-ups along the park access road. It has impacted visitor
 experience and is a serious public safety issue as emergency vehicles do not have access to

the park. A day-use pass will give visitors the comfort of knowing they have access to the park and will alleviate heavy line-ups for access to a limited number of parking spaces.

14. Has the increase in visitors led to budget pressures for BC Parks?

The surge in visitation since COVID, along with the enhanced cleaning of our facilities has
resulted in increased cost and government has provided BC Parks with an additional \$8.1
million to deal with these new pressures. Funding in the amount of \$900k for the new day
use pass system pilot is included in that new funding.

15. Wouldn't the money being spent on the pilot program be better spent investing in BC Parks aging infrastructure such as trails and campsites?

- Managing use in these busy parks is key to protecting the park infrastructure from the damage that comes from over-use. BC Parks is undertaking a comprehensive capital program as it does each year including:
 - Annual Park Facility Maintenance Program \$13.98M
 - Special backcountry facility capital \$1M
 - o Campsite expansion capital \$17.9M since 2017 including \$4.17M this year

16. How long will the day-use pass pilot program last and will you be adding more parks this year?

At this time, we don't plan to expand the program further this year. The pilot program will be
in place for the peak season until October 1 for all parks except the Berg Lake Trail at Mount
Robson and Golden Ears. The passes will end at Mount Robson on Sept. 15 and Oct. 12 for
Golden Ears.

17. Could this pilot project be expanded in future years?

- BC Parks has seen more visitors to our parks over the years and this can lead to overcrowding and high environmental impacts.
- As we look for ways to ease pressures from high visitor numbers, day-use passes could be explored as a possible option.
- While new to BC Parks, active management of day-use numbers is common in other parks systems where demand exceeds capacity

18. Aren't you just putting more pressure on local and regional parks by limiting numbers?

- Our mandate as a park agency is to protect and conserve these areas to enable their continued enjoyment for all British Columbians. Unmanaged and growing use has adverse impacts on the very values that make these areas special.
- BC Parks has been in frequent communication with adjacent municipalities and partner agencies, so they are aware of the ongoing initiatives we have been implementing.

19. What about backcountry campers?

- Backcountry campers with camping permits do not require a day-use pass. They will need to
 have their camping permits ready to show park operator staff at the trailhead. Parks with
 backcountry camping permits include: Garibaldi Park, Golden Ears park, and Mount Robson
 Park.
- Day passes are required for the day of entry in Mount Seymour and Cypress Parks as these parks do not require a permit to camp.
- Day passes are required for all users of the Stawamus Chief Park Chief Peaks Trail, including users staying in the front country campground. There is no backcountry camping in Stawamus Chief Park.

20. Will this restrict First Nations access?

 No. First Nations will not require a pass to access the parks for food, ceremonies and other uses.

21. How many parks are now open?

- There are now 868 parks and protected areas open.
- A number of parks and protected areas remain closed near vulnerable and remote communities and will only reopen when it is safe to do so, taking into consideration the safety of the visitors and staff, impact on nearby communities and protection of the environment. Some parks might have to remain closed.
- BC Parks continues to work with these communities to respect their interests and address concerns about reopening these parks.

"People in B.C. love the outdoors, but some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots and safety issues, such as parking along the highway," said George Heyman, Minister of Environment and Climate Change Strategy. "This pilot program acknowledges that frequent park users have an important role to play in protecting these important natural spaces and the species that depend upon them."

Although parks have wide open spaces, most visitors are often confined to trails that can become crowded in certain areas like viewpoints. Overuse of trails leads to environmental impacts, such as trail widening, soil erosion, altered hydrology and damaged vegetation.

Beginning Monday, July 27, 2020, people can get a free BC Parks day-use pass and visit certain areas in six of the busiest parks, including:

- * Mount Robson Park: Berg Lake Trail
- * Stawamus Chief Park: Chief Peaks Trail
- * Cypress Park: upper mountain trails, including the Howe Sound Crest Trail, Hollyburn Mountain Trails and the Black Mountain Plateau trails
- * Mount Seymour Park: upper mountain trails including the Seymour Main Trail, Dog Mountain Trail and Mystery Lake Trail
- * Garibaldi Park: trailheads at Diamond Head, Rubble Creek and Cheakamus
- * Golden Ears Park: all trails and day-use areas

Garibaldi Park will fully reopen on July 27 with the introduction of day-use passes in select areas. Like many parks in the Sea-to-Sky corridor, Garibaldi has seen a significant increase in visitors during the last four years, which has led to overcrowding in some areas of the park.

The free day-use passes are part of a pilot program intended to help BC Parks re-open busy areas and test the passes as a tool to manage overcrowding. The passes can be obtained on the Discover Camping website and will be released daily at 6 a.m. for same-day bookings. The number of passes available each day depends on the park and ranges from vehicle passes for the Berg Lake Trail and Golden Ears Park to individual trail passes in the other parks for morning, afternoon or full day.

"We strongly support BC Parks reopening these six popular parks, while working to manage visitation and conserve nature in the places we love," said Bruce Passmore, executive director, Canadian Parks and Wilderness Society, B.C. chapter. "With many people staying home this summer, the demand for outdoor recreation continues to surge, putting more pressure on our park system. We welcome solutions that will help manage overcrowding in certain areas and strengthen our opportunity to protect vital ecosystems."

Backcountry campers with camping permits are not required to reserve a day-use pass, but should carry proof of their camping permit if they are using one of the select trails that require a pass. Park operator staff will be checking passes upon arrival. Visitors can download the pass onto their mobile device or print it to show at the park.

VICTORIA – To help people stay active and safe in several of B.C.'s most popular provincial parks, government is introducing a new, free day-use pass pilot program.

"People in B.C. love the outdoors, but some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots, and safety issues such as parking along the highway," said George Heyman, Minister of Environment and Climate Change Strategy. "This pilot program acknowledges that frequent park users have an important role to play in protecting these important natural spaces and the species that depend upon them."

Although parks have wide open spaces, most visitors are often confined to trails that can become crowded in certain areas like viewpoints. Overuse of trails leads to environmental impacts, such as trail widening, soil erosion, altered hydrology and damaged vegetation.

Beginning July 27, people can access a free BC Parks day-use pass and visit certain areas in six of the busiest parks, including:

- o Mount Robson Park: Berg Lake Trail
- o Stawamus Chief Park: Chief Peaks Trail
- Cypress Park: upper mountain trails including the Howe Sound Crest Trail, Hollyburn Mountain Trails, and the Black Mountain Plateau trails
- Mount Seymour Park: upper mountain trails including the Seymour Main Trail, Dog Mountain Trail, and Mystery Lake Trail
- o Garibaldi Park: trailheads at Diamond Head, Rubble Creek, and Cheakamus
- o Golden Ears Park: all trails and day-use areas

Garibaldi Park will fully reopen on July 27 with the introduction of day-use passes in select areas. Like many parks in the Sea-to-Sky corridor, Garibaldi has seen a significant increase in visitors during the last four years, which has led to overcrowding in some areas of the park.

The free day-use passes are part of a pilot program intended to help BC Parks re-open busy areas and test passes as a tool to manage overcrowding. The passes can be obtained on the Discover Camping website and will be released daily at 6 am for same-day bookings so people can plan for the day, knowing they can visit their park of choice before they hit the road. The number of passes available each day depends on the park and ranges from vehicle passes for the Berg Lake Trail and Golden Ears Park to individual trail passes in the other parks for morning, afternoon or full day.

"We strongly support BC Parks reopening these six popular parks while working to manage visitation and conserve nature in the places we love," said Bruce Passmore, the Executive Director of Canadian Parks and Wilderness Society, BC Chapter. "With many people staying home this summer, the demand for outdoor recreation continues to surge, putting more pressure on our park system. We welcome solutions that will help manage overcrowding in certain areas and strengthen our opportunity to protect vital ecosystems."

Backcountry campers with camping permits are not required to reserve a day-use pass, but should carry proof of their camping permit if they are using one of the select trails that require a pass. Park operator staff will be checking passes upon arrival. Visitors can download the pass onto their mobile device or print it to show at the park.

27. How did you arrive at these numbers?

- These numbers were calculated to allow for those with camping passes as well as the carrying capacity of the parking lots and the trails.
- One of the many things we consider when managing our parks is carrying capacity, which is determined by the maximum number of people that can use an area while still maintaining

28. What happens if you don't have a day-use pass? How will this be enforced?

- · If passes are fully subscribed, you will need to wait until the next day.
- Park operators will be checking passes in the park and visitors should have a printed copy available for review or downloaded onto their phone.

29. What if you are on a trail that requires a pass in order access a trail that doesn't require a pass, could you still face a penalty?

The pilot project is a test to see how the system addresses the problem of overcrowding in some provincial parks.

We will learn as we go and at the outset the focus is education not enforcement. Once enforcement kicks in, Rangers will exercise their discretion.

30. Does a day use pass guarantee me a parking spot?

 We have set day use pass capacities based on several factors, including the number of parking spaces available. Day use visitors should be able to get a parking space when they book a day use pass.

31. Can you provide data on this year's visitor numbers compared to a typical year?

- · Garibaldi and the Chief Peaks Trail at Stawamus Chief have been closed since March.
- Mount Seymour, Golden Ears and Cypress opened for day use June 1. Use has been higher
 in these parks this summer since many people are staying local due to COVID-19.
- The table below shows the number of visitors in the six parks during the last four years.

32. Are you receiving complaints about overcrowding in these parks?

- Overcrowding in parks along the Sea-to-Sky corridor has been an ongoing issue for many years and we have received complaints about overcrowding in Garibaldi.
- At Stawamus Chief, we have parking issues and had to implement a Compliance Action Plan
 a few years ago to allow park operators to tow vehicles that were illegally parked and
 blocking access for emergency vehicles on a weekly basis.
- Just before we closed the Chief Peaks Trail in March, we heard concerns about the high number of people accessing the trail and their inability to physically distance because of the

- multiple pinch points and high-touch surfaces on the trail. This was the impetus for closing the trail before the system-wide park closure.
- At Golden Ears we have been experiencing significantly higher volumes of visitors than in
 past years, which has led to long line-ups along the park access road. It has impacted visitor
 experience and is a serious public safety issue as emergency vehicles do not have access to
 the park. A day-use pass will give visitors the comfort of knowing they have access to the
 park and will alleviate heavy line-ups for access to a limited number of parking spaces.

33. Has the increase in visitors led to budget pressures for BC Parks?

No. There are no area/local pressures identified at this time.

34. How long will the day-use pass pilot program last and will you be adding more parks this year?

At this time, we don't plan to expand the program further this year. The pilot program will be
in place for the peak season until October 1 for all parks except the Berg Lake Trail at Mount
Robson and Golden Ears. The passes will end at Mount Robson on Sept. 15 and Oct. 12 for
Golden Ears.

35. Could this pilot project be expanded in future years?

- BC Parks has seen more visitors to our parks over the years and this can lead to overcrowding and high environmental impacts.
- As we look for ways to ease pressures from high visitor numbers, day-use passes could be explored as a possible option.
- While new to BC Parks, active management of day-use numbers is common in other parks systems where demand exceeds capacity

36. Aren't you just putting more pressure on local and regional parks by limiting numbers?

- Our mandate as a park agency is to protect and conserve these areas to enable their continued enjoyment for all British Columbians. Unmanaged and growing use has adverse impacts on the very values that make these areas special.
- BC Parks has been in frequent communication with adjacent municipalities and partner agencies, so they are aware of the ongoing initiatives we have been implementing.

37. What about backcountry campers?

- Backcountry campers with camping permits do not require a day-use pass. They will need to
 have their camping permits ready to show park operator staff at the trailhead. Parks with
 backcountry camping permits include: Garibaldi Park, Golden Ears park, and Mount Robson
 Park.
- Day passes are required for the day of entry in Mount Seymour and Cypress Parks as these parks do not require a permit to camp.
- Day passes are required for all users of the Stawamus Chief Park Chief Peaks Trail, including users staying in the front country campground. There is no backcountry camping in Stawamus Chief Park.

38. Will this restrict First Nations access?

 No. First Nations will not require a pass to access the parks for food, ceremonies and other uses.

39. How many parks are now open?

- There are now 868 parks and protected areas open.
- A number of parks and protected areas remain closed near vulnerable and remote communities and will only reopen when it is safe to do so, taking into consideration the

B.C. introduces free day-use passes for six popular provincial parks

VICTORIA – To help people stay active and safe in several of B.C.'s most popular provincial parks, government is introducing a new, free day-use pass pilot program.

"People in B.C. love the outdoors, but some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots, and safety issues such as parking along the highway," said George Heyman, Minister of Environment and Climate Change Strategy. "This program acknowledges that frequent park users have an important role to play in protecting these important natural spaces and the species that depend upon them."

Although parks have wide open spaces, most visitors are often confined to trails that can become crowded. Overuse of trails leads to environmental impacts, such as trail widening, soil erosion, altered hydrology and damaged vegetation.

Beginning July 27, people can access a free BC Parks day-use pass and then visit certain areas in six of the busiest parks, including:

- o Mount Robson Park: Berg Lake Trail
- o Stawamus Chief Park: Chief Peaks Trail
- Cypress Park: upper mountain trails including the Howe Sound Crest Trail, Hollyburn Mountain Trails, and the Black Mountain Plateau trails
- Mount Seymour Park: upper mountain trails including the Seymour Main Trail, Dog Mountain Trail, and Mystery Lake Trail
- o Garibaldi Park: trailheads at Diamond Head, Rubble Creek, and Cheakamus
- o Golden Ears Park: all trails and day-use areas

Garibaldi Park will fully reopen on July 27 with the introduction of day-use passes in select areas. Like many parks in the Sea-to-Sky corridor, Garibaldi has seen a significant increase in visitors during the last four years, which has led to overcrowding in some areas of the park.

The free day-use passes are part of a pilot program intended to help BC Parks re-open busy areas and test passes as a tool to manage overcrowding. The passes can be obtained on the Discover Camping website and COVID-19 – Park system reopen COMM Plan

June 2020

will be released daily at 6 am for same-day bookings so people can plan for the day, knowing they can visit their park of choice before they hit the road. The number of passes available each day depends on the park and ranges from vehicle passes for the Berg Lake Trail and Golden Ears Park to individual trail passes in the other parks for morning, afternoon or full day.

"We strongly support BC Parks reopening these six popular parks while working to manage visitation and conserve nature in the places we love," said Bruce Passmore, the Executive Director of Canadian Parks and Wilderness Society, BC Chapter. "With many people staying home this summer, the demand for outdoor recreation continues to surge, putting more pressure on our park system. We welcome solutions that will help manage overcrowding in certain areas and strengthen our opportunity to protect vital ecosystems."

Backcountry campers with camping permits are not required to reserve a day-use pass, but should carry proof of their camping permit if they are using one of the select trails that require a pass. Park operator staff will be checking passes upon arrival. Visitors can download the pass onto their mobile device or print it to show at the park.

Further details about the passes required in each park, along with detailed information about BC Parks response to COVID-19 and which parks remain closed, can be found at www.bcparks.ca. Before heading out, people are advised to visit the individual park page for any changes to available services.





41. Are you receiving complaints about overcrowding in these parks?

- Overcrowding in parks along the Sea-to-Sky corridor has been an ongoing issue for many years.
- In 2017/2018, Cypress Park had 1,832,635 visitors, Mount Seymour Park had 946,597 visitors, Garibaldi Park had 106,951, Stawamus Chief Park had 547,201, and Mount Robson Park had 205,559 visitors.
- At Stawamus Chief, we have parking issues and had to implement a Compliance Action Plan
 a few years ago to allow park operators to tow vehicles that were illegally parked and
 blocking access for emergency vehicles on a weekly basis.
- Just before we closed the Chief Peaks Trail in March, we heard concerns about the high number of people accessing the trail and their inability to physically distance because of the multiple pinch points and high-touch surfaces on the trail. This was the impetus for us closing the trail before the system-wide park closure.
- Garibaldi and the Chief Peaks Trail in Stawamus Chief Park have been closed since March, but some people have ignored the closure.

42. Have the increased visitors led to budget pressures for BC Parks?

No. There are no area/local pressures identified at this time.

43. Could you be adding more parks to the day-use pass program this year?

 It is possible that other parks may be added as the summer progresses, depending on the visitor numbers and if people are complying with the guidance provided by the PHO.

44. Aren't you just putting more pressure on local and regional parks by limiting numbers?

 No. BC Parks has been in frequent communication with adjacent municipalities and partner agencies, so they are aware of the on-going initiatives that BC Parks have been implementing.

45. Is this a pilot project which could be expanded in future years?

- BC Parks has seen more visitors to our parks over the years and this can lead to overcrowding and high environmental impacts.

46. How do you get a day-use pass?

- The day-use passes can be attained on the Discover Camping website and will be released daily at 12 am. There is no fee for the passes.

- These limits were calculated to allow for those with camping passes as well as the carrying capacity of the parking lots and the trails. The numbers could change as the situation evolves.

- If passes are sold out, you will need to wait until the next day.
- BC Parks staff will be checking passes in the park and visitors should have a printed copy available for review or download one onto their phone.
- Depending upon the park, passes may be checked upon arrival at the parking lot or at the trail

49. Is this temporary?

 This will be in place for the peak season until October 1 for all parks except for the Berg Lake Trail, which will end the day-use passes on September 15.

50. How many parks are now open?

- There are 868 parks and protected areas open.
- A number of parks and protected areas remain closed near vulnerable and remote communities and will only reopen when it is safe to do so, taking into consideration the safety of the visitors and staff, impact on nearby communities and protection of the environment. Some parks might have to remain closed.
- BC Parks continues to work with these communities to respect their interests and address concerns about reopening these parks.

Free day use permits required for six popular provincial parks

VICTORIA – BC Parks is implementing a new free day-use permitting program in six provincial parks so people can stay safe, active and enjoy some of BC's most popular tourist destinations this summer.

"Some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots, and safety issues, such as parking along the highway," said George Heyman, Minister of Environment and Climate Change Strategy. "Managing the number of visitors through day-use permits in certain areas will help keep these popular parks open and safe for everyone to enjoy throughout the summer, and decrease the impact on sensitive environments."

As of July 8, BC Parks will be requiring day-use permits for the Berg Lake Trail in Mount Robson Park, the Chief Peaks Trail at Stawamus Chief Park, and Peace Arch Park, which was temporarily closed on June 18 to address concerns about public safety and in neighbouring communities due to a significant increase in park visitors. On July 15, Cypress Park, Mount Seymour Park and Garibaldi Park will require a day-use permit for specific trails. Other trails within the parks may not require a day pass.

The free permits can be attained on the Discover Camping website and will be released daily for same-day bookings at 12 am. The number of permits available each day depends on the park, and the type of permit ranges from vehicles to trails for morning, afternoon or full day. For example, Garibaldi Park, which has been temporarily closed, will have 250 permits available for people wanting to access the Diamond Head area, 150 permits for Cheakamus and 340 permits for Rubble Creek. Peace Arch Park will have a daily limit of 240 vehicles. Details for each pass can be found on www.bcparks.ca.

BC Parks staff will be checking passes upon arrival at the parking lot or at the trailhead. Visitors can download the permit on their mobile device or print it for presentation. The fee permits will be required until the end of October for five of the parks. Berg Lake Trail willhave the permit system in place until Sept. 15.

Background

In March 2020, the Provincial Health Officer (PHO) issued an order requiring physical distancing between people while out in public and when recreating to prevent the spread of COVID-19.

BC Parks encountered implementation challenges, with park visitors not following the PHO's directive to maintain 2-metre spacing, which put visitor and staff health at risk. As phase one of BC Parks reopening approach BC Parks re-opened many parks on May 14th for day use. Phase two re-opened the Discover Camping reservation system on May 25th and campgrounds on June 1st for most parks. Along with some near vulnerable populations, parks near the Lower Mainland and the popular Berg Lake Trail in Mt. Robson with very high visitor numbers have remained closed.

For phase three of parks reopening in some of the busier parks, the strategy to re-open under reduced visitor numbers is to use a new day use reservation system

Purpose of the Plan

To guide internal communications in support of the new day use reservation system and pass requirement for 6 provincial parks to be implemented in two phases.

Communications Objectives

- To inform staff, partners, stakeholders, and the general public of the new day use pass for 6 popular parks and what it means for visitors.
- To ensure the public is aware of the new system and how it helps meet the expectations outlined by the Provincial Health Officer as they relate to safe recreational practices and allowing us to re-open these popular parks.
- To align with the last phase of the strategic plan for reopening the parks and protected area system, including specific communications related to the phase of the plan.

Strategic Approach

- Ever since we closed parks, we have been working on a phased approach to reopen.
- Most provincial parks and protected areas are now open, but some
 of our most popular parks experience a high number of visitors,

- 1. What are you announcing today?

- Visitors will now require a free day-use pass to access specific areas in six provincial parks.
- The day-use passes are part of a pilot program to manage the number of visitors in popular parks and provide opportunities for physical distancing in congested areas.
- · The parks include:
 - Mount Robson Park: Berg Lake Trail
 - Stawamus Chief Park: Chief Peaks Trail
 - Cypress Park: upper mountain trails including the Howe Sound Crest Trail, Hollyburn Mountain Trails, the Black Mountain Plateau trails.
 - Mount Seymour Park: upper mountain trails including the Seymour Main Trail,
 Dog Mountain trails, and Mystery Lake Trail
 - Garibaldi Park: trailheads at Diamond Head, Rubble Creek, and Cheakamus
 - Golden Ears Park: all trails and day-use areas
- Garibaldi Park will fully re-open on July 27 with the introduction of day-use passes. The
 park will also open to camping on July 27.

2. Why is BC Parks doing this?

- To keep our parks safe and open for everyone, we need to work together.
- Some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots and safety issues such as parking along the highway.
- Visitor safety is our priority and day-use passes allow us to safely manage the amount of people in busy parks to prevent crowding on trails, provide opportunities for physical distancing, and a much more enjoyable experience.
- Overuse of trails also leads to environmental impacts, such as trail widening, soil
 erosion, damaged vegetation, altered hydrology, and increased muddiness.
- While new to BC Parks, managing day-use numbers is common in other park systems where demand exceeds capacity.

52. What are the penalties if you are caught on a trail without a pass?

 Under the Park Act, the potential penalties are \$115, however the focus for this pilot will be on education and helping users adjust to the new requirements.

53. If we are a family of four, do we need four passes?

 For parks where the passes are vehicle based, you can have up to eight people per vehicle pass. If the park requires individual permits then yes, each person in the family requires their own pass. A person can book up to eight trail passes under one booking. So for a family of four, one person can book all four trail passes for the day.

54. How do you get a day-use pass?

 The day-use passes can be attained on the Discover Camping website and will be released daily at 6 am. There is no fee for the passes.

- The number of passes available each day depends on the park and the type of pass ranges from vehicle passes for the Berg Lake Trail and Golden Ears Park, to trail passes in the other parks for the morning, afternoon or full day.

- People are encouraged to create an account on Discover Camping ahead of time to enjoy a speedier transaction.

55. Why 6 am? I will be on the road by then.

- BC Parks worked with its online service provider to give people as much time as possible to plan and reserve their passes. We recognize 6 am will be a tight turnaround for some people.
- This is a pilot program and if the feedback we receive is that the reservation times don't work for a significant number of people, BC Parks will address that concern prior to a full launch of the program.

56. How many people will be allowed to enter each day?

- This daily limit varies by park. Initially it was:
 - o 50 (vehicles) for Mount Robson Berg Lake Trail parking lot
 - o 500 for Cypress Howe Sound Crest Trail
 - 300 for Cypress Hollyburn Mountain trails
 - o 500 for Cypress Black Mountain Plateau trails
 - 800 for Mount Seymour upper mountain trails
 - 250 for Garibaldi Diamond Head trailhead
 - 340 for Garibaldi Rubble Creek trailhead
 - o 150 for Garibaldi Cheakamus trailhead
 - o 400 for Stawamus Chief Chief Peaks Trail
 - \circ 970 (vehicles) for Golden Ears South Beach day use parking lot
 - 100 (vehicles) for Golden Ears Alouette boat launch parking lot (trailers)
 190 (vehicles) for Golden Ears East/West Canyon parking lot

57. How did you arrive at these numbers?

- These numbers were calculated to allow for those with camping passes as well as the carrying capacity of the parking lots and the trails.
- One of the many things we consider when managing our parks is carrying capacity, which is determined by the maximum number of people that can use an area while still maintaining other values, such as ecological, cultural and positive visitor experience. 58. What happens if you don't have a day-use pass? How will this be enforced?

- If passes are fully subscribed, you will need to wait until the next day.
- Park operators will be checking passes in the park and visitors should have a printed copy available for review or downloaded onto their phone.

59. What are the penalties if you are caught on a trail without a pass?

 Under the Park Act, the potential penalties are \$115, however the focus for this pilot will be on education and helping users adjust to the new requirements.

60. What if non day-use pass trails intersect with those requiring passes?

 People in the backcountry on multi-day trips who require brief access to a trail requiring a pass as part of their journey will not require a pass. Similar issues will be managed with staff using discretion and focusing primarily on visitor education.

61. Does a day use pass guarantee me a parking spot?

 We have set day use pass capacities based on several factors, including the number of parking spaces available. Day use visitors should be able to get a parking space when they book a day use pass.

62. Can you provide data on this year's visitor numbers compared to a typical year?

- Garibaldi and the Chief Peaks Trail at Stawamus Chief have been closed since March.
- Mount Seymour, Golden Ears and Cypress opened for day use June 1. Use has been higher in these parks this summer since many people are staying local due to COVID-19
- The table below shows the number of visitors in the six parks during the last four years.

63. Are you receiving complaints about overcrowding in these parks?

- Overcrowding in parks along the Sea-to-Sky corridor has been an ongoing issue for many years and we have received complaints about overcrowding in Garibaldi.
- At Stawamus Chief, we have parking issues and had to implement a Compliance Action Plan a few years ago to allow park operators to tow vehicles that were illegally parked and blocking access for emergency vehicles on a weekly basis.
- Just before we closed the Chief Peaks Trail in March, we heard concerns about the high number of people accessing the trail and their inability to physically distance because of the multiple pinch points and high-touch surfaces on the trail. This was the impetus for closing the trail before the system-wide park closure.
- At Golden Ears we have been experiencing significantly higher volumes of visitors than
 in past years, which has led to long line-ups along the park access road. It has impacted
 visitor experience and is a serious public safety issue as emergency vehicles do not
 have access to the park. A day-use pass will give visitors the comfort of knowing they
 have access to the park and will alleviate heavy line-ups for access to a limited number
 of parking spaces.

64. Has the increase in visitors led to budget pressures for BC Parks?

The surge in visitation since COVID, along with the enhanced cleaning of our facilities
has resulted in increased cost and government has provided BC Parks with an additional
\$8.2 million to deal with these new pressures. The funding for the new day use pass
system pilot are also included in that new funding.

65. Wouldn't the money being spent on the pilot program be better spent investing in BC Parks aging infrastructure such as trails and campsites?

- Managing use in these busy parks is key to protecting the park infrastructure from the damage that comes from over-use. BC Parks is undertaking a comprehensive capital program as it does each year including:
 - Annual Park Facility Maintenance Program \$13.98M

- o Special backcountry facility capital \$1M
- o Campsite expansion capital \$17.9M since 2017 including \$4.17M this year
- As well, BC Parks has identified additional capital works that have been proposed for consideration as part of government's economic recovery package.

66. Aren't you just putting more pressure on local and regional parks by limiting numbers?

- Our mandate as a park agency is to protect and conserve these areas to enable their continued enjoyment for all British Columbians. Unmanaged and growing use has adverse impacts on the very values that make these areas special.
- BC Parks has been in frequent communication with adjacent municipalities and partner agencies, so they are aware of the ongoing initiatives we have been implementing.

67. What about backcountry campers?

- Backcountry campers with camping permits do not require a day-use pass. They will
 need to have their camping permits ready to show park operator staff at the trailhead.
 Parks with backcountry camping permits include: Garibaldi Park, Golden Ears park, and
 Mount Robson Park
- Day passes are required for the day of entry in Mount Seymour and Cypress Parks as these parks do not require a permit to camp.
- Day passes are required for all users of the Stawamus Chief Park Chief Peaks Trail, including users staying in the front country campground. There is no backcountry camping in Stawamus Chief Park.

68. Will this restrict First Nations access?

 No. First Nations will not require a pass to access the parks for food, ceremonies and other uses.

69. How many parks are now open?

- There are now 868 parks and protected areas open.
- A number of parks and protected areas remain closed near vulnerable and remote communities and will only reopen when it is safe to do so, taking into consideration the safety of the visitors and staff, impact on nearby communities and protection of the environment. Some parks might have to remain closed.
- BC Parks continues to work with these communities to respect their interests and address concerns about reopening these parks.

70. How long will the day-use pass pilot program last and will you be adding more parks this year?

At this time, we don't plan to expand the program further this year. The pilot program will
be in place for the peak season until October 1 for all parks except the Berg Lake Trail at
Mount Robson and Golden Ears. The passes will end at Mount Robson on Sept. 15 and
Oct. 12 for Golden Ears.

71. Could this pilot project be expanded in future years?

- BC Parks has seen more visitors to our parks over the years and this can lead to overcrowding and high environmental impacts.
- As we look for ways to ease pressures from high visitor numbers, day-use passes could be explored as a possible option.

PITCH:

BC Parks is implementing a new free day-use pass program in five provincial parks – the Berg Lake Trail in Mount Robson Park, the Chief Peaks Trail at Stawamus Chief Park, and select trails within Cypress Park, Mount Seymour Park and Garibaldi Park. Garibaldi Park has been closed since April and Stawamus Chief Park has been partially closed since March due to overcrowding during the COVID-19 pandemic.

What is the challenge/ opportunity?

Opportunities:

- Overcrowding in parks in the Sea-to-Sky corridor has been an ongoing issue for many years.
- Visitor numbers show how busy the targeted parks can get during the summer.
 - In 2017/2018, Cypress Park had 1,832,635 visitors, Mount Seymour Park had 946,597, Garibaldi Park had 106,951, Stawamus Chief Park had 547,201, and Mount Robson Park had 205,559 visitors.
- Mount Seymour and Cypress opened for day use on June 1
- Day-use passes provide an opportunity to try a system that can help manage the number of visitors in some of the most popular parks, which also minimizes the impact on the environment and helps improve overall visitor experience.
- It also provides more opportunities for physical distancing in congested areas so people can safely enjoy the benefits of being out in B.C.'s popular parks.

Challenges:

 There will be pushback from people who now need to get a day-use pass to access their regular park, and in some cases, using parts of the park currently accessible without a pass.

- Demand could outstrip supply. The number of passes available each day depends on the park and ranges from vehicle passes to access the Berg Lake Trail to individual trail passes in the other parks for morning, afternoon or full day.
- The passes are only available online booking through telephone or at the
 gate are not options. It is also not clear if the online system will be able to
 accommodate increased traffic from people booking day-use passes at the
 same time as people are booking campsites on the same system

Enforcement may be challenging in a park setting. Depending on the park, monitoring may happen either at the gatehouse/trailhead or through spot checks along the trail.

	 Most provincial parks and protected areas are now open, but some of our most popular parks are experiencing a high number of visitors, resulting in crowded facilities, packed parking lots and safety issues, such as parking along the highway. Managing the number of visitors in popular parks through free day-use passes will allow more parks to re-open and help keep other parks safe for everyone to enjoy. We need to work together to keep people safe and protect the natural ecology of our parks.
Is it time sensitive?	Yes. Since summer is the busy season for outdoor enthusiasts, BC Parks would like to have the day-use permits in place asap. The passes will be required until October for four parks. The Berg Lake Trail will have the pass system in place until Sept. 15.
What is the planning arc and timeline?	 Issue a province-wide NR ideally a week before the launch of the day-use program. (Date TBD). Messaging about the new permits and where to get them will also be posted on the BC Parks website, and BC Parks/BC Gov social media channels. BC Parks will also send emails to PUP holders and stakeholders (park operators, volunteers, Discover Camping customers). Signage will also be posted in the parks that are impacted. In addition to NR, CLOs can do interviews with local media if GCPE gets requests from media. Social media will again be used on the day the program launches to remind people about the day-passes.
