Subject: Transport Canada - reimplementation of the closed deck restriction for BC Ferries

I was advised by BC Ferries this morning that Transport Canada is lifting the waiver that permitted passengers to remain in their vehicles in the enclosed lower car decks. As of September 30th, passengers will have to once again make their way to the main passenger decks during transit. BC Ferries will be making an announcement on this change today and they anticipate significant public backlash.

BC Ferries wanted to retain the waiver and made appeals to the Minister of Transport at the federal level but were unsuccessful.

I provided a heads up to Lori and understand that this is already known within government but was previously unknown to me and wanted to make sure you are all aware as we receive media inquiries.
