**Re: Vancouver Canucks and National Hockey League Request for Exemption to the Quarantine Act**

I have reviewed the Vancouver Canucks Training Camp at Rogers Arena Plan (Dec 2020) and the National Hockey League (NHL) Training Camp and Regular Season COVID-19 Protocols and NHL 2020/21 Season Club Travel Protocol which outline the protocols that Vancouver Canucks and NHL plan to implement to control COVID-19 transmission among players and staff during training camp in Vancouver, BC scheduled for December 2020. Vancouver Canucks are requesting an exemption to the Quarantine Act so that players and staff returning to Canada can participate in training camp activities during their quarantine period.

Vancouver Canucks propose using a "working quarantine" as was approved by the federal government, the Provincial Health Officer, the Ministry of Health and Vancouver Coastal Health and successfully executed by the organization in July 2020. The plan would allow players and staff returning to Canada to participate in training camp activities along with other players and staff during their quarantine period.

According to the protocols, for 14 days following return to Canada each player or staff member who has not been diagnosed with COVID-19, does not have COVID-19 symptoms and has not been in contact with a confirmed case of COVID-19, would be permitted to leave their residence or hotel to engage in training camp activities only.

Vancouver Canucks will regularly test all players and staff according to NHL protocols. Each positive test result will be reported to the local health authority. Each person with a positive test result must isolate for at least 10 days at the direction of the local health authority. Obtaining negative results does not modify this requirement.

Vancouver Coastal Health (VCH) has been happy to work with Vancouver Canucks and NHL as they move through their return to training and return to play protocols and is in support of their request for an exemption to the Quarantine Act so that players and staff may return to Canada and participate in training camp during their quarantine period as we believe the risk to players, staff and the community as a result of these protocols is low.

*"Recently, over the last weeks, we've seen an increase in community exposures connected to recreational sports like hockey and soccer as they've started, slowly, to restart. The result has been that some sports facilities have needed to close or shut down for periods of time. We know that physical activity is important for our overall health. And from the beginning we've encouraged people to go outside and to be active. And we know, as well, that it's incredibly important for young people and for our school-aged children.*

*"As with many other activities that have restarted, these facilities, sports leagues and recreational organizations needed to have a COVID-19 safety plan, and we've been working with the organizations to make sure that those are guided by public health principles to ensure that we can have a safe return to sport.*

*And, like the recent NHL playoffs, the plans have prioritized the players over the spectators. And I know that's a challenge for some people who want to be there to support their children, in particular, who are playing on teams, but we also know that spending time socializing or cheering with other parents and fans before, during and following games increases risks of transmission and exposure for families.*

*"That's why there are restrictions on spectators in arenas and on sidelines at games. And it's important for all of us to think about our cumulative interactions. The more time we spend with others in one area means we have to be careful about spending less time in another area. If you're in a busy workplace, have children in school, then it is all the more important to limit your time with others on other, whether it's social events or recreational sports and other areas.*

*"As much as you may want to see the winning goal or celebrate that perfect pass after the game, we need to ensure that we are keeping ourselves and our loved ones safe. And the best way to do that is to follow our COVID-19 safety basics on and off the field.*

*"I know most people are doing the right thing, but I ask that you keep this top of mind. It is important for us as communities across this province to keep our workplaces open and essential that we keep our schools open for the health of our community and for the health of our children.*

*"This new normal is new, and it's new for all of us. But it is not forever. It is for now. And that means if you are playing in a sports league, pick one league. Don't pick multiple leagues. If your children are involved in activities after school, pare it down so that they're not exposed to large numbers of different groups of people at different days.*

*"Our actions today have a direct impact on how our province will fare tomorrow and in the weeks to come. We know that we can do this. We have seen us flattening our curve again. We've kept our numbers in control, mostly through the work that we're doing together to keep our interactions safe, and the work that the public health teams are doing to follow up an individual.*

*"Each day and month that you choose to do the right thing, you're helping to protect all of us. You're in keeping our important activities and places open and safe. And just as we did this past weekend, let's continue to find new ways to support each other and show we care at a safe distance."*

**Request**

I'm a reporter from CBC News looking for comment on hockey and the potential spread of COVID-19.

A report from the CDC on a recreational hockey game in Florida points to hockey as being a breeding ground for transmission.

It notes that "the sport, which includes heavy respiration and frequent physical contact, was the likely vehicle for the outbreak. Despite a smaller number of players and few spectators, the report notes that venues like ice rinks—closed spaces where people are in close contact—are hotbeds for virus transmission.

"The indoor space and close contact between players during a hockey game increase infection risk for players and create potential for a superspreader event, especially with ongoing community COVID-19 transmission," the report read.

I am wondering if the health ministry can comment on this and whether any restrictions will be placed on indoors sports like hockey this winter. Is there anything in particular coaches and players should do to protect themselves? (Masks while playing?)
