I'd be interested in seeing what this would could out to with labour included based on projections.

I'm looking at the very broad price overview of this, taken into consideration with the specs that Scott's team at TNO have outlined for a dialed back, but similar vision.

The large price tag of TNO's option would equate to about 10 years worth of projected use, whereas the same budget, applied to a projection of the rental costs provided here would equate to 2.3 years of coverage, not inclusive of labour.

I'm not married to either of these options, although I do have thoughts about each. But having all of these estimates in front of me really helps to sharpen the thinking around long-term costs, value and use cases of each setup, and the potential for each option moving forward.

Now that we have this info, I think this gives us a lot to discuss.




