Good morning to you both,

I just wanted to check in with you both about approval or one final month using the studio equipment in the caucus room. Our original agreement was three months, March 8 to June 8, which we extended one month to July 8<sup>th</sup> already. The Premier has a busy July in the works and while that will include travelling for the first time in a long while, I expect he will still make frequent use of the studio if is available, so I wanted to make sure you are ok with one more month extension, to August 8<sup>th</sup>. I am working with our vendor to find a longer term or potentially permanent solution for the fall, but we have a bit of time there as I expect August will be very quiet. The monthly rate for the extra month will be the same, \$15,000. And the crew from our vendor SW will dismantle the space shortly after the 8<sup>th</sup> of August.
