If so, how many? How many coyotes is BCCOS planning to euthanize after four were culled yesterday? How are the animals euthanized after they're captured using soft foot traps?

Provided statement from COS and Sgt. Simon Gravel responded:

"No additional coyotes have been capture in the last 24 hours. Conservation Officers will continue to monitor Stanley Park and respond to coyote reports as necessary. "Conservation Officer Services continues to work with park rangers, area organizations the municipality and wildlife biologists on a long-term strategy to address and reduce coyote conflicts. Please report any aggressive coyote encounters to the RAPP line at 1-877-952-7277."

"BC Parks is providing frontline support to manage wildfire emergencies in protected areas across the province. BC Parks staff are being re-deployed to other BC Parks regions currently affected by wildfires to ensure the continued safety of visitors to parks, and our staff. Where resources allow, BC Parks staff may be deployed to assist in broader provincial wildfire efforts. BC Parks took a similar approach with staff resources in the 2017 and 2018 wildfire seasons."

 - To date, the COS has euthanized six coyotes in the park and other coyotes believed to be responsible for these incidents will be euthanized if located.
- 3. How many coyotes are thought to live in the park overall?
 - The COS estimates XYZ coyotes remain in the park.

 - COS has responded to approximately 30 coyote attacks over the past seven months. This is significantly higher than previous years.

- 2. What the strategy is to deal with them. I understand four were taken out the other day. How many total?
 - To date, the COS has euthanized six coyotes in the park and other coyotes believed to be responsible for these incidents will be euthanized if located.
- 3. How many coyotes are thought to live in the park overall?
 - The COS estimates XYZ coyotes remain in the park.
- 4. Is a full cull a possibility? How would such a decision be made?
 - The COS works with the Vancouver Park Board, area organizations, the municipality and wildlife biologists to consider all options for addressing and reducing coyote conflicts in the park.
 - The role of the COS in this case is to remove coyotes that through food conditioning have lost their fear of humans and that are a threat to public safety.
- 5. How are the animals destroyed?
 - In the event that an animal is a danger to public safety and needs to be euthanized, the COS
 does so using the most humane means possible. In this case, the most humane option is by
 firearm.

General summary bullets of scrum – question of closure didn't come up as expected but some lines below.

- Every party is working together to protect public safety and resolve a complicated situation as quickly as possible that includes COS, Vancouer Parks Board, the Wildlife Branch and others.
- Everyone is engaged and working towards the same goal. A Coyote Task Force was created months ago with all parties to work to address the situation.

Relying on expert advice and putting the resources towards protecting people.

Wildlife pop is FLNRORD domain but we do believe there are multiple coyotes involved in the incidents.

The COS is leading the response to this specific incident and a long term strategy is being led by FLNRORD.

The COS is investigating after a two-year-old girl was attacked by a coyote in Stanley Park last night.

At approx. 9: 30 p.m. on Monday, a group of adults and children were walking from the parking lot near the aquarium when a coyote suddenly jumped on the child. Her father intervened and the coyote left the area. The child suffered injuries and was treated in hospital.

The public is asked to use abundant caution in Stanley Park, as there is a high risk of encountering an aggressive coyote.

The COS only became aware of this incident this afternoon.

Conservation Officers will be patrolling Stanley Park and will continue to have a presence in the park over the next several days to help ensure public safety.

We understand the public is concerned about these incidents. The COS has euthanized two coyotes and is working to locate and euthanize the coyote involved in this attack.

Conservation Officers believe multiple coyotes are involved in incidents in Stanley Park and are continuing efforts with park rangers, area organizations, the municipality and wildlife biologists to address and reduce coyote conflicts.

- We recognize and understand the public is concerned about these incidents.
- We are also concerned about the behaviour of coyotes in Stanley Park.
- No one wants to see anyone injured by a coyote, especially a child, and we are thankful she is recovering.
- The COS is patrolling the park today and will continue to have a presence in the park over the next several days to help ensure public safety.
- We are continuing efforts to coordinate with the Vancouver Park Board, area organizations, the municipality and wildlife biologists to address and mitigate coyote conflicts.
- To date, the COS has euthanized two coyotes and other coyotes believed to be responsible for these incidents will be euthanized if located.
- We are again asking the public to use abundant caution if you are in Stanley Park, as there is a high risk of encountering an aggressive coyote.
- We believe the aggressive behaviour towards people shown by the coyotes may be the result of the animals being fed either directly or indirectly by people. We cannot

- stress enough the importance of not feeding dangerous wildlife, as coyotes that have lost their fear of humans are a public safety risk.
- The public is asked to please report any aggressive coyote behaviour to the RAPP line.

Why did it take a child to be injured for the COS to take action? Wasn't this preventable?

- The COS is continuing ongoing efforts to address and reduce coyote conflicts in the park.
- These efforts include working with the Vancouver Park Board, area organizations, the municipality and wildlife biologists to consider all options for addressing and reducing coyote conflicts in the park.
- We believe multiple coyotes are involved in incidents in the park and their behaviour may have escalated due to being fed by people.
- To date, COs have spent more than 100 hours patrolling Stanley Park.

What has been done to mitigate public safety?

- Conservation Officers have and continue to respond to reports and patrol park areas as part of ongoing efforts to locate and euthanize offending coyote(s).
- In several cases, park areas and surrounding trails were immediately closed.
- There is extensive signage in the park and a public outreach and education campaign around coyotes is continuing.
- The COS continues to warn the public to consider alternative locations to Stanley Park and to use abundant caution if using the park.

Why does the COS think this is happening?

- It is not normal behaviour for coyotes to pursue people.
- Aggressive behaviour towards people is usually the result of the animal becoming comfortable due to being fed, either directly or indirectly by people.
- COs believe there are multiple coyotes involved in the incidents at Stanley Park.

How many coyote attacks have there been?

Since December 2020, there have been 31 reported coyote attacks.
