ISSUE:

Seeking Deputy Minister approval to write-off an ^{s.22} salary overpayment for ^{s.22} 5, GCPE s.22

BACKGROUND:

- In October 2021, GCPE submitted \$.22 package to TELUS Employer Solutions (TES). The package contained correct information and dates.
- Due to TES entry error, s.22 form was not processed in full in January 2022, and not corrected until April 29, 2022. As a result
 - s.22 was overpaid s.22
 2022.
 - Overpayment amount was s.22
- On August 31, 2022, TES notified s.22 of the overpayment. The four-month lag between the overpayment occurring and notifying s.22
 s 22
- On September 1, 2022, s.22 responded and requested further information to better understand the situation.
- On September 13, 2022, TES sent requested information to ^{s.22} did not respond immediately because s.2 was trying to figure it out with PSA. However, PSA did not respond.
- On Oct 26, 2022, TES notified s.22 that they were forwarding information to TES Payroll Accounting.
- On November 16, 2022, TES Accounting sent overpayment letter to \$.22 with December 7 deadline to repay all of the \$.22
- On November 21, 2022, s.22 called the Contact Center stating s.22

- On November 21, 2022, Megan Harris, GCPE ADM, and Chelsea Blyth, GCPE HR Manager, started to escalate this situation as \$.22
 - s.22 However, TES did not respond. PSA Payroll replied to Chelsea that all paperwork at their end was filed correctly, so the issue had to be dealt with TES.
- On November 30, 2022, Megan escalated this issue to PSA directly, but she did not receive a response.
- On December 2, 2022, Megan emailed Deb Godfrey.
- On December 2, 2022,s.22 from TES Payroll connected with Chelsea. The overpayment recovery was paused.
- PSA scheduled a follow-up meeting with s.22 in early January 2023.

DISCUSSION:

Situation

- The cause of the overpayment was TES human error.
- s.22
- TES client service did not provide prompt and appropriate support to s.22.
- TES set up overpayment recovery in November without s.22 approval.
- PSA Payroll was unresponsive to GCPE SHR's request to discuss.

Financial Policy for Write-off

 Section 7.2.22 of Core Policy & Procedures Manual (CPPM) requires that "ministries must immediately inform employees of any salary or other overpayments and attempt to establish a mutually agreeable schedule for full repayment. The repayment schedule must be signed off by the ministry and the employee..."

This policy was not properly followed in this situation.

- Section 7.2.26 of CPPM outlines the write-offs of uncollectible debts or obligations:
 - Only those debts or obligations for which all appropriate collection action has been taken can be considered for write-off.
 - Write-off submissions must include all relevant information (any information the ministry possesses relevant to the debt or obligation and its collectability).
 - Debts where, in the view of the creditor ministry, further expenses to collect are not
 justified in relation to the amount of the debt and the possibility of collection.
 - Debts where liability has not been admitted by the debtor and where the success of proceedings to collect is unlikely.
 - Debts where the existence of an enforceable debt due to the Crown cannot be readily established (that is, where records have been lost or destroyed and the ministry is unable to prove receipt of services by the debtor).
 - All write-off submissions must include details of the collection action taken, the budget impact, the debtor's financial status if relevant, and why further collection action is not possible or practical.
 - The chief financial officer of a ministry is responsible for authorizing the write-off of ministry debt or obligations of \$5,000 or less.

- Officers must maintain adequate records of any amounts that they have written-off.
- When authority has been received to write-off a debt or obligation, the debt or obligation must be transferred from the ministry accounts to a reference file of "debts written off", where it must remain until paid, extinguished, or remitted (pursuant to section 18 or 19 of the Financial Administration Act or by another enactment).
- Annually, ministries must submit statements of debts written-off during the fiscal year, together with supporting authorizations, to Financial Reporting and Advisory Services, OCG, for Public Accounts reporting purposes.

Given that multiple government offices/staff and the payroll contractor are involved in this situation, further time and effort in collecting the amount of the debt may not be justified.

CFO RECOMMENDATION:

Ministry of Finance, CFO, Amy McAleese's understanding is that the DM for GCPE has previously approved write-off of the overpayment without being provided the applicable financial policy context. This briefing note is intended to document all of the considerations for the DM in accordance with policy and confirm the DM's desired approach to this situation with this additional context.

In review of the materials provided to her regarding this payroll overpayment, she notes and acknowledges that this situation and approach from TES and PSA $^{\rm s.22}$

and there appears to have been a breakdown in process creating this situation.

Overpayments to employees do occur and are often a result of human error, each situation needs to be assessed on its own merit for approach to collection or write-off. However, government has a responsibility to ensure appropriate application of financial policies and procedures are followed in alignment with the best use of taxpayer funds.

As noted above in the excerpts from the Core Policy and Procedures Manual, based upon the Financial Administration Act, there is a requirement to document not only the human impacts of an overpayment situation, but the financial considerations related to the situation.

In assessing the application of policy to the information she has been provided, she notes the following considerations:

(1) While the original re-payment schedule \$.22 s.22

(5) The financial impact to the ministry to write this amount off would be minimal and within budget based on the Q3 forecast submitted.

Based on the above considerations, Amy McAleese believes the financial considerations to support write-off of the debt owed to government has not been met from the financial perspective; and she does not recommend write off.

OPTIONS:

Option 1: Approve the write-off of s.22 salary overpayment.

Option 2: Do not approve the write-off of s.22 salary overpayment.

Relevant Policy

Ministries must immediately inform employees of any salary or other overpayments and attempt to establish a mutually agreeable schedule for full repayment. The repayment schedule must be signed off by the ministry and the employee, and placed on the employee's payroll file. The amount owing must be recorded as a receivable until the overpayment has been recovered. Ministries must consult with Strategic Human Resources in any situation where the collection action being considered is beyond the scope of this policy.

7.2.26 Write-offs of Uncollectible Debts or Obligations

- 1. Only those debts or obligations for which all appropriate collection action has been taken can be considered for write-off.
- 2. Write-off submissions must include all relevant information (any information the ministry possesses relevant to the debt or obligation and its collectibility).
- 3. debts where, in the view of the creditor ministry, further expenses to collect are not justified in relation to the amount of the debt and the possibility of collection;
- 4. debts where liability has not been admitted by the debtor and where the success of proceedings to collect is unlikely;
- 5. debts where the existence of an enforceable debt due to the Crown cannot

- be readily established (that is, where records have been lost or destroyed and the ministry is unable to prove receipt of services by the debtor); and

Ministries must consult with Strategic Human Resources in any situation where the collection action being considered is beyond the scope of this policy.

7.2.26 Write-offs of Uncollectible Debts or Obligations

- 1. Only those debts or obligations for which all appropriate collection action has been taken can be considered for write-off.
- 2. Write-off submissions must include all relevant information (any information the ministry possesses relevant to the debt or obligation and its collectibility).
- 3. debts where, in the view of the creditor ministry, further expenses to collect are not justified in relation to the amount of the debt and the possibility of collection;
- 4. debts where liability has not been admitted by the debtor and where the success of proceedings to collect is unlikely;
- 5. debts where the existence of an enforceable debt due to the Crown cannot be readily established (that is, where records have been lost or destroyed and the ministry is unable to prove receipt of services by the debtor); and
- 6. All write-off submissions must include details of the collection action taken, the budget impact, the debtor's financial status if relevant, and why further collection action is not possible or practical.
- 7. The chief financial officer of a ministry is responsible for authorizing the write-off of ministry debt or obligations of \$5,000 or less.
- 8. Officers must maintain adequate records of any amounts that they have written-off
- 9. When authority has been received to write-off a debt or obligation, the debt or obligation must be transferred from the ministry accounts to a reference file of "debts written off", where it must remain until paid, extinguished, or remitted (pursuant to section 18 or 19 of the *Financial Administration Act* or by another enactment).
- 10. Annually, ministries must submit statements of debts written-off during the fiscal year, together with supporting authorizations, to Financial Reporting and Advisory Services, OCG, for Public Accounts reporting purposes.
