Background:

On April 5, 2016, Justice Hinkson denied the Province's request for a temporary injunction to remove campers from the courthouse site. The judge found that "Although the plaintiffs have established that there is a fair question to be tried in this case, they have not demonstrated that they will suffer irreparable harm if an injunction is not granted. Further, I find that the balance of convenience weighs overwhelmingly in favour of the defendants."

The court has set a trial date of Sept. 7 for a permanent injunction hearing. If granted, it would enable the Province to permanently return the Victoria courthouse to a greenspace for public use.

Following the court decision, the Province announced on April 14 that it is working with the City of Victoria and fire and police officials to develop a plan for safety standards to better protect people at the site and nearby residents.

An inspector from the Office of the Fire Commissioner visited the site on Feb. 27, which resulted in an order being issued for campers to deal with the fire hazards that were identified. There has been little progress to date in complying with the order.

The Province is working with the Portland Hotel Society (PHS) to help in the management and safety of the site and to connect site occupants with housing, health and other services. PHS currently has 2-3 staff on site, 7 days per week from 10:00 a.m. - 8:00 p.m. Staff regularly check in throughout the day and help individuals with the necessary supplies and taking them to appointments.

On April 25, Minister Coleman indicated that the Province will re-assess the situation at the end of April and, if safety risks continue at the site, may consider applying again for an injunction.

The Province and BC Housing have provided a number of new housing and shelter units to accommodate those camping at the courthouse site, including My Place, Choices and Mt. Edwards.

Including all of the housing options the Province has brought to the table, B.C. has housed **191** campers, including homeless at the First Metropolitan Church who may have not been in the camp:

Housing units targeted specifically to tent city:

- 38 at Mt. Edward
- 50 at Choices
- 40 at My Place (former Boys and Girls Club)

In addition:

- 45 at First Met (overnight shelter)
- 18 campers have transitioned into permanent housing (13 through a rent supplement)

Total - 191

On May 3, the Province announced it was providing \$510,000 to keep My Place open for an additional five months, until Sept. 30. The B.C. government is also providing \$130,000 to allow the overnight shelter at the First Metropolitan Church to remain open until the end of June.

BC Housing has also entered into a purchase agreement to buy the 51-unit Super 8 hotel located at 2915 Douglas Street to provide additional housing options for those in need in Victoria The deal closes on Sept. 30 and will be ready for tenancy in November.

Neighbours of the protest camp on the Victoria courthouse lawn are increasingly concerned for their personal safety in the wake of several violent incidents and other safety concerns.

A representative of the Mad as Hell group addressed City Council on April 14, sharing neighbours' stories of crime and violence in the area. A reporter also tweeted that he had be threatened.

Tourism representatives have also expressed concerns about the impact that the tent city is having on tourists and the tourism industry. The Chamber of Commerce has also expressed concerns about economic impacts; however, individual businesses are reportedly afraid to speak out for fear of reprisals.

On April 5, 2016, Justice Hinkson denied the Province's request for a temporary injunction to remove campers from the courthouse site.

The judge found "that the plaintiffs have not met the criteria for an interim injunction... Although the plaintiffs have established that there is a fair question to be tried in this case, they have not demonstrated that they will suffer irreparable harm if an injunction is not granted. Further, I find that the balance of convenience weighs overwhelmingly in favour of the defendants."

The court has set a trial date of Sept. 7 for a permanent injunction hearing. If granted, it would enable the Province to permanently return the Victoria courthouse to a greenspace for public use.

Following a court decision to allow campers to stay at the Victoria courthouse site through the summer, the Province announced on April 14 that it is working with the City of Victoria and fire and police officials to develop a plan for safety standards to better protect people at the site and nearby residents.

An inspector from the Office of the Fire Commissioner visited the site on Feb. 27, which resulted in an order being issued for campers to deal with the fire hazards that were identified. There has been little progress to date in complying with the order.

The Province is working with the Portland Hotel Society to help in the management and safety of the site and to work with campers to connect them with housing, health and other services. The Portland Hotel Society will provide these services on site and soon will be there on a 24/7 basis.

PHS currently has four staff on site every day, starting to identify site occupants' needs around health and housing. PHS intends to pay occupants a small fee to assist with site clean-up and safety.

On April 25, Minister Coleman indicated that the Province will re-assess the situation at the end of April and that, if safety risks continue at the site, government may consider applying again for an injunction.

The Province and BC Housing have provided a number of new housing and shelter units to accommodate those camping at the courthouse site, including My Space (the former Boys and Girls Club), Choices (View Royal) and Mt. Edwards.

As of April 15, 50 people are now residing at Choices and 38 have moved into Mt. Edwards. A number of people from Mt. Edwards and My Place have moved into more permanent housing.

Neighbours of the protest camp on the Victoria courthouse lawn are increasingly concerned for their personal safety in the wake of several violent incidents and other safety concerns.

A representative of the Mad as Hell group addressed City Council on April 14, sharing neighbours' stories of crime and violence in the area. A reporter also tweeted that he had be threatened.

Tourism representatives have also expressed concerns about the impact that the tent city is having on tourists and the tourism industry. The Chamber of Commerce has also expressed concerns about economic impacts; however, individual businesses are reportedly afraid to speak out for fear of reprisals.

Here is a high level update of OHCS's key work this week. In addition, please find attached two Out-of-Province travel requests for your review and approval.

• Courthouse Tent City

- o Injunction hearing wrapped up on Tuesday, March 15^{th,} 2016. The judge asked for a two week leave to deliver his ruling, although it could come at any time.
- BC Housing is looking to extend the seasonal shelter spaces in Victoria to ensure there are shelter spaces available well into the Spring. Should have confirmation next week.
- Mt. Edwards transitional housing is full with 38 residents.
- Choices Shelter and transitional housing in View Royal has 40 residents; 14 inside and 26 camping outdoors. Expected to be full by next week (capacity set at 50, may push to 60).

Maple Ridge

- o BC Housing has extended funding for the winter shelter in Maple Ridge for three more months to accommodate the increased need for shelter in the community.
- BC Housing also has purchased the Quality Inn Hotel in Maple Ridge for 5.5M to create 61 units of supportive housing, in partnership with Fraser Health.
- A community information session will be held in Maple Ridge on March 29th to answer questions about the Quality Inn project.
- An Op-ed from MRC on the Province's response to homelessness in Maple Ridge was sent to the local newspaper on March 17, 2016.

Support Recovery Housing

- The Housing Policy Branch has been working with the Ministry of Health, SDSI, and PSSG to develop a
 proposal to transition supportive recovery housing into a provincial program, administered by BC
 Housing, with operational funding contributions from the Ministry of Health and SDSI.
- MRC briefed on March 15th; an information Note will now be shared with the ADM, Health Services and Quality Assurance so he can brief the Minister of Health to determine interest in moving forward.
- Next steps will include bringing together the Ministers of Housing, Health and SDSI to reach consensus on funding

Non-Compliant Elevators

- OHCS is looking to address any potential impact on tenants who may need more housing assistance if their elevator is shut down and they have to move because they can't navigate stairs.
- We are working with BCH to determine whether a housing outreach worker could be a potential solution. The outreach worker would be proactive in getting into the building to offer assistance to tenants.
- Weekly calls have been set up with BCSA to coordinate what building will be effected by elevator shut downs and when.

Home Inspectors

- On March 15, new requirements for home inspectors were announced.
- o This fulfills our commitment to provide policy recommendations to PSSG.
- Phase 2 amendments are underway, which will result in a single occupational standard and a common competency profile.
