Update as of 6:45 pm April 11

Vancouver Fire has confirmed that the Winters' Hotel fourth floor has collapsed into third floor. COV Building Department has completed an assessment and considers the parapet unstable at this time; they have also confirmed that that the exterior bricks are in a compromised state but are not currently considered to be unstable.

Vancouver Fire has also confirmed that residents from all but two evacuated buildings will be able to return to their homes tonight, with readmittance beginning for some as early as 6pm.

Buildings with tenants who will not be able to return until further notice include the Winters Hotel (203 Abbot – 86 units) and the Gastown Hotel (112 Water Street – 90 units). Current approximate count of total affected units is 176.

There are currently five reported injuries, exact conditions of which are unknown. There are no reported casualties yet, and there are 10 people who are currently unaccounted for.

A total of 13 area businesses have been confirmed to be behind the fire line and will likely not be able to operate for a few days. Emergency response is coordinating notification for those affected and with COVs Building Department to establish a fenced safety perimeter once an appropriate distance has been identified.

All shelter sites except the Walton and the Evelyn Saller Centre are expected to be activated prior to 6:30 pm April 11 and COV cots have been delivered to all that requested this assistance. Food is being provided and emergency response is working to confirm overdose prevention and reduction supplies on site.

The Evelyn Saller centre is not able to accept new guests <u>until 11pm</u>, however until that time any arrivals' names will be put on a list for an easier intake later in the evening. The Walton will be available <u>beginning 3pm April 12.</u>

Vancouver Coastal Health has deployed a nurse on site at Bette's Boutique to provide health support. This muster point is expected to remain open as triage point for evacuees <u>until midnight April 11</u>, however staff will adjust and remain open if necessary to meet need. BC Housing staff are also currently checking with Atira to see if Bette's Boutique can remain open all night to provide any late arrival evacuees with a warm space and coffee

There is a strong likelihood that main muster point will shift to Japanese Hall starting April 12, and VCH will deploy a nurse to that site.

BC Housing has sent staff to Bette's Boutique to assist with response and tenant relocation. BCH is also working to coordinate VCH review of tenant list to confirm continuity for medication and urgent appointments on an as-needed basis.

Emergency Support Services have connected with psychosocial assistance and have confirmed they are ready to deploy if required.

Limited clothing options are being sent to Bette's Boutique for those who have lost items in the fire. There is availability to coordinate more significant clothing if required.

PHS has also flagged a need for social grants to displaced tenants to address ongoing needs.

Update as of 4:50 pm April 11, 2022

Latest count is that approximately **86 tenants** at the Winters Hotel have been affected by the April 11 fire.

Several properties adjacent to the Winters Hotel have been evacuated and there is a possibility that residents from some or all of these buildings will not be able to return today due either to smoke damage or ongoing fire response activity. Current estimate is that 200 – 300 people may be unable to return today, though no exact count has been confirmed.

Properties which have already been evacuated and have been identified as having strong potential for tenants not being able to return today include:

- **Gastown Hotel 112 Water Street (90 units)
- **Dominion Hotel 210 Abbot Street (approximately 49 units)
- **Colonial Hotel 122 Water Street (approximately 71 units)
- Abbot Place private rental 233 Abbot (46 units)
 - Total = ~256 units
 - **Properties for which BC Housing provides funding

BC Housing, City of Vancouver and Emergency Response Services have identified 157 spaces which can be activated today if for evacuees if needed. Winters Hotel residents will be prioritized for spaces where there is 24 hour operations. Spaces include:

- Japanese Hall (approx. 50 spaces, 24 HR operations)
- Evelyn Saller (42 spaces, 11PM-7AM operations)
- Woodwards (20 spaces, 24 HR operations)
- Walton EWR (15 spaces, 3PM-7AM operations)
- Hornby Shelter (15 spaces, 24 HR operations)
- Metson Shelter (4 spaces, 24 HR operations)
- First Ave Shelter (4 spaces, 24 HR operations)
- Yukon Shelter (5 spaces, 24 HR operations)
- Al Mitchell (2 spaces, 24 HR operations)
- UNCONFIRMED The Metson (15 spaces, may not be available until April 12)

As some of the above sites do not have cots available, City of Vancouver has confirmed they can provide cots and blankets to accommodate. Emergency support services can provide transportation as needed, either via bus or taxi, and is also coordinating food for evacuees.

Emergency Response has confirmed that the Winters Hotel will need to be assessed prior to adjacent buildings being occupied again and have advised that this process will likely take some time.

Vancouver Coastal Health is sending clinical outreach workers to assist on site and coordinate with community clinics to fill prescriptions for those with ongoing medical needs who have lost existing prescriptions in the fire.

City of Vancouver is also working on a flyer for distribution to evacuees and has requested BC Housing communications review their draft once available.

Emergency response is also exploring the possibility of providing counselling services for evacuees, however these talks are very early and are not confirmed.

There is currently no information regarding confirmed injuries or casualties.

I'm working on a story based on the fire investigation report for the Winters Hotel fire.

The family of the deceased still have questions about why the operator did not realize Dennis Guay and Mary Garlow were missing until several days after the fire. Has BC Housing completed its review into this? Is there any insight you can share about how this happened and how it might be prevented in the future?

My deadline is end of day Thursday, if possible.

Draft response from BCH:

We would like to express our sincere condolences to the families and friends who tragically lost loved ones during the fire at the Winters Hotel.

It had been reported that the Winters Hotel was safely evacuated of all occupants during the April 11 fire. However, Atira filed a formal missing persons report for one of the tenants on April 12th and followed up again on April 15th and both times was advised by emergency services that the tenant had been accounted for. Atira also raised concerns about the second tenant at a number of community round tables and was informed the tenant had been accounted for. We continue to be disheartened to learn that these accounts were inaccurate.

A taskforce group that includes representatives from the City of Vancouver, emergency services agencies, non-profit housing operators and BC Housing will secure an external third-party contractor to lead a full review of the response to the fire at the Winters Hotel. The contractor will ensure fairness and objectivity.

The full scope of the review is still being determined, but we know this review should make recommendations to ensure clear roles and responsibilities of all parties to inform an improved response in future to major disasters. The review will also determine if each of the parties need to make any updates to existing policies and procedures.

Once the terms of reference for the review have been finalized, then the taskforce will select a contractor to undertake this work. We expect the review will begin in the Fall and will be complete by Spring 2023.

Key Messages:

- Two people are believed to have died when a fire ravaged the Winters Hotel in Vancouver on April 11, 2022.
- We are deeply saddened by this tragic loss of life and our thoughts are with Mary-Ann Garlow's and Dennis Guay's loved ones and the other former residents of the hotel.
- Everyone has a right to feel safe in their home and s.1 government is committed to making sure fewer families lose loved ones to fires.
- I am directing a coroner's inquest into the deaths of Mary-Ann Garlow and Dennis Guay.
- s.13 Recommendations from the inquest into the Winters Hotel deaths
 s.1 could help prevent fires in single-resident occupancy buildings and save lives.
- As the number of fire-related deaths increases in British Columbia, it is imperative that we take action to ensure vulnerable people are protected from fire hazards.

QA:

- 1. What happened at the Winters Hotel?
 - On April 11, 2022, a fire ravaged the Winters Hotel, a single-resident occupancy building-(SRO) hotel in Vancouver's Gastown.
 - It is believed that two residents' deaths were caused by the blaze, and five people were injured.
 - The fire damage was severe and the building was demolished, s.13
- 2. Why is the minister directing an inquest intos.1 these deaths? Why now?
 - Everyone deserves to feel safe in their homes and our government is taking action now to save lives.
 - An inquest jury will hear evidence from witnesses under oath and make findings regarding the facts of the Winters Hotel deaths. The jury can also

make recommendations aimed at preventing deaths under similar circumstances.

- Potentially life-saving recommendations could prevent further tragic losses and ensure more people are protected from fires in their homes.
- With fire-related deaths increasing in B.C., it is s.13 imperative that effective fire mitigation measures are in place for everyone.

If needed:

- Over the last two reporting years, there has been a 119% increase in fire-related deaths around B.C., according to the Office of the Fire Commissioner's annual report.
- o In 2021, there were 59 fire-related deaths and 180 fire injuries.
- Only 42% of reported residential structure fires had a working smoke alarm.

3. When will the inquest take place?

- The deaths of Mary-Ann Garlow and Dennis Guay are currently being investigated by the Coroner.

Hey Tasha, Atira (Janice Abbott) did do an interview with Global last night. She also did interviews with CKNW and CBC this morning.

She told me this morning that this is a jurisdictional issue – The City of Vancouver building code stipulates a one-stage system in SROs. They had asked to change to a two-stage system for a different SRO (Gastown). In a one stage system, every alarm goes to a monitoring company immediately. According to Atira, even if they call the monitoring company immediately and advise them it is a false alarm, they are required to have Vancouver Fire attend.

In a two-stage alarm, functions basically like this:

- 1. Trouble signal these are for people smoking in a unit, tampering with a detector, wiring fault, etc. These trigger a local alarm only, which must be acknowledged within a certain timeframe (usually around 60 seconds). If it is not acknowledged at the panel, then the system calls the monitoring company.
- 2. Alarm Signal heat, sprinkler flow, or heavy smoke detection these trigger an immediate call to the monitoring company and Vancouver Fire.

BSSB – owner not manager is responsible for code compliance. Potential follow-up. Violations should go to manager if delivered to operators.

Who is violation/order being written against? Will be given to whomever is onsite as representative. Staff give to manager. A chief's order is more formal, that would be delivered by registered mail, posted.

Bylaws and fire code enforcement to consider.

Data being collected. FDM – fit out inspection reports also click sense data and analytics can pull greater level of data and fire code. Reporting data is robust. Fire crews raise alert that going to same addresses for false fire alarms smoking in hallways, had that data and are now trying to target.

Doing public education campaign, fire and life safety in SROs with residents, working on smoking cessation with VCH.

False alarm data also correlates to number of fires.

Fire safety grant education: Originally targeting private but will include some public ones without sprinklers, idea is to train residents in fire safety. Our involvement is limited. Will train the trainer. Are offering training for all the staff and with BC Housing. Daily checks for operator – exits clear, debris. Risk with battery bikes etc. Developed course after winters fire. No uptake but now full

SRO & SOCIAL HOUSING FIRES

SUGGESTED RESPONSE:

- The safety of residents living in SROs and social housing is a top priority. BC Housing and its service providers work hard to keep people safe.
- We know fires are traumatizing and extremely disruptive for residents, staff and the surrounding community.
- The Province is working with the Office of the Fire Commissioner and Vancouver Fire Rescue Services to address fire safety in SROs^{s.13}
- BC Housing works closely with fire and rescue and other service providers to ensure that policies and procedures are up to date for the safety and well-being of residents and staff.
- It is vital that buildings are safe. BC Housing works to ensure that non-profit housing providers are aware of the need to keep on top of repairs, especially those related to health and safety, and supports them to address concerns as soon as possible.
- In situations where sprinkler systems or other safety mechanisms cannot be repaired
 or reactivated immediately, BC Housing works with its non-profit providers to ensure
 that necessary secondary safety measures are established, such as a fire watch, until
 work can be completed.
- In the event of a fire, BC Housing and service providers work quickly to find alternate housing arrangements and to ensure that people receive adequate supports.
- People forced from their homes by fire, floods, earthquakes or other emergencies may receive Emergency Support Services for immediate needs when alternative supports, including insurance, are not available.
- Services may include meals, shelter, clothing, pet care, emotional support, and family reunification.

If asked about the future use of SROs:

- Our intention is to create opportunities for those living in SRO spaces to live in selfcontained units and, long term, to convert existing SRO stock into more appropriate self-contained units.
- The Minister of Housing is leading work to support a healthier and safer Downtown Eastside, which includes a range of housing and SROs.
- Following a request from former Minister responsible for Housing, David Eby, in August 2022, BC Housing launched a Request for Proposals for an independent firm to review the SRO Renewal Initiative P3 Project, announced in March 2012.
- Concerns have been raised about the use of private sector partnerships in providing SRO housing for vulnerable people, and in keeping these P3 buildings maintained under the terms of the agreements entered into at the time.
- The RFP process is complete, and a contractor has been selected. The review is expected to take several months. Key deliverables include:
 - Performance of the SRO Renewal Initiative P3 Project
 - Comparative analysis on the construction, post construction and all of the operations of a P3 vs a traditional model
 - To determine compliance of Project Co. with the requirements of the Project Agreement during the established review period.
- In 2021, the City of Vancouver reached out to the Province and CMHC to form an intergovernmental working group to develop a coordinated investment strategy to replace or redevelop SROs.
- This work is ongoing, while we continuously work to improve the habitability of SROs and bring people indoors using every opportunity available.
- The Ministry of Housing, BC Housing, the Federal Government and the City of Vancouver have formed a working group to assess the SRO stock, define renovation and redevelopment options, and determine resource allocation. This work will help to inform decision making and ultimately feed into work being led by the Ministry of Housing to support the Downtown Eastside.

ISSUES NOTE: Ministry of Housing 2023-02-07

- Since 2018, more than 36,000 new homes are open or underway across the province for renters, homeowners and people at risk of or experiencing homelessness, including more than 8,000 in Vancouver.
- We know there is more to do, which is why we have approximately 700 new supportive homes underway in Vancouver.

BACKGROUND:

On Jan. 31, 2023, Vancouver City Council approved an initiative to improve fire safety in SROs. Council will grant \$110,000 to the SRO Collaborative Society to run a one-year fire safety pilot project.

There has been media coverage of a higher-than-normal number of fires that have occurred in various SROs and other social housing buildings over the past number of years, resulting in two deaths at the Winters Hotel and the displacement of hundreds of residents in 2022.

The fires that have affected various SROs and other social housing projects across the city have been devastating to residents, local communities, and Vancouver as a whole. In each event, BC Housing has worked with the City of Vancouver, emergency services and housing providers to ensure residents' safety and provide continuity of indoor shelter.

Many of the SRO buildings in BC Housing's portfolio are over 100 years old and require frequent and repeated maintenance. Despite investments in capital repairs and renovations in government-owned SROs, most SROs have significant challenges due to aging facilities and inadequate design. Conditions are often inhospitable, particularly in privately-owned buildings.

Major renovations are disruptive and costly, including due to possible heritage, seismic, brownfield, zoning, room loss, and resident relocation considerations resulting in many SROs continue to deteriorate.

A recent City of Vancouver bylaw change requires all SRO fire escapes to be assessed. This will result in considerable costs. For example, a recent assessment of one building resulted in upgrade costs of approximately \$500,000.

Safety concerns in government-funded SROs are addressed as soon as possible. In situations where sprinkler systems or other safety mechanisms cannot be repaired or reactivated immediately, BC Housing works with its non-profit providers to ensure that necessary secondary safety measures are established, such as a fire watch, until work can be completed.

BCH has recently launched a Fire Reduction Working Group among senior leadership and staff, which currently meets monthly while a smaller, core group convenes bi-weekly. This group is still in information gathering and research stage but will be working towards better understanding of fire events involving SROs and other BC Housing projects, including:

- Preventative measures
- Researching fire causes, including moderns sources such as e-transport charging stations

- Response processes for staff and external partners
- Innovations in fire suppression

According to the City of Vancouver, as of October 2022, fires have displaced approximately 343 residents, who were temporarily relocated to shelter space and then either returned to their homes or relocated to permanent housing as appropriate. Of the impacted residents, a total of 155 were able to return to their original homes, and approximately 188 required long-term relocation in alternative units.

People forced from their homes by fire, floods, earthquakes or other emergencies may receive Emergency Support Services for immediate needs when alternative supports, including insurance, are not available. s. 13 s. 13

The most recent information shows a total of six significant fires affecting BC Housing-funded SRO buildings in Vancouver in 2022, including:

- April 11, 2022: Winters Hotel fire, which took the lives of two people and caused long-term relocation of 144 residents of the Winters and neighbouring Gastown Hotel.
- May 15, 2022: St. Helen's fire, which temporarily displaced 29 residents.
- **July 6, 2022:** Hotel Maple fire, which temporarily displaced 80 residents.
- Aug. 22, 2022: Princess Rooms fire, which caused long-term relocation of 36 residents.
- **Sept. 24, 2022:** Sereena's Place fire, which temporarily displaced 46 residents and led to longer-term relocation of eight individuals.
- **Sept. 28, 2022:** Hazelwood Hotel fire, nearly all residents from which were able to immediately return after evacuation.

SRO buildings in Vancouver may be publicly, non-profit, Chinese Benevolent Association or privately owned, and the information above only covers those which are part of BC Housing's portfolio of housing projects.
