When that funding ran out, the City asked BCH to help fund it so that we could keep it open until permanent, purpose-built supportive housing is constructed.<sup>s.13</sup> s.13

There are 100 units of permanent, purpose-built supportive housing underway in Cowichan Valley, with <u>Sq'umul' Shelh Lelum'</u> having completed in April 2022, and <u>another site</u> currently under construction in Duncan with occupancy expected later this summer.

# Larwill – VAGA Dev. Application

#### **ISSUE SUMMARY:**

The Vancouver Art Gallery Association (VAGA) has tentatively secured a \$100M private donation from the Audain Foundation toward its plans to redevelop City of Vancouverowned land at 688 Cambie Street, which is currently home to Larwill Place, a 98-unit supportive housing project, for the construction of a new art gallery. BC Housing's land lease expires on Sept. 30, 2023.

Although this donation does not bring VAGA past the threshold point at which they could submit a development application, it does bring them significantly closer to that goal. As the two modular supportive housing Larwill Place buildings are located on the northern third of this site, any news involving a potential development application will likely trigger questions about the current residents' housing. VAGA has expressed an intent to publicly announce and sign the donation on Nov. 4, 2021.

#### **KEY MESSAGES:**

- We understand people living at Larwill Place may have questions.
- No one living at Larwill Place will need to move right now.
- We have a firm commitment from the City for our lease agreement. This donation does not change anything for residents, supports or staff.
- MPA Society and VCH will be engaging with residents to ensure they are aware that there will be no change to their housing and services at this time.
- The homes at Larwill Place were always intended to be temporary housing, providing access to stable housing for almost 100 people while other housing is brought online in Vancouver.
- BC Housing, MPA Society and Vancouver Coastal Health (VCH) have always been prepared to vacate the site by the end of the lease on September 30, 2023.
- Before the temporary supportive housing is moved from that site, we will ensure that all
  residents are connected to alternative housing that matches their needs.
- At that point, BC Housing would provide relocation offers to long-term housing that is similar in size, type and affordability. All residents will also be offered support in the moving process.

#### **BACKGROUND FOR MINISTRY:**

 In 2005, VAGA selected 688 Cambie Street as a potential site for the new Vancouver Art Gallery.

In 2011, Council unanimously approved reserving approximately two acres of the City-

- owned site at 688 Cambie for cultural use including a new Vancouver Art Gallery and directed staff to report back on the need for a new gallery and the business case.
- In 2013, Council again approved approximately 1.8 acres at 688 Cambie for the new gallery.
- Most recently in 2019, Council re-committed to this site.
- VAGA has submitted all required documents with the exception of architectural drawings for their development permit application. City staff will begin processing their application once it is complete.
- As recently as June 2021, VAGA expressed an interest in obtaining final permits prior to February 2022. The City has confirmed to BC Housing that this timeline is unrealistic.
- VAGA has secured a \$100-million donation from a private donor. This donation is a significant step toward the figure needed to move forward with the construction of a new art gallery on the southern two-thirds of the lot.
- However, the City has confirmed that this donation does not push VAGA past the threshold percentage necessary prior to the submission of any development application.
- VAGA has not confirmed their latest timeline for when they are aiming to submit their development permit application.
- VAGA has scheduled to announce and finalize the donation on November 4 with a 9:30 am press conference at the Vancouver Art Gallery, as well as a pitch to the media.

- BC Housing currently holds a lease on the site for two temporary modular supportive housing buildings with 98 units, called Larwill Place. The development permit for Larwill Place was approved on an interim basis pending redevelopment and expires on September 30, 2023.
  - 20 of these units are Vancouver Coastal Health rooms, and as such will require coordination with their staff to ensure resident notification and continuity of housing.
- BC Housing has a firm commitment on the current lease for the site, so it cannot be shortened from its current September 30, 2023, end date even if additional funding is secured by VAGA.
- However, all residents at Larwill will need to be relocated approximately five months
  prior to the September 30, 2023, end date so that the modular units can be
  disassembled, leaving the site empty for new construction.

Four months prior to the start of disassembly, BC Housing will need to begin the process
of tenant relocation to other suitable housing. BC Housing remains committed to
providing operational funding to MPA Society to the end of their operational term on site.

### **Residents and Operator Implications**

- The operator for Larwill Place, MPA Society, needs to be prepared for questions from residents and their site staff to mitigate anxieties amongst those directly affected. They will be sharing information with site staff and residents only at the time of the public announcement scheduled for November 4.
- VAGA's announcement on November 4 has the potential to create stress and uncertainty for the residents and staff of these two buildings. It is important that residents and staff hear consistent, clear information directly from MPA and not from media or other sources.
- In the future, BC Housing, MPA, VCH and the City of Vancouver will be working with residents to develop relocation plans and with individual residents on long-term housing solutions to meet the lease end of September 30, 2023.
- BC Housing is also working with MPA to ensure that the operations agreement is in place until the end of the lease, regardless of being on site at Larwill Place, or if relocations have begun to occur.
- The eventual relocation plan will require BC Housing and the operator to hold one-onone conversations with each resident to learn their needs and preferences. Relocation
  offers will be made to long-term housing that is similar in size, type and affordability, and
  support in the moving process will be offered to all residents.
- BC Housing is working with MPA Society and VCH to ensure timely and accurate communication to Larwill residents is provided on the update to the Larwill Place site, including what that means for them:
  - Delivery of notification letters with FAQ materials at the same time as VAGA's funding announcement, on November 4, 2021.
  - Regular updates for residents to provide info and answer questions.
    - BC Housing and MPA have also provided staff contacts for residents to talk with if they have any questions, including in-person at Orange Hall.

- As required under 2019 legislation, nearly all B.C. local governments have completed their first Housing Needs Reports, and many are preparing for their next report.
   In rural and northern communities, many housing needs reports describe needs for workforce housing, accessible housing options for seniors, and family-sized housing.
- Housing affordability, inadequate housing and rental stock are among the leading causes driving workforce out-migration from rural communities
- Small and medium-sized businesses in rural communities are therefore unable to meet growth targets, compete with larger firms, and match customer demands
- Difficulty finding partners with the right skills, knowledge, and financial resources;
- Limited ability to acquire suitable land;
- Limited experience of local builders to deliver multi-unit housing projects;
- Infrastructure constraints and related costs of upgrading infrastructure;

- Lack of technical expertise in navigating BC Housing (including HousingHub) and CMHC funding programs; and
- Limited investment and limited economies of scale.

  - Grants are being disturbed using a funding formula that includes a base amount of \$500,000, adjusted population, and per capita population growth between 2016 2021. The adjusted population method takes into account the per capita impacts of service demands on smaller and rural communities and the additional pressures experienced by faster-growing communities.

# Larwill – VAGA Dev. Application

#### **ISSUE SUMMARY:**

The Vancouver Art Gallery Association (VAGA) has tentatively secured a \$100M private donation from the Audain Foundation toward its plans to redevelop City of Vancouverowned land at 688 Cambie Street, which is currently home to Larwill Place, a 98-unit supportive housing project, for the construction of a new art gallery. BC Housing's land lease expires on Sept. 30, 2023.

Although this donation does not bring VAGA past the threshold point at which they could submit a development application, it does bring them significantly closer to that goal. As the two modular supportive housing Larwill Place buildings are located on the northern third of this site, any news involving a potential development application will likely trigger questions about the current residents' housing. VAGA has expressed an intent to publicly announce and sign the donation on Nov. 4, 2021.

#### **KEY MESSAGES:**

- We understand people living at Larwill Place may have questions.
- No one living at Larwill Place will need to move right now.
- We have a firm commitment from the City for our lease agreement. This donation does not change anything for residents, supports or staff.
- MPA Society and VCH will be engaging with residents to ensure they are aware that there will be no change to their housing and services at this time.
- The homes at Larwill Place were always intended to be temporary housing, providing access to stable housing for almost 100 people while other housing is brought online in Vancouver.
- BC Housing, MPA Society and Vancouver Coastal Health (VCH) have always been prepared to vacate the site by the end of the lease on September 30, 2023.
- Before the temporary supportive housing is moved from that site, we will ensure that all
  residents are connected to alternative housing that matches their needs.
- At that point, BC Housing would provide relocation offers to long-term housing that is similar in size, type and affordability. All residents will also be offered support in the moving process.

#### **BACKGROUND FOR MINISTRY:**

 In 2005, VAGA selected 688 Cambie Street as a potential site for the new Vancouver Art Gallery.

In 2011, Council unanimously approved reserving approximately two acres of the City-

- owned site at 688 Cambie for cultural use including a new Vancouver Art Gallery and directed staff to report back on the need for a new gallery and the business case.
- In 2013, Council again approved approximately 1.8 acres at 688 Cambie for the new gallery.
- Most recently in 2019, Council re-committed to this site.
- VAGA has submitted all required documents with the exception of architectural drawings for their development permit application. City staff will begin processing their application once it is complete.
- As recently as June 2021, VAGA expressed an interest in obtaining final permits prior to February 2022. The City has confirmed to BC Housing that this timeline is unrealistic.
- VAGA has secured a \$100-million donation from a private donor. This donation is a significant step toward the figure needed to move forward with the construction of a new art gallery on the southern two-thirds of the lot.
- However, the City has confirmed that this donation does not push VAGA past the threshold percentage necessary prior to the submission of any development application.
- VAGA has not confirmed their latest timeline for when they are aiming to submit their development permit application.
- VAGA has scheduled to announce and finalize the donation on November 4 with a 9:30 am press conference at the Vancouver Art Gallery, as well as a pitch to the media.
- VAGA is concerned about a potential leak of the substantial donation ahead of their planned activities because it could antagonize the donor and jeopardize the donation and has therefore been very cautious in confirming details to both City and BC Housing staff.
- BC Housing currently holds a lease on the site for two temporary modular supportive housing buildings with 98 units, called Larwill Place. The development permit for Larwill Place was approved on an interim basis pending redevelopment and expires on September 30, 2023.
  - 20 of these units are Vancouver Coastal Health rooms, and as such will require coordination with their staff to ensure resident notification and continuity of housing.
- BC Housing has a firm commitment on the current lease for the site, so it cannot be shortened from its current September 30, 2023, end date even if additional funding is secured by VAGA.
- However, all residents at Larwill will need to be relocated approximately five months
  prior to the September 30, 2023, end date so that the modular units can be
  disassembled, leaving the site empty for new construction.

Four months prior to the start of disassembly, BC Housing will need to begin the process
of tenant relocation to other suitable housing. BC Housing remains committed to
providing operational funding to MPA Society to the end of their operational term on site.

### **Residents and Operator Implications**

- The operator for Larwill Place, MPA Society, needs to be prepared for questions from residents and their site staff to mitigate anxieties amongst those directly affected. They will be sharing information with site staff and residents only at the time of the public announcement scheduled for November 4.
- VAGA's announcement on November 4 has the potential to create stress and uncertainty for the residents and staff of these two buildings. It is important that residents and staff hear consistent, clear information directly from MPA and not from media or other sources.
- In the future, BC Housing, MPA, VCH and the City of Vancouver will be working with residents to develop relocation plans and with individual residents on long-term housing solutions to meet the lease end of September 30, 2023.
- BC Housing is also working with MPA to ensure that the operations agreement is in place until the end of the lease, regardless of being on site at Larwill Place, or if relocations have begun to occur.
- The eventual relocation plan will require BC Housing and the operator to hold one-onone conversations with each resident to learn their needs and preferences. Relocation
  offers will be made to long-term housing that is similar in size, type and affordability, and
  support in the moving process will be offered to all residents.
- BC Housing is working with MPA Society and VCH to ensure timely and accurate communication to Larwill residents is provided on the update to the Larwill Place site, including what that means for them:
  - Delivery of notification letters with FAQ materials at the same time as VAGA's funding announcement, on November 4, 2021.
  - Regular updates for residents to provide info and answer questions.
    - BC Housing and MPA have also provided staff contacts for residents to talk with if they have any questions, including in-person at Orange Hall.
