Late on Saturday afternoon, Island Health took disciplinary action against three hospitalists for violations of the Medical Staff Rules.

Physicians who practice in Island Health hospitals are bound by the Professional Standards and Guidelines of the College of Physicians and Surgeons of British Columbia, the Island Health Medical Staff By-Laws and Rules. These Medical Staff Rules prescribe a process of disciplinary action when medical staff do not comply with these expectations.

For reasons of personnel privacy, we cannot discuss details but want to emphasize that decisions around disciplinary action regarding staff and/or physicians are never made lightly.

There have been media reports linking what occurred on the weekend to contract negotiations with the Victoria Hospitalist Physicians Incorporated (VHPI). This group has provided hospitalist services at VGH and RJH under a contract with Island health for many years and an interim agreement between the VHPI and Island Health expired on February 28. In January of this year, Island Health issued an Expression of Interest (EOI) seeking interest from individuals, associations or organizations to deliver these services at RJH and VGH in the future. The VHPI did not respond to the EOI. Island Health is currently in discussions with organizations and individuals who did respond and we anticipate contracts will be established in due course.

This sudden reduction in physician complement has resulted in some confusion regarding physician coverage and process. The questions and answers below have been developed to provide as much information as we can at this time. Regular updates will be provided throughout the duration of the EOI process.

We deeply regret that this situation has occurred and we are confident that patient care processes will be stabilized as quickly as possible.

Questions and Answers

1. How will patients be cared for?

Physician coverage is being arranged as necessary to ensure ongoing patient care. Efforts are being made to ensure all shifts are covered. This coverage will be provided by existing hospitalists who chose to continue to meet their professional and ethical obligations and/or by a combination of Island Health medical leaders and other physicians able to provide coverage. This means that some administrative functions usually performed by the medical leaders may not be carried out during this time.

2. If a hospitalist has been assigned to my patients, will they continue to provide this service?

At this time, hospitalists are providing care for patients previously admitted. With respect to newly admitted patients, they are being care for by the medical staff and other physicians able to provide coverage.

3. What do I tell family members who are concerned about the care their loved one is receiving on the unit?

We understand that family members and the public have questions and concerns. Please reassure them that physicians will continue to oversee patient care. We are arranging physician coverage as necessary to ensure patient care needs are met.

4. What do I do if I have questions about my patients?

Staff should use normal communication channels if they have questions about their patients' care. For example, nurses should contact their Clinical Nurse Leader (CNL) or Manager who is being supported by the Coordinator Site Operations (CSO) and Site Directors.

5. What other support and oversight is provided?

Additional clinical operations leaders have been brought in to provide leadership, site coordination and to resolve patient care issues at both RJH and VGH. A site command centre has been established at both sites, and is being led by an Executive Director (VGH) or the Chief Nursing Officer (RJH) and each site is developing detailed procedures and communication processes. A schedule will be developed to ensure staff are supported to resolve issues into the evenings. Island Health's leadership team is taking this matter extremely seriously. Patient care is at all times our number one priority.

6. Will this impact patient procedures and staff schedules?

We do not expect there to be any impact on procedures including surgeries, nor do we anticipate any impact on staff schedules.

7. I see some staff wearing buttons or stickers that say "I support Hospitalists", is this allowed?

Staff have a fundamental right to wear buttons or stickers that demonstrate support of an idea, ideology or particular opinion provided that the message is not offensive on the basis of a prohibited ground of Human Rights, unnecessarily interferes in safe patient care, is false, malicious or may bring disrepute to Island Health.

The College of Physicians and Surgeons of British Columbia has received an inquiry in relation to a contract matter between the Victoria Hospitalist Physicians Inc. and the Island Health Authority (IHA). We appreciate that contract matters are by their very nature complex, challenging and potentially contentious. We hope that all parties involved resolve their issues effectively and efficiently.

Our purpose in writing to you today is to ensure your awareness of the College's expectations of physicians who are considering withdrawing services in relation to a contract dispute. You have been identified by IHA as a hospitalist working at the Royal Jubilee Hospital and/or at the Victoria General Hospital. As your governing body, the College has a statutory responsibility under the *Health Professions Act* to protect the public, and act in the public interest. In accordance with that responsibility, please read the standard of the College Board titled *Withdrawal of Physician Services*.

The College website explains that standards are legally enforceable. Any failure to adhere to this standard may be characterized as unprofessional conduct and have consequences for your future professional practice. In the event of a complaint to the College, most physicians access legal counsel appointed by the CMPA to assist them. You may wish to contact the CMPA for advice about these circumstances.

Good morning,

I am writing to let you know we are managing our way through what appears to be an organized withdrawal of services by hospitalists at Royal Jubilee Hospital and Victoria General Hospital on the Island. The withdrawal started yesterday and continues as of this morning. Hospitalists at the two sites are reportedly refusing to accept new patients admitted through the ER, transfers of care from other physicians, and/or acute consultations for patients with medical complications.

Island Health is not aware how long the withdrawal is expected to continue as the hospitalists are refusing to communicate with senior medical leadership. The withdrawal, from our perspective, is directly related to local contract negotiations.

As the threat of withdrawal appeared imminent yesterday, the College issued a notice to roughly 70 hospitalists reminding them that the College has legally enforceable professional standards with respect to withdrawal of services. The Ministry, Island Health and the College held a conference call this morning to discuss current status, patient impact and mitigation strategies to ensure patients receive the care they need going forward. So far, specialists at both sites have stepped up and have taken on responsibility for the patients the hospitalists are refusing to care for. These specialists deserve our credit and appreciation for doing so.

Island Health will be pursuing the matter expeditiously today through its medical staff processes. A meeting will be taking place involving the Island Health HAMAC, the South Island MAC and the College to reinforce to the hospitalists the potential legal consequences of their actions, both in terms of privileges and licensing.

I understand Dr. Baidwan from Island Health may have been in communication with Dr. Cavers regarding the issue over the past several weeks, but he may not be aware of how activities have unfolded over the past coupe days. We are not necessarily expecting comment or action from you at this point, but simply want you to be aware of the situation. Perhaps how we might constructively manage these types of issues in the future is something we could discuss at a later date. For the present, however, please feel free to call any of us if you would like more information on this situation.

TITLE: South Island Hospitalist Services and Negotiations

PURPOSE: To provide background on South Island hospitalist services and

negotiations

BACKGROUND:

• Island Health currently contracts with two separate hospitalist groups: a physician association serving Nanaimo Regional Hospital (NRGH), and a corporation serving the South Island, including both Victoria General Hospital (VGH) and Royal Jubilee Hospital (RJH). Victoria Hospitalist Physicians Incorporated (VHPI) is the corporation providing hospitalist services at VGH and RJH.

- As is the case in other health authorities, hospitalist services are funded through the
 health authority's operational budget rather than alternative payments. Hospitalists,
 through their association/corporation then provide service invoices to the health
 authority to enable partial recoveries by the health authorities via fee for service
 (FFS) billings under the Medical Services Plan.
- Island Health has no direct contractual or compensatory relationship with individual
 hospitalists. However, the health authority has oversight responsibility for any and all
 physicians practicing within its facilities, and so all hospitalists must be members of
 the health authority medical staff and be granted privileges by the health authority.
 Those privileges are subject to ongoing review and renewal at the discretion of the
 health authority. Changes to the status of a physician's privileges
- VHPI currently employs approximately 70 part-time and full-time hospitalists at RJH and VGH. As Island Health contracts with the corporation, and the corporation is responsible for recruiting, scheduling and compensating individual hospitalists, the breakdown of full and part-time hospitalists and associated compensation rates for individual hospitalists is not available to Island Health. However, in 2013/14 Island Health paid the corporation \$14,376,267 for services.
- Hospitalist coverage at RJH and VGH is provided 24 hours/day, 7 days/week using one or more hospitalists per shift per site. This coverage does not include covering 'Code' situations.
- Hospitalists operate on a solo-physician principle. They choose their individual patient lists daily with their patients located throughout the hospital.
- Unlike the contract with the NRGH hospitalists, the VHPI costs have risen unacceptably in recent years and VHPI has taken an adversarial stance with Island Health in contract negotiations over the past year.
- South Island FFS recovery is about 27%, by comparison Nanaimo's is 46%.
- While NRGH hospitalists have increased the level of billing detail to demonstrate
 accountability, this has not occurred for the VHPI group which submits a list of
 physicians and number of hours worked on a particular day but does not indicate
 specific hours of work or location. Despite repeated requests, the Corporation has
 refused to provide further invoice detail to align with generally accepted accounting
 principles and in alignment with other physician service contracts.

- The VHPI has four contracts as follows:
 - o One contract for the main hospitalist service
 - One contract for administration of the contract(s)
 - o One contract for non-code blue emergencies
 - One contract for support to the medical ambulatory care unit
- VHPI contract costs have risen from \$3.6M yearly in 2003 to \$14.6M in 2013/14.
- Among all the hospitalists groups in Canada surveyed in 2013, the South Island
 Hospitalists see the lowest number of patients each day. They also assign specific
 patients to specific hospitalists, making inter-site transfers challenging.

Island Health's number one priority is to deliver top-quality, safe, accessible, appropriate and compassionate care for all its patients. Island Health has looked at the arrangements in 20 other health care jurisdictions in Canada and in BC, including the contract in place with the Nanaimo hospitalists. Island Health has found that the contract with the VHPI is more lucrative than anywhere else (the most expensive in BC), and Island Health wants to align the contract with contracts in other areas.

The Hospitalists should be made aware that any of their actions that negatively impact patient care will be reported to the College of Physicians and Surgeons of BC.

In the past, Island Health has considered hiring existing hospitalists directly, instead of them being sub-contractors for the Victoria Hospitalist Physicians Incorporated.

The APP rate for Hospitalists under the Physician Master Agreement is:

- \$173,561 \$216,951 (Salary)
- \$194,388 \$242,985 (Service Contract)

However, as above, it is not clear what individual hospitalists earn in Island Health due to the lack of reporting by the corporation.
