If a client received more than one type of Professional Service during a fiscal year (e.g., Home Nursing and Community Rehabilitation), the client would be counted once in each service type category, but only once in the aggregated grouping for all Professional Services combined. See the descriptions following below for information about each Professional Service type and selection criteria.

5 Methodology

- **CCData:** Professional Services data and associated client counts from CCData are attributed to the fiscal year of discharge; therefore, clients and all visits are counted in the fiscal year of discharge regardless of the year in which the visits occurred.
- **HCCMRR:** Professional Services data from the HCCMRR are based on the fiscal year of the reporting periods in which the visits occurred.

6 Data Issues - Professional Services Visits (except for Interior Health Authority):

- **Interior HA:** Professional Services visits are higher in 2008/2009, the year the Interior Health authority transitioned its visit recording methodology.
