Hi Geoff,

Sorry I didn't respond to you sooner. Dom is right that DINs are typically not uploaded to PharmaNet manually but rather through a load provided by FirstDataBank on weekly basis. As FirstDataBank gets information from Health Canada, sometimes there are delays for new DINs to get uploaded. In such cases, pharmacies typically phone HIBC to have DINs entered manually. Therefore, please advise the pharmacy in question to contact HIBC.

Hope that helps.

Hi Tijana & Dom, sorry to bother you with this issue immediately prior to the weekend. However, I was just informed that a Vancouver pharmacist apparently cannot dispense Entresto for a heart failure patient because the DIN is not yet included in the PharmaNet database. (Considering the clinical benefit of Entresto, the patient is understandably anxious to get their treatment started ASAP!)

I wasn't sure who to notify at MBPSD of this issue so I am copying you both. I have attached the Product Monograph.

Entresto is available in three dosage strengths and the DIN for each strength is included in the attached October 2nd NOC from Health Canada.

On behalf of the patient awaiting their prescription, thank you for looking into this! Can you get back to me with an ETA regarding the addition of Entresto DINs into Pharmanet? (Alternatively, how the Pharmacist should proceed with dispensing the prescription until the Entresto DINs can be added?)
