The following are other considerations for the Commission that can be addressed in the future as they are not currently affecting the commissions ability to operate:

- The Commission consists of up to nine members (and their alternates) appointed by the Lieutenant-Governor in Council.
 - three of these members are nominated by the BCMA
 - three are nominated on the joint recommendation of the Minister of Health and the BCMA to represent beneficiaries; and
 - three are public servants who represent the Government of British Columbia.
- There is currently one vacant beneficiary representative position on the Commission. The other two beneficiary representatives will expire on December 31, 2017 but are eligible for reappointment.
- The position of Second Alternate Government Representative is also vacant.
