This is an issue that seems to ebb and flow every few months. We have a template response that we are currently using, stating that the issue of funding pumps for people over 25 is currently being re-examined by the ministry. We have rec'd a couple new incomings in the past week.

Here is what the template says:

The Honourable Adrian Dix, Minister of Health, has asked me to respond to your email of XXXXX XX, 2017, regarding the coverage of insulin pumps for all ages.

I would first like to recognize the difficulties diabetes presents. I appreciate the challenges this creates for families and recognize that the costs associated with this condition are a significant concern to British Columbians.

British Columbia PharmaCare is the Ministry of Health (the Ministry) program that helps BC residents to pay the eligible costs of many prescription drugs and certain medical supplies.

PharmaCare's current policy helps cover one pre-approved insulin pump every 5 years for patients 25 years of age or younger, who have Type 1 diabetes or another form of diabetes requiring insulin and who meet the medical criteria.

The Ministry's decision to cover insulin pumps for children was informed by evidence indicating that this vulnerable population would receive the greatest benefit from the initial funding available for the program. The extension of coverage to include people age 25 and younger ensures that young adults, who are transitioning into early adulthood, can focus their attention and resources on education and prepare for the next phase of their lives.

In addition, PharmaCare also provides British Columbians with diabetes coverage for:

- insulin and other diabetes medications;
- insulin pump supplies (infusion sets and reservoirs);
- blood glucose testing strips; and
- needles and syringes for insulin use.

It might interest you to know that coverage for insulin pump supplies is available whether or not the pump was covered by PharmaCare. Actual coverage will depend on the rules of your PharmaCare plan, including any deductible.

In the face of significant cost pressures on our PharmaCare program, the Ministry must make the most effective use of funding for the management of diabetes and all pharmaceutical products.

I am pleased to advise you that the Ministry is presently considering extending coverage to adults over the age of 25. However, at this time PharmaCare's policy on insulin pumps remains unchanged.

The concerns you have raised are well taken. I hope you find this information of interest.

Update on pest and sanitary cases

Hi Matt,

I am told that both cases related to pest and sanitary issues on residential property fall within the purview of Municipal Affairs and Housing—however I did some cursory research in hopes of better understanding these cases:

- The Standards of Maintenance bylaw is the mechanism that provides local government with the ability to meet
  the needs of tenants who live in unsafe and unhealthy accommodation due to poor building maintenance:
  <a href="http://www.housing.gov.bc.ca/pub/htmldocs/pub\_guide.htm">http://www.housing.gov.bc.ca/pub/htmldocs/pub\_guide.htm</a>. As far as I can tell, it does not appear that the
  City of Abbotsford or Ashcroft have a specific Standards of Maintenance Bylaw.
- 2. As you already know, the Residential Tenancy Act has a provision regarding landlord obligations to repair and maintain the residential property in a manner that "complies with the health, safety and housing standards required by law." A standards of maintenance bylaw can clearly deal with all living areas, but in some cases may not extend to the yard and buildings and parts of the building external to the actual living areas such as elevators, lobbies and hallways. In these cases local government can use the unsightly property provisions of the Municipal Act and sections of the Fire Services Act to deal with maintenance and safety issues on the property and the Health Act to deal with a range of sanitary and health issues related to the upkeep of the property.
- 3. The BC Building and Fire Codes This code establish minimum requirements for safety, health, accessibility, fire and structural protection of buildings and energy and water efficiency. I could not identify a readily available copy, but one strategy is to request the Legislative Librarians' assistance in pulling out the relevant health-related provisions: <a href="https://www2.gov.bc.ca/gov/content/industry/construction-industry/building-codes-standards/the-codes">https://www2.gov.bc.ca/gov/content/industry/construction-industry/building-codes-standards/the-codes</a>

- I could not identify if the City of Abbotsford has a Public Health Bylaw, but the <u>Good Neighbour Bylaw</u> requires that "Every owner of Residential Premises or Residential Property subject to a Tenancy Agreement shall: (a) maintain the physical condition and structural repair of the Residential Premises or Residential Property to the health, life safety and fire protection standards of the British Columbia Building Code and the City of Abbotsford Fire Prevention Bylaw"
