Dear Honourable Ministers,

I am the President for the Crystal Waters Stata Council and represent 34 owners for properties located in the District of Lake Country, British Columbia adjacent to Crystal Water Road on the shores of Kalamalka Lake. I have recently met with Norm Letnick, our Member of the Legislative Assembly for Kelowna-Lake Country. Mr. Letnick suggested that I write to the Ministry of Health and the Ministry of the Environment to see if we could find a workable solution to a situation that has befallen our strata and its owners.

Over the past few years our Strata Council and our owners have had trouble understanding the reporting and testing protocols being demanded of our strata by the Ministry of Environment. Our strata has a very modern, up to date, well managed and well maintained wastewater plant. The plant itself was built for 60 lots with a capacity of 88.3 cubic meters per day. Because the strata was developed with only 34 lots, the wastewater plant we operate will never use its full capacity.

When the original developer of Crystal Waters applied to the B.C. government to receive a permit to operate the plant, he applied to the Ministry of the Environment for a permit the 60 units he planned to

build. The anticipated outflow levels were associated with his original target of 60 units and 88 cubic meters per day.

The development was re-designed and ended up with a total 34 lots. Because of the regulatory process chosen by the developer and because of a change in ministry people and protocols, we are now monitoring output levels and suspended solids with a test protocol and costs that are more stringent and higher than any other strata, campground and development of similar size in the Province of B.C. The cost of operating our wastewater facility consumes 43% of our total annual budget. Of these costs, 90% is for testing costs. For our 2017-18 fiscal year, our costs have doubled which results in 87% of the total budget will be consumed for testing sewage outflows.

As far as I am aware, Crystal Waters is the only community that has to test, at this very high frequency, both ground samples and lake samples. Our testing frequency is 12 times per year where a number of similar communities only test two times per year, or not at all. We test Kalamalka Lake four times per year and know that for other communities there is no lake water testing required.

We have discovered that all developments similar to ours in size are regulated by the Ministry of Health. We know that a neighbouring strata, only a few kilometers south of us, is regulated by the Ministry of Health. In the attached information you will see that our long term outflows have a daily average of +/- 10 cubic meters per day. For the Ministry of Heath to oversee and regulate our operations, we have to have daily outflows that would remain less than 22.7 cubic meters per day.

Per the provincial guidelines and regulatory practices being applied on properties similar to ours, the owners at Crystal Waters believe that with a designed daily domestic sewage flow of less than 22,700 litres per day, our strata should be regulated by the Minister of Health under the "Small Sewage Regulation" (SSR).

We have had a number of meetings with our testing company, Golder and Associates and initiated meetings with the local authorities from the Ministry of Environment and the Ministry of Health. Your expertise and guidance in finding a solution to our concerns will be greatly appreciated.

British Columbia is committed to an evidence-based process that includes at its centre the Common Drug Review's (CDR) determinations of a drug's clinical efficacy and cost effectiveness.

Vertex, which is charging \$250,000 per year per patient for this drug, has indicated that it has new data about Orkambi that may impact the CDR's previous recommendations. The Ministry worked to advocate for a change to the rules of the Common Drug Review so that the company could present this data, and it has agreed to make this change. We also encouraged the manufacturer to make a resubmission to the CDR under the revised rules, which it is now doing.

The resubmission to the CDR doesn't guarantee that the drug will be approved. Decisions are going to be made based on the evidence and by health professionals – not politically.

We are pleased that Vertex has decided to provide compassionate access – that is entirely appropriate, as B.C. awaits for the resubmission and review process to move ahead. All jurisdictions respect the CDR process and we have full confidence that CDR is aware of the particular circumstances surrounding Orkambi.

Research strategy forges a path to better public health care

VICTORIA – Improving outcomes for patients and the public health-care system they rely on through robust, unbiased analysis and evaluation is at the centre of the new Ministry of Health research strategy, Health Minister Adrian Dix announced today.

"The Ministry of Health should be the centre of independent, non-conflicted health information and research as part of ensuring the best outcomes for British Columbians, and the best investments in their public health system," said Dix.

"This strategy will help restore the Ministry of Health position as a leader in evidence-based health policy to ensure patient safety, better health outcomes and quality improvement in our public health care system. At a time when questions about how to deliver patient-centred care grow in number, complexity and urgency, we must enhance our research capacity to support the fundamental goals of public health care," said the Health Minister.

The plan "Putting our Minds Together: Research and Knowledge Management Strategy" responds to recommendation 35 in the Ombudsperson's report (title?) for a plan to address gaps found in evidence-based programs after the 2012 Health Ministry firings. It expands the use of objective analysis across all the work of Ministry.

"In the 21st century, accessing and utilizing research is essential to preventing illness, improving quality of life and helping patients recover fully. This plan both fills gaps created by the damaging impact of the 2012 health firings, and paves a path to make the Ministry a forerunner again in evidence based research and analysis," added Dix.

"Already in the September budget up-date, we delivered a renewed long-term commitment to the Therapeutic Initiative. The TI over almost 25 years in BC has saved lives and saved money through education and independent reviews of the efficacy and value of prescription drugs."

""Putting our Minds Together" is about preventing illness, improving quality of life and helping patients recover fully and quickly. Much was lost in the health firings scandal this plan points the way to a brighter future. I wish to thank all those who participated in its development – inside and outside of government."

"This is much more than just a response to the Ombudsperson's report," commented Dr. Malcolm Maclure, a professor and B.C. chair of patient safety in the department of anaesthesiology, pharmacology and therapeutics at the University of British Columbia, and former co-director of research and evidence development in the ministry's pharmaceutical services division. "To me, it's a refreshing blueprint for concrete steps towards a culture in which decision-makers and researchers collaborate on developing evidence that is directly relevant to policy."

Highlights of the strategy include:

- In collaboration with the University of British Columbia's Therapeutics Initiative (TI), the ministry's
 pharmaceutical services division will develop a new optimal drug use program to help doctors with
 appropriate prescribing.
- TI will undertake systemic drug utilization reviews. The latter involves post market evaluation of drugs, to assess if they being prescribed appropriately, if they are cost effective and to evaluate new evidence about their therapeutic value and safety, prescribed to patients in the real world over a period of time.
- Introduction of Healthwiser, a platform to evaluate patient services, programs and policies through rapid cycle, ongoing evaluation,
- Starting in September 2018, the ministry will have senior researchers as well as those who are early in their careers working on site with staff as part of research residency and fellowship programs
- Improving access to data (add detail)

"We congratulate the Ministry of Health on the strategy and look forward to continuing our collaborative relationship with the ministry to improve the health-care system, health outcomes for British Columbians and the research enterprise in the province," said Bev Holmes, president and CEO of the Michael Smith Foundation for Health Research.

Implementation of the strategy is well underway and will take approximately 18 months to complete. A \$5-million annual fund will support the research, evaluation and knowledge management activities included in the strategy. This fund is in addition to a \$10-million, 5-year grant to renew and bolster the Therapeutics Initiative.

Since April 2017, when the Ombudsperson's report was released, the Ministry of Health has worked to respond to all of the report's recommendations, including the creation of this research strategy report.
