Yikes, so sorry Joni. This one slipped through the cracks.

In answer to your question: MONICA: A reference was made in the meeting to CASC contracts and allowable FFS billings under the agreement. Could you please clarify if FFS billings are allowed in CASC agreements and if so, under what circumstances.

There are 3 parts to the CASC contract:

- Anaesthesia managed by VCHA
- Ortho-Trauma managed by VCHA
- Cardio Vascular Thoracic (CVT) managed by PHC
- Most of the funding for the CASC contract comes from FFS. The approx.^{s.17} MoH contributes is called "gap funding" by VCHA. (the total cost of CASC is about ^{s.17}
- However, that does not mean the physicians working under CASC keep any of the FFS.
- The physicians are on salary and "assign their FFS" to their Health Authorities (to VCHA for the Anaes & Ortho-Trauma surgeons, to PHC for the CVT surgeons)
- The Anaesthesia CASC surgeons assign all MSP-FFS and all 3rd party billings except for WCB. That is part of their CASC agreement.
- ullet The other two CASC (Ortho-Trauma & CVT) assign ALL their FFS to either VCHA or PHC
