The model works well for patients with chronic disease. Nurse practitioners are an important part of such a multidisciplinary team and can do some of the gatekeeping to increase system efficiency.

I took a look at the link to the Victoria Division of Family Practice and found it heartening that there is an organization to support family physicians and to explore new models of service delivery. Unfortunately, the bottom line is still that no doctor is accepting patients at this time but there would appear to be some hope that in future, there may some options available. I am happy to hear that this issue has been assigned high priority.

Thank you for taking the time to respond in depth. I will be watching with interest as some of these initiatives unfold and will not give up the search for a physician or team where we will receive continuity of care. I have also expressed my concern to a Langford council member as I believe that there is a duty to provide services to the growing population which has resulted from a high rate of development on the Westshore. This duty needs to be a joint effort of all levels of government working cooperatively. Please share my comments as you see fit.

Thank you for your email regarding the shortage of family physicians in Victoria area. My name is Maureen and I am a constituency assistant for MLA John Horgan. John and his colleagues take this shortage very seriously. I appreciate that you are in good health and are working towards a future plan. I would like to give you some back ground and share with you the position of the government: Primary care is the first point of contact for most patients in the health system, and the majority of patient visits are in a primary care setting. But many British Columbians cannot find a primary health care provider.

The Ministry of Health is focused on making certain there is the right number, type, and distribution of health care providers across the province. Our strategy to achieve this is interdisciplinary team-based care, where teams of doctors, nurse practitioners, nurses and other health care professionals work together to provide care to people.

There is a wealth of research evidence from around the world indicating that team-based care has significant benefits for patients, providers and the sustainability of the health system. Team-based care has been shown to reduce hospitalizations and physician visits while improving outcomes for patients with chronic diseases.

It also reduces duplication and streamlines care, increasing the efficiency and sustainability of the health system. The Ministry is currently working with a number of communities to test funding models to support team-based care in order to increase access for patients to primary care.

Expansion of team-based care will include adding team members to existing family practices and health authority primary care clinics to form in-practice teams, and networking clinics and providers into groups that work together as part of a broader community-based team. Giving providers the chance to be part of a team can also encourage existing providers to stay and attract new ones to the practice, which is particularly important in communities where people are having difficulty finding a regular primary care provider.

In addition to the work of the Ministry, groups of family doctors throughout the province are collaborating through their local Divisions of Family Practice to improve access for patients. On the South Island, the Victoria Division of Family Practice is recruiting new family doctors and locums to the community.

They are also supporting physician retention through succession planning, coaching, medical record optimization, and other initiatives to improve efficiency and allow doctors to accept more patients. If you would like to read more about what the Victoria Division of Family Practice is doing, I encourage you to visit their website at: <a href="https://www.divisionsbc.ca/victoria">www.divisionsbc.ca/victoria</a>.

For those that do not have a primary care provider, working with a nurse practitioner may prove beneficial. Nurse practitioners perform the full range of nursing functions, as well as some functions similar to physicians such as diagnosing and managing common acute and chronic illnesses, prescribing, ordering diagnostic tests and referring to specialists.

Our government committed to training more doctors, nurses and allied health professions to care for our citizens. Strategies are underway at a provincial, regional, and community level to ensure the necessary health workforce is in place. For example, to address the shortage of physicians, the Ministry funds 346 entry-level physician training (residency) positions at the University of BC including 58 for physicians who have some of their training outside of Canada.

Another initiative is the Practice Ready Assessment BC (PRA-BC) program, which creates a pathway for experienced physicians from overseas to work in British Columbia. In its first two and a half years of operation, the PRA-BC program has brought 83 family physicians to BC.

Team-based care has great potential to help more people access care and is one of our top priorities. By bringing teams of family doctors, nurse practitioners, nurses and other health-care professionals together we can better address everyday health issues and support long-term health needs like home care.

We recognize that for those who are in urgent need of a family doctor, the work isn't happening quickly enough. But please be assured that we are making addressing the shortage a priority.

Thank you again for writing, and I hope this has started the process to address your concerns.

#### To all concerned:

I am writing today as the Electoral Area Representative for the Strathcona Regional District, Area C (Discovery Islands - Mainland Inlets) regarding an extremely urgent matter that needs immediate action by Island Health and the Ministry of Health. As you will read below, the Quadra Island Medical Clinic will be closing its doors at the beginning of November. This will create an incredible void in the available medical services on Ouadra island.

I have included below a short executive summary of the problem and our request to temporarily solve the problem. It requires the cooperation of both Island Health and the Ministry and would cover a period of approximately 14 months. The request is not a very large one and need not be considered precedent setting. It is an emergency. As the representative of Area C, I represent the people served by this Clinic. Extreme hardship will be imposed upon them by this closure and excessive cost will be borne by the Ministry through the need for additional travel to Campbell River and the use of the Travel Assistance Program forms that will then be charged to the Ministry and paid to BC Ferries. As outlined below, our operational shortfall could be up to a maximum of \$100,000.00. This pales in comparison to the

minimum of approximately \$230,000.00 in Travel Assistance Program forms that the Ministry will need to fund due to the closure. I realize that Island Health does not necessarily have the funding for this operational request and that is why I am asking the Ministry to step in and help in this desperate situation. We need time to explore alternatives. We cannot do that without *commitment* of funding from both Island Health and the Ministry.

We have had commitments from Island Health for most parts of this request but we need commitment for *all* parts as listed below. We need that commitment immediately as our time has run out. I am including the letter that Dr. Boegel is required as a doctor to send out to her patients 3 months prior to her closing of the practice. This letter will be a public document and will certainly be noticed by the media. The issue has already been in articles in the local paper. This letter will be the definitive word on the closure. We all need to work together collaboratively to provide the service we are requesting, hopefully prior to this letter being released.

I would hope that you will be able to respond to this email right away. We have no time left, through no fault of our own.

In those early months, as my recruitment efforts progressed, it became clear that it was not possible to recruit a physician interested in taking on the ownership and management of the clinic. As time went on without a likely successor, I asked a group of interested community members to form a working committee with the idea of forming a Health Society to assume ownership and management of the clinic at the time of my departure and to collaborate with Island Health and the Ministry of Health to financially support the Society toward this end. The working group has held a community forum and has sought and received widespread community support. They have invited and welcomed the active involvement of our Regional Director, Jim Abram, sought the support of our MLA, Claire Trevena, met multiple times with Island Health representative Dr. Tom Gornall, met with representatives of the We Wai Kai Nation, including Chief Brian Assu, and Kwakiutl District Council Health Director for Campbell River, Kim Roberts, and consulted with the local Divisions of Family Practice administrator, Christine Colbert. They have received the support of Harbourside Medical Clinic in their efforts. They have researched the new Ministry of Health concept of serving communities by creating Community Health Centers that would house Patient Medical Homes, which could offer a wider scope of health services on Quadra. They have researched the expense to the Ministry of Health and to Island Health of the potential loss of medical services on Quadra including costs to the Transportation Assistance Program and emergency

services provision at Campbell River Hospital. They have officially formed the Quadra Island Health Society to carry on the work of the clinic and to investigate plans for ongoing health services for Quadra and the Discovery Islands.

After this extensive effort, I and the working committee have presented a concrete proposal to Island Health requesting, first, that Island Health apply to the Ministry of Health for authorization to allow the clinic to be staffed by a full-time locum physician during 2019 and, second, that Island Health subsidize the Health Society financially to cover expenses that might not be met by the income of the clinic during the transitional year. During the consultation process described above, I have received promises of support from Dr. Tom Gornall, who was assigned to represent Island Health in working with me and the committee. I have sought, contacted and received interest from physicians who would be pleased to share the extended locum position we seek.

Despite promises of support, Island Health has yet to apply to the Ministry for the extended locum position or to commit to provide the modest financial support requested to allow the Health Society to take on the financial obligations of the clinic. I had hoped to leave the clinic, which has provided not only physician services, but also lab and mental health services, in the hands of the newly formed Quadra Island Health Society. But, without a commitment of support from Island Health, the Society simply can't assume this burden.

I want to thank all my patients for the great gift you have given me, the joy of serving as your physician. I want to especially thank the committee members and Jim Abram who have worked so hard in the last months to maintain ongoing and create even better health services for our Quadra and outlying island communities.

I am writing today as the Electoral Area Representative for the Strathcona Regional District, Area C (Discovery Islands - Mainland Inlets) regarding an extremely urgent matter that needs immediate action by Island Health and the Ministry of Health. As you will read below, the Quadra Island Medical Clinic will be closing its doors at the beginning of November. This will create an incredible void in the available medical services on Quadra island.

I have included below a short executive summary of the problem and our request to temporarily solve the problem. It requires the cooperation of both Island Health and the Ministry and would cover a period of approximately 14 months. The request is not a very large one and need not be considered precedent setting. It is an emergency.

As the representative of Area C, I represent the people served by this Clinic. Extreme hardship will be imposed upon them by this closure and excessive cost will be borne by the Ministry through the need for additional travel to Campbell River and the use of the Travel Assistance Program forms that will then be charged to the Ministry and paid to BC Ferries. As outlined below, our operational shortfall could be up to a maximum of \$100,000.00. This pales in comparison to the minimum of approximately \$230,000.00 in Travel Assistance Program forms that the Ministry will need to fund due to the closure. I realize that Island Health does not necessarily have the funding for this operational request and that is why I am asking the Ministry to step in and help in this desperate situation. We need time to explore alternatives. We cannot do that without commitment of funding from both Island Health and the Ministry.

We have had commitments from Island Health for most parts of this request but we need commitment for all parts as listed below. We need that commitment immediately as our time has run out. I am including the letter that Dr. Boegel is required as a doctor to send out to her patients 3 months prior to her closing of the practice. This letter will be a public document and will certainly be noticed by the media. The issue has already been in articles in the local paper. This letter will be the definitive word on the closure. We all need to work together collaboratively to provide the service we are requesting, hopefully prior to this letter being released.

I would hope that you will be able to respond to this email right away. We have no time left, through no fault of our own.

Thank you for your attention to this extremely important matter.

Since announcing my retirement last winter I have attempted to find a physician to replace me and Dr. Kellerhals at QIMC. In those early months, as my recruitment efforts progressed, it became clear that it was not possible to recruit a physician interested in taking on the ownership and management of the clinic. As time went on without a likely successor, I asked a group of interested community members to form a

working committee with the idea of forming a Health Society to assume ownership and management of the clinic at the time of my departure and to collaborate with Island Health and the Ministry of Health to financially support the Society toward this end.

The working group has held a community forum and has sought and received widespread community support. They have invited and welcomed the active involvement of our Regional Director, Jim Abram, sought the support of our MLA, Claire Trevena, met multiple times with Island Health representative Dr. Tom Gornall, met with representatives of the We Wai Kai Nation, including Chief Brian Assu, and Kwakiutl District Council Health Director for Campbell River, Kim Roberts, and consulted with the local Divisions of Family Practice administrator, Christine Colbert. They have received the support of Harbourside Medical Clinic in their efforts. They have researched the new Ministry of Health concept of serving communities by creating Community Health Centers that would house Patient Medical Homes, which could offer a wider scope of health services on Quadra. They have researched the expense to the Ministry of Health and to Island Health of the potential loss of medical services on Quadra including costs to the Transportation Assistance Program and emergency services provision at Campbell River Hospital. They have officially formed the Quadra Island Health Society to carry on the work of the clinic and to investigate plans for ongoing health services for Quadra and the Discovery Islands.

After this extensive effort, I and the working committee have presented a concrete proposal to Island Health requesting, first, that Island Health apply to the Ministry of Health for authorization to allow the clinic to be staffed by a full-time locum physician during 2019 and, second, that Island Health subsidize the Health Society financially to cover expenses that might not be met by the income of the clinic during the transitional year. During the consultation process described above, I have received promises of support from Dr. Tom Gornall, who was assigned to represent Island Health in working with me and the committee. I have sought, contacted and received interest from physicians who would be pleased to share the extended locum position we seek.

Despite promises of support, Island Health has yet to apply to the Ministry for the extended locum position or to commit to provide the modest financial support requested to allow the Health Society to take on the financial obligations of the clinic. I had hoped to leave the clinic, which has provided not only physician services, but also lab and mental health services, in the hands of the newly formed Quadra Island Health Society. But, without a commitment of support from Island Health, the Society simply can't assume this burden.

I want to thank all my patients for the great gift you have given me, the joy of serving as your physician. I want to especially thank the committee members and Jim Abram who have worked so hard in the last months to maintain ongoing and create even better health services for our Quadra and outlying island communities. # Work begins on new Tofino General Hospital helipad

TOFINO – Helicopter access to Tofino General Hospital will resume in early 2019, thanks to a strong community partnership between Island Health, the Tofino General Hospital Foundation and the Alberni-Clayoquot Regional District.

The new helipad will be built on Tofino General Hospital Foundation lands located adjacent to hospital. It is in the same general area as the existing helipad, which closed in December, 2011 after Transport Canada issued an order for upgrades. A request for proposals for construction will be issued in the coming weeks, and work will begin once the tender is awarded.

Project cost will be shared by Island Health (60 per cent) and the Alberni Clayoquot Regional Hospital District (40 per cent).

"The community has been clear that a helipad at Tofino General Hospital is an important part of the health-care picture for this region and it is great news that this project is moving forward," said Health Minister Adrian Dix. "Once in place, this helipad will help ensure that the most critically ill patients are able to get to the care they need as quickly as possible."

In late 2016, Island Health met with community stakeholders, including municipal representatives, neighbours and the hospital foundation for input into the proposed helipad. Following this consultation, a plan was developed for the project.

"Island Health is extremely pleased the helipad is underway," said Leah Hollins, Chair of the Island Health Board of Directors. "We know helicopter access to Tofino General Hospital is a priority for residents of the West Coast of Vancouver Island, and we appreciate the community support and feedback we received during our planning process."

"The helipad will help to ensure residents and visitors to Tofino have access to the critical emergency care they need it," said Scott Fraser, MLA for Mid-Island – Pacific Rim, "it will complement the already top-notch care provided by our health care professionals at Tofino General Hospital."

#### Good morning,

As you may know, in Budget 2017 the federal government announced a new federal tax-free grant to families of first responders who die as a direct result of their duties. The objective is to recognize the service and sacrifice of Canada's first responders who die in the line of duty, including deaths resulting from occupational illness and from a psychological impairment (i.e. suicide). The grant consists of a one-time lump-sum payment of \$300,000 to the surviving families of first responders who die as a result of their duties on or after April 1, 2018.

The latest information provided by Public Safety Canada (PSC) is that the class of eligible recipients includes family members of all police officers (including RCMP), firefighters and paramedics, including all related volunteers, reservists and auxiliaries.

Provinces must sign a Memorandum of Agreement (MOA) with the Government of Canada for residents to be eligible for this grant. This requirement is to ensure that the full amount of the grant would not be off-set or subject to any reductions by any existing or future benefit schemes that operate at the provincial or municipal levels. A PowerPoint on the Program is attached and will provide you with more information.

PSC officials will be travelling to Victoria on May 30, 2018, to meet with government officials. This is an opportunity for PSC officials to provide information on the Memorial Grant and to answer questions from provincial staff. I think some of the confusion stems from the fact that ICBC lists "Permanent Resident card (previously Canadian record of landing)" as an acceptable form of primary ID. Angela has a Verification of Status document from IRCC for her client, that (as the below link states) can be used as a "record of landing or confirmation of permanent residence" (<a href="http://www.cic.gc.ca/english/helpcentre/answer.asp?qnum=564&top=12">http://www.cic.gc.ca/english/helpcentre/answer.asp?qnum=564&top=12</a>). Can you confirm with the appropriate provincial ministry if a Verification of Status would be accepted?

Not only is the processing time for a permanent resident card varied (it can range from 98 days to 24 months) the process can be difficult and frustrating for an individual with limited comprehension.

While I know that hiring decisions are made primarily at the regional health authority level, <u>8.22</u> is wondering what broader strategies and/or initiatives the Ministry is developing in order to combat shortages of RNs <u>8.22</u> and perhaps more broadly in the Greater Victoria Region. I certainly recognize that this was an area that was severely neglected over the past decade, and <u>8.22</u> experience serves as an example of why we need to

change the healthcare status quo in this province to ensure she – and the thousands of people s.22 are able to count on a healthcare system that will be there for them.

Thank you kindly for your time and consideration of this request for information. Our office looks forward to learning more about the strategies and/or initiatives your Ministry is employing in this area.

Kassandra thank you for the time the other day. I have attached a short 2-pager which will provide the sequence of events and where things were left off in April of 2016, along with basically what CNIB is requesting for moving forward.

A couple of points that I am not sure we discussed; at every level within MOH when this was discussed MOH officials always felt this services should be provided through the Provincial Services Authority not through individual contracts with each Health Authority which could result in a patchwork approach for where there is or is not services available.

The other reality is by 2019, without some form of agreement, VLRS will only be able to provide a level of service equal to the level of funding, so it would be desirable to have a transition plan in place for next year.

On your question regarding the Pacific Training Institute for the Blind, they are an independent group, reasonably small and mainly Victoria centric. CNIB has reached out a number of time unsuccessfully to engage them to see if there are some synergies in the delivery of services to people with vision challenges. The most significant challenge is they have no standards for their programs and not certified or accredited with any professional association or collage, which puts their programming at some risk. The previous government never did put out a press release around the funding they did provide and this really can be a good news announcement.

John Mulkas.22 Once you have had a chance to read the note and consider what is the best approach for CNIB to continue the conversation, possibly we can have another chat on what our next steps should be.

Because this is a budget issue and I suspect that is always a challenge, CNIB would still be prepared to look at some form of phasing in over a longer period as part of an execution plan.

I have spoken with our staff who are responsible for the MSP coverage decision, and they have clarified the basis for their decision for me.

They are bound under legislation to not issue MSP coverage without documentation that proves PR status in Canada. IRCC would need to at least provide a letter explaining the situation as they have explained it to you in order for MSP to revise their decision.

All the information on the IRCC website refers to the 2 of 5 year residency requirement as a determinant of Permanent Residency "Status". We would need to see something in print that nuances that and makes a distinction between PR status and PR card. She may have PR *eligibility*, but will need documentation to prove her *status*. If you can get any kind of documentation that substantiates \$.22 status, MSP will gladly revisit their

The point you make there is precisely the catch. I've been over it a number of times with staff in IRCC and the Minister's office. It seems that the 2-years-out-of-5 requirement is needed to get a PR card, but it doesn't invalidate PR status. So they will confirm that she has PR status, but she is ineligible to get a card proving as much until she's spent two years in Canada again.

So she has applied for a card with a request for exemption to that requirement on humanitarian grounds. If that is denied, her options are: 1) stay in Canada for another 16 months to meet the 2 year requirement (though it seems that may mean doing so without medical coverage), or 2) go through a process of having her current PR status revoked in order to be able to apply once again for PR status that would come with a new card.

I have spoken with our staff who are responsible for the MSP coverage decision, and they have clarified the basis for their decision for me.

They are bound under legislation to not issue MSP coverage without documentation that proves PR status in Canada. IRCC would need to at least provide a letter explaining the situation as they have explained it to you in order for MSP to revise their decision.

All the information on the IRCC website refers to the 2 of 5 year residency requirement as a determinant of Permanent Residency "Status". We would need to see something in print that nuances that and makes a distinction between PR status and PR card. She may have PR *eligibility*, but will need documentation to prove her *status*. If you can get any kind of documentation that substantiates <u>s.22</u> status, MSP will gladly revisit their

I hope this helps. Feel free to volley back if you have additional information or can clarify any detail that is confused. Cheers.

The point you make there is precisely the catch. I've been over it a number of times with staff in IRCC and the Minister's office. It seems that the 2-years-out-of-5 requirement is needed to get a PR card, but it doesn't invalidate PR status. So they will confirm that she has PR status, but she is ineligible to get a card proving as much until she's spent two years in Canada again.

So she has applied for a card with a request for exemption to that requirement on humanitarian grounds. If that is denied, her options are: 1) stay in Canada for another 16 months to meet the 2 year requirement (though it seems that may mean doing so without medical coverage), or 2) go through a process of having her current PR status revoked in order to be able to apply once again for PR status that would come with a new card.

Extrication has always been our work as often this takes place in "hot zones" such as motor vehicle incidents where BCAS members are often not permitted to enter. As the newsletter states the EMALB can grant endorsements for us to perform these tasks.
