### **Registration committee**

- (a) reviewing the standards of practice to enhance the quality of practice and to reduce incompetent, impaired or unethical practice among registrants,
- (b) administering a quality assurance program to promote high standards of

### ***Patient relations committee***

19. (1) The patient relations committee is established consisting of 3 persons appointed by the board.

(2) The patient relations committee must include at least one appointed board member.

(3) The patient relations committee must

- (a) establish and maintain procedures by which the college deals with complaints of professional misconduct of a sexual nature,
- (b) monitor and periodically evaluate the operation of procedures established under paragraph (a),
- (c) develop and coordinate, for the college, educational programs on professional misconduct of a sexual nature for members and the public as required,
- (d) establish a patient relations program to prevent professional misconduct, including professional misconduct of a sexual nature,

(e) develop guidelines for the conduct of registrants with their patients, and

(f) provide information to the public regarding the college's complaint and disciplinary process.

(4) For the purposes of this section, "professional misconduct of a sexual nature"

(a) sexual intercourse or other forms of physical sexual relations between the registrant and the patient, (b) touching, of a sexual nature, of the patient by the registrant, or (c) behaviour or remarks of a sexual nature by the registrant towards the patient; but does not include touching, behaviour and remarks by the registrant towards the patient that are of a clinical nature appropriate to the service being provided.

INFORMATION BULLETIN

Universal, no-cost coverage for Mifegymiso in B.C. to start on Jan. 15, 2018

VICTORIA - The provincial government will soon be providing universal, no-cost coverage for the drug Mifegymiso. Mifegymiso, an alternative to surgical abortion, is a combination of the drugs mifepristone and misoprostol. It can be used to terminate pregnancies at an early stage - up to nine weeks from the start of the last menstrual period. Universal, no-cost coverage will commence Jan. 15, 2018. Since July 11, 2017, PharmaCare has been covering Mifegymiso, subject to the rules of a person's PharmaCare plan. Patients under the Fair PharmaCare plan may face an out-of-pocket expense. Currently, the out-of-pocket cost for Mifegymiso for individuals without PharmaCare coverage is approximately \$300.

Removing the cost barrier helps ensure that individuals can access this safe and available option if they choose. In April 2017, the common drug review recommended Mifegymiso, also known as RU-486, for public coverage. Pharmacists are able to dispense Mifegymiso to patients with a valid prescription. To obtain a prescription, patients must visit a physician or nurse practitioner for s.13

s.13 Health-care professionals who are going to prescribe or dispense Mifegymiso are encouraged to complete an education program.

Mifegymiso will be available at all participating pharmacies throughout B.C. All pharmacies will be able to order the drug as needed, which could take up to two business days to receive. Stock of Mifegymiso will be available at pharmacies that are rural, remote or have previously dispensed high volumes of the medication.

Can you please submit this case for MLA bullets?

Judy Darcy's office, as well as that of Bob D'Eith and Bruce Ralston, have received correspondence from multiple constituents who are concerned about losing their jobs as a result of a P3 contract at Royal Columbian Hospital — a single example is attached below.

This case got lost in the shuffle in the early days of us setting up our systems, and has just now been brought to me for follow-up. I am feeling sensitive to the fact that these MLA offices have been waiting for some time for assistance with this issue. It is not an asap, but needs to be handled without unnecessary delay. This issue is politically sensitive. We need clear confirmation regarding whether the P3 contract has been put into place, or not. If it has, what work/services does it apply to? And if confirmed, what does this mean for people currently employed by the hospital in capacities that may be affected, such as maintenance? If the contract has not been put into place, what is the timeline on and process for that decision?

We need strong messaging that can be put into the hands of CAs to have fully informed dialogues with the constituents who have been in touch with them. They are likely to have quite a number of questions.
