### **Request**

I'd be interested in talking to the minister about the new seniors report today. The idea that seniors are far more likely to end up dying in a hospital ER if they are in privately-operated care homes is fascinating. But for the minister I'd specifically like to talk about the larger issue of where private care homes fit within the new government's healthcare plan, whether he envisions reducing the number of privately-run beds with publicly-operated ones, etc.

I also have some other background questions I will send in a separate email.

Some background Qs I'm interested in from the ministry re: seniors report.

There's a line in the report that says:

"We know that, on average, contracted care facilities pay lower wages than public facilities. Only 54 out of 187 contracted facilities pay the funded wage rate and benefits of the master collective agreement (\$23.95 per hour); the other facilities pay less, some of them much less (some are below \$19 per hour)." (pg9)

I'm curious as to how this work and whether the ministry tracks it.

Does the health authority give a care provider the full wage of \$23.95 per hour for a staff member, regardless of whether that private operator actually pays that rate to its employees?

For example, the facilities that pay \$19 to an employee – does it still receive \$23.95 from the health authority for that position? And if so, where does the almost \$5 difference go? Is that profit for the private care provider?

Is the ministry concerned about this? Would it not essentially mean that the private operators are pocketing money that is earmarked by government to employee pay?

Another Q: What is the new government doing to prevent contract flipping in seniors care homes? The report questions whether private care home staff skill mix, and the uncertainty caused by frequent layoffs and contract flipping, is a contributing factor to the high hospitalization rates. Is the new government doing anything to prevent that?
