Hi Kassandra,

We need the Minister's decision on the theme for this year's BC Francophonie Day. Once we have the Minister's decision on the theme, we will come forward with other decision points (e.g. recipients for the BC Francophonie Day award who worked on matters related to the theme, etc.).

We are proposing "**Honouring our B.C. Francophone History**" as this year's theme for BC Francophonie Day. The rationale is that the project to identify historic places of significance to the Francophone community will soon be completed and it will be very timely for Minister Dix to make an announcement. The *Francophone Historic Places Project* is a joint project involving FAP and Heritage Branch in the Ministry of Forests, Lands and Natural Resource Operations and

Rural Development (FLNRORD). If the Minister agrees on the proposed theme, Minister Donaldson (or his representative) would take part in the event and we would develop a role for him. The timeliness of the project, the community angle, public participation, the sense of belonging to BC and having taken part in making BC what it is today, are key factors related to the choice of this proposed theme.

Background: In 2017, FLNRORD and the B.C. Francophone Affairs Program partnered for the implementation of the *Francophone Historic Places Project*. An Advisory Committee and an Evaluation Committee made up of members of the Francophone community also collaborated on this project. This project builds on the experience gained from previous historic place recognition projects working with Chinese Canadian, Japanese Canadian and South Asian Canadian communities. Previous historic place recognition projects were concluded by an event announcing the selected historic sites.

Francophone Historic Places Project Update: As part of this project, the B.C. government sought nominations from the public for historic places with significance to British Columbia's Francophone community. The online nomination process was held from March to June 2018. Nominations could be any type of places, anywhere in British Columbia, including structures, buildings and groups of buildings, districts or landscapes. Approximately 100 sites were nominated through this process. As of today, nominations have almost all been reviewed by an Evaluation Team. Each nominated site is evaluated against value-based criteria, to recommend which sites throughout British Columbia should be included on the BC Register of Historic Places and nominated to the Canadian Register of Historic Places. FLNRORD staff advises that the Evaluation Team will provide their final selection of sites to Minister Donaldson in the coming weeks for his approval. The project will also deliver a Historical Context Thematic Framework and an online map that will include all nominated places and highlight those that are formally recognized at the provincial level.

Opportunity: The B.C. Francophonie Day celebrations on March 7th is a very meaningful event for francophones and francophiles in British Columbia. This annual event is well attended by the B.C. Francophone Community. It would be timely for Minister Dix and Minister Donaldson to announce the final selection of Francophone historic places in British Columbia under the proposed B.C. Francophonie Day theme: "Honouring our B.C. Francophone History".

1. Introduction

In preparation for Primary Care Network planning, the Central Okanagan Division of Family Practice and Interior Health are requesting Expressions of Interest (EOI) from Physician offices able to provide space in their clinic during extended hours for the purposes of provision of urgent primary care services. This EOI is the first step in the procurement of space to support urgent primary care in the Central Okanagan.

2. Background

The Ministry of Health defines a core attribute of a Primary Care Network (PCN) as the provision of same day access for urgently needed care through the PCN or an urgent primary care centre.

Urgent primary care is defined as primary care for injuries and illnesses that should be seen by a health care provider within 12 to 24 hours but do not require the level of service or expertise found in an emergency department. Urgent primary care tends to be provided outside of traditional primary care office hours and ideally takes an inter-disciplinary team based approach to patient care.

Urgent primary care services do not need to be provided in a new facility; they can be developed using current infrastructure and resources. These services can be located at an existing primary care facility through Interior Health leasing space and

providing staff and resources to operate the facility during extended hours. The Division of Family Practice and Interior Health would work with the clinic regarding the design of the urgent care services. Interior Health would be responsible for their operation and appropriate remuneration will be negotiated.

3. **Clinic Location and Space Requirements**

The Central Okanagan Division of Family Practice and Interior Health are looking for clinic space where urgent primary care services can be provided outside of regular business hours. It is a preference of the Ministry and the Health Authority that the clinic is not located in the vicinity of the hospital, in order to better distribute the services across the PCN.

- Availability of space in the evenings 7 days per week and on weekends and statutory holidays.
- Space configured to accommodate physician-led appointments and additional capacity for non-physician clinical team members to support care.

The psychiatric unit has one nurse for every five patients during the day and one nurse for every eight patients after 2300hrs.

There is also a Rehab/Mental Health support worker seven days a week (days and evenings) as well as a charge nurse leader, social worker and occupational therapist, Monday to Friday. Peer support workers are also on the unit for a few hours seven days a week.

It is a 24 bed unit at Nanaimo Regional General Hospital.

The Psychiatric Intensive Care unit has one nurse for every two patients. There is a Rehab/Mental Health and Substance Use support worker seven days a week (days and evening). It is a four bed unit.

The Psychiatric Emergency Service has three nurses 24/7. This is a staffing increase (from two nurses to three made permanent on Jan 1st, 2019). There is an option to request more staff, if needed, for high volume and acuity. There is a Rehab/Mental Health and Substance Use Support worker seven days a week (days and evenings).

The Psychiatric Intensive Care Unit and Psychiatric Emergency Services share a social worker seven days a week.

There is an acute care Clinical Coordinator for all three units.

None of the units has had a staffing cut. As noted above, the Psychiatric Emergency Service had a staff increase as of January 1, 2019.

Among the most troubling aspects of the new agreement is the ramping up of aggressiveness in the design of the pay parking system itself. Hospital parking lots with controlled entrances used to offer patients and their supporters an opportunity to pay for parking upon exiting the lot. This design didn't involve meters that needed to be constantly fed to avoid a violation notice. The new contract however, explicitly directs Impark to phase out this design, currently used at only five LM hospitals, and install automated kiosks in combination with mobile LPR (Licence Plate Recognition) armed patrol staff to monitor and issue tickets on expired meters. Many Vancouver area residents will be familiar with the guess-your-time and prepay method as it has been the dominant pay parking system for the past few years. Some of the text alludes to the

potential roll-out of pay parking to even more Health Authority managed properties.

The impetus to automate hospital parking lots is, as evidenced by the contract text, to encourage the issuing of parking violations. The parking lot operator is heavily incented to employ patrol staff that can issue as many violation notices as possible. Incredibly, the PHSA document demands Impark collect on all violation notices it issues and then defines that revenue as theirs to keep. Not one dime of the standard \$80 parking ticket given out at local hospitals is retained by the Health Authorities. The hospital parking lot gig is likely a lucrative one for Impark. Meanwhile the Health Authorities seem content with the approximate \$3.50 per hour per parked vehicle from standard parking rates.

Background

Recommendation

We are investing \$11.8 million to improve access to treatments for people living with chronic conditions, adding 7 new drugs, and expanding coverage criteria for 5 existing ones, under our PharmaCare Special Authority program. These listing decisions are informed by a rigorous evidence-based national and provincial reviews.

Up to 4,900 people may benefit from these new listings and expanded coverage. This announcement is part of the \$33.5 million investment in new and expanded drug listings since Fall 2018. In addition, we invested \$15 million over three years to remove the age restriction for insulin pump coverage so that anyone living with diabetes who needs a pump has access to one.

Beyond new and expanded drug listings, our government's \$105-million investment over three years into Fair PharmaCare to reduce or eliminate deductibles and/or copayments for the first time in 15 years means that many families dealing with chronic diseases will have improved access to the medications they need. Since Jan. 1, 2019, these changes have been helping 240,000 lower-income families get the help they need with prescription drug costs, so they don't have to make a choice between treatments and other essentials like food or heat.

The first temporary beds were acquired in 2011 under the service agreement that allows Island Health to use additional capacity on a temporary basis. Reporter is working on a story about a woman who has been told she can't bring her therapy dog into a grocery store, after having previously been permitted to do so. In the email below, Fraser Health confirms that the current health act prohibits such animals.

Background

Recommendation

British Columbia has several laws that address access rights for persons with disabilities who require the use of trained guide dogs and service dogs, including the Food Premises Regulation, the Guide Dog and Service Dog Act, and the BC Human Rights Code.

Section 25 of the Food Premises Regulation permits the operator of a food premise to allow a guide dog or service dog on the premises, but not in any area where the food is prepared, processed or stored. The operator may also allow any animal where a health officer determines it will not pose a risk of a health hazard.

For information on the B.C. Guide Dog and Service Dog Act, or certification, please contact the Ministry of Public Safety and Solicitor General.

The BC Human Rights Code protects persons with disabilities from discrimination, including those who require the assistance of guide dogs, service dogs or therapy dogs because of their disabilities. Section 8 of the Code prohibits discrimination in the provision of services, such as those provided by retail stores, restaurants and other services customarily available to the public. Under section 8, a service provider must

not discriminate against a person with a disability without a bona fide and reasonable justification such as a health or safety reason.

Interior Health

Allan Louis: Allan Louis is the owner of Maximum One Venture. Previously, he worked as a manager for Vernon Travel Lodge. He has also worked as the security manager for Casino of the Rockies and as a service advisor for Cranbrook Dodge. Active in his community, Mr. Louis serves as a councillor of the Okanagan Indian Band, maintaining a focus on ideas and initiatives meant to benefit the membership. He is co-chair of the Aboriginal Education Committee for School District #22, recognizing First Nation interests and challenges with the current education model. In addition, he is an active member of the First Nation Health Council, working together with local, provincial, and federal governments to achieve innovative ways of delivering health services to First Nations. Mr. Louis attended Okanagan College.

Island Health

Alana Nast: Alana Nast is a chartered professional accountant from Victoria. After graduating from the University of Victoria in 1983 with a bachelor's in Economics, she entered articles with the Office of the Auditor General of B.C. and received her designation in 1988. She worked for national accounting firms in Victoria for 13 years. She is currently a principal with Green Horwood & Co LLP chartered professional accountants where she continues to operate her accounting practice.

Fred Pattje: Mr. Pattje is a retired councillor of the City of Nanaimo. As a councillor, he chaired committees on public safety, city planning, arts & culture, and parks & recreation. He was also an alternate director of the Regional District of Nanaimo. Mr. Pattje previously worked for Canadian airlines in various positions including marketing and sales. Mr. Adam represented the Lake Babine Nation for over 27 years in different capacities, including serving as chief for 17 years. He has also been elected six times as Commissioner of the B.C. Treaty Commission.

John Kurjata: John Kurjata is a senior partner in the accounting firm of chartered professional accountants, a public accounting firm with an office in Dawson Creek, B.C. Before studying to become a certified accountant, Mr. Kurjata owned and managed businesses in the trucking industry. He is currently a director on the Lake View Credit Union board of directors since 2015, elected chair in April 2018. He was also a board member of Community Futures Peace Liard for 15 years, including being part of the self-employment and loans committees, and was a past chair. Mr. Kurjata was appointed to the Northern Lights College board of governors in 2011, elected vice chair in 2012, and then was elected board chair in 2015.

Patricia Sterritt: Patricia Sterritt is of Tsimshian ancestry, belonging to the Gitga'at Tribe of Hartley Bay. Ms. Sterritt is currently retired and living in Prince Rupert. Prior to retirement, in her capacity as a community leader and social program director, she worked with multicultural organizations committed to serving people; building relationships, establishing communication strategies, and creating outreach programs.

Vancouver Coastal Health

Dr. Penny Ballem: Dr. Ballem is a clinical professor of medicine at UBC and a fellow of the Canadian Academy of Health Sciences. She has had a 35-year career as a health leader and academic clinician in B.C. She served as the BC deputy minister of health from 2001-2006. She also served as the city manager for the City of Vancouver from 2008-2015. She has extensive board experience, having served on public sector, non-profit and private sector boards. Marilyn Slett: Kawazi+ (Marilyn Slett) is a citizen of the Heiltsuk Nation and the elected chief councillor of the Heiltsuk Tribal Council. She is currently serving her third consecutive term as chief councillor, beginning in 2008 and following previous positions as tribal councillor and executive director of the Heiltsuk Tribal Council. She is also currently the president of Coastal First Nations, on the board of directors of the British Columbia Assembly of First Nations, the co-chair of the Wild Salmon Advisory Council to British Columbia, and she has served as the BC Women's Representative on the Assembly of First Nations Women's Council.

Provincial Health Services Authority

Donisa Bernardo: Donisa Bernardo recently retired as the financial secretary for the Hospital Employees Union, and served on its provincial executive for 20 years. Ms. Bernardo sits on a number of committees, including the Municipal Employees' Pension Committee, which appointed her to the Municipal Pension Board of Trustees in 2014 as primary trustee. Ms. Bernardo started her health care career as a pharmacy technician in 1984.

Sandra Harris: A program developer and advisor for social development at the Gitksan Government Commission, Sandra Harris is strongly committed to community development and lifelong learning. Born and raised in the Bulkley Valley (Smithers B.C.), she belongs to the Wet'suwet'en Nation of the Laksilyu, Little Frog Clan and carries the hereditary name, Wii Esdes. Ms. Harris has lived in the Skeena Watershed, in Gitksan territory for almost 20 years.

Ms. Harris is also an Indigenous Focusing Complex Trauma (IFOT) practitioner working with health, social and justice front line workers. This work helps her to share teachings about intergenerational trauma and grief and loss, supporting first responders, suicide prevention and debriefing supports, connecting to Indigenous strengths and resilience.

Dr. Kerry Jang: Dr. Kerry Jang is a professor of psychiatry at UBC, where he teaches in the medical school and conducts research on the causes of mental illness and urban health. He has authored or co-authored over 125 peer review papers, several chapters and three books. In 2008 he was elected to Vancouver City Council and

served for a decade before retiring from political life. During his time on council he initiated programs to assist the homeless and mentally ill, including establishing lower-barrier shelters, the Healthy City Strategy, modular housing, and local responses to the opioid and overdose crisis

Interior Health

Allan Louis: Allan Louis serves as a councillor of the Okanagan Indian Band, maintaining a focus on ideas and initiatives meant to benefit the membership. He is co-chair of the Aboriginal Education Committee for School District 22, recognizing First Nation interests and challenges with the current education model. In addition, he is an active member of the First Nation Health Council, working together with local, provincial, and federal governments to achieve innovative ways of delivering health services to First Nations. Mr. Louis is the owner of Maximum One Venture. Previously, he worked as a manager for Vernon Travel Lodge. He has also worked as the security manager for Casino of the Rockies and as a service advisor for Cranbrook Dodge. Mr. Louis attended Okanagan College.

Island Health

Alana Nast: Alana Nast is a chartered professional accountant from Victoria. After graduating from the University of Victoria in 1983 with a bachelor's in Economics, she entered articles with the Office of the Auditor General of B.C. and received her designation in 1988. She worked for national accounting firms in Victoria for 13 years. She is currently a principal with Green Horwood & Co LLP chartered professional accountants where she continues to operate her accounting practice.

Fred Pattje: Mr. Pattje is a retired councillor of the City of Nanaimo. As a councillor, he chaired committees on public safety, city planning, arts & culture, and parks & recreation. He was also an alternate director of the Regional District of Nanaimo. Mr. Pattje previously worked for Canadian airlines in various positions including marketing and sales. Active in his community, Mr. Pattje is a member of the board of the Nanaimo Conservatory of Music. He is also a founding member of the Departure Bay Neighbourhood Association. Wilfred (Wilf) Adam: Wilf Adam was born in Burns Lake, grew up in a small community called Pendleton Bay, and later returned to live in Burns Lake. Mr. Adam represented the Lake Babine Nation for over 27 years in different capacities, including serving as chief for 17 years. He has also been elected six times as Commissioner of the B.C. Treaty Commission. Adam is a co-founder of the Burns Lake Law Centre.

John Kurjata: John Kurjata is a partner at SKK an accounting firm based in Dawson Creek, B.C. Before studying to become a chartered professional accountant, Mr. Kurjata owned and managed businesses in the trucking industry. He is currently a director on the Lake View Credit

Union board of directors since 2015, elected chair in April 2018. He was also a board member of Community Futures Peace Liard for 15 years, including being part of the self-employment and loans committees, and was a past chair. Mr. Kurjata was appointed to the Northern Lights College board of governors in 2011, elected vice chair in 2012, and then was elected board chair in 2015.

Patricia Sterritt: Patricia Sterritt is of Tsimshian ancestry, belonging to the Gitga'at Tribe of Hartley Bay. Ms Sterritt served on the Harley Bay Band council from 1996 to 2005. She was Director of Social Services for the North Coast Tribal Council for ten years. Ms. Sterritt worked with multicultural organizations committed to serving people; building relationships, establishing communication strategies, and creating outreach programs. She was the primary point of contact for the bands with all provincial and federal government agencies and worked with federal department heads, staff and university faculty to develop curriculum for band social workers that resulted in the Uvic Social Work Degree Program in the North.

Vancouver Coastal Health

Dr. Penny Ballem: Dr. Ballem is a clinical professor of medicine at UBC and a fellow of the Canadian Academy of Health Sciences. She has had a 35-year career as a health leader and academic clinician in B.C. She served as the BC deputy minister of health from 2001-2006. She also served as the city manager for the City of Vancouver from 2008-2015. She has extensive board experience, having served on public sector, non-profit and private sector boards. She has received significant public recognition for her work in medicine and public service including the Queens Golden Jubilee Medal for Public Service, the 2012 Wallace Wilson Award for leadership, the Marion Powell Award from Women's College Hospital for leadership in Women's Health, the Cannell Award from the Society of Obstetricians and Gynecologists of Canada for her contributions to leadership in reproductive health and others. She advises governments across Canada on health policy, health systems and health human resources

Marilyn Slett: Kawazi+ (Marilyn Slett) is a citizen of the Heiltsuk Nation and the elected chief councillor of the Heiltsuk Tribal Council. She is currently serving her third consecutive term as chief councillor, beginning in 2008 and following previous positions as tribal councillor and executive director of the Heiltsuk Tribal Council. She is also currently the president of Coastal First Nations, on the board of directors of the British Columbia Assembly of First Nations, the co-chair of the Wild Salmon Advisory Council to British Columbia, and she has served as the BC Women's Representative on the Assembly of First Nations Women's Council.

Provincial Health Services Authority

Donisa Bernardo: Donisa Bernardo recently retired as the financial secretary for the Hospital Employees Union, and served on its provincial executive for 20 years. Ms. Bernardo sits on a number of committees, including the Municipal Employees' Pension Committee, which appointed her to the Municipal Pension Board of Trustees in 2014 as primary trustee. Ms. Bernardo started her health care career as a pharmacy technician in 1984.

Sandra Harris: Sandra Harris is a program developer and advisor for social development at the Gitksan Government Commission. Ms. Harris is strongly committed to community

development and lifelong learning. Born and raised in the Bulkley Valley (Smithers B.C.), she belongs to the Wet'suwet'en Nation of the Laksilyu, Little Frog Clan and carries the hereditary name, Wii Esdes. Ms. Harris has lived in the Skeena Watershed, in Gitxsan territory for almost 20 years. Ms. Harris is also an Indigenous Focusing Complex Trauma (IFOT) practitioner working with health, social and justice front line workers. This work helps her to share teachings about intergenerational trauma and grief and loss, supporting first responders, suicide prevention and debriefing supports, connecting to Indigenous strengths and resilience.

Dr. Kerry Jang: Dr. Kerry Jang is a professor of psychiatry at UBC, where he teaches in the medical school and conducts research on the causes of mental illness and urban health. He has authored or co-authored over 125 peer review papers, several chapters and three books. In 2008, he was elected to Vancouver City Council and served for a decade before retiring from political life. During his time on council he initiated programs to assist the homeless and mentally ill, including establishing lower-barrier shelters, the Healthy City Strategy, modular housing, and local responses to the opioid and overdose crisis.

Her role as director oversees 23 programs that help the community address the needs of individuals with language and cultural barriers and assist thousands of immigrants and refugees integrate into community life each year. She has also worked as a freelance journalist with a master's degree in political science from the University of Delhi, and a diploma in print journalism from the London School of Journalism. Manpreet is the vice president of the Affiliation of Multicultural Societies and Service Agencies of BC board, director for the Social Planning and Research Council of BC board, trustee for the Fraser Valley Health Care Foundation and board director for Prospera Credit Union.
