Teen mental health is rampant; not just in Nanaimo, but all over Canada. It is heart breaking to see the lost kids walking around the streets, with their hoodies pulled up over their heads to help them hide.

When these same kids were babies and up to coming age of sixteen they are nurtured by their parents; they are taken to doctors when they are sick, to hospitals when they are broken but once they become sixteen they are expected to take care of themselves. If they have mental illnesses they are to know and understand how to care for their illness and themselves. If they need a medication the parents are asked to leave the doctors office and the teen is treated. What I am getting at is once the kid reaches sixteen they are no longer under the care of their family.

These kids are guided by peer pressure, hormones, fear and intimidation. They have never learned how to care for themselves; not in schools nor at home. If the family tries to still intervene in a child's life they are told by law enforcement to step away as the kid is sixteen.

Most kids, especially kids with mental illness, have no idea how to handle money, feed themselves, how to work; nothing; but they are considered adults.

They suffer different mental diseases and have no idea what to do so they turn to street drugs. Now this is when politicians step in; they supply these kids with clean needles and drug kits in case they over dose, how considerate of them.
