Have you heard anything from the Province on my Cancer treatment? The Yttrium -90 treatment was completed by Vancouver General Hospital on June 21. This procedure was recommended by Dr. Paul Klimo my oncologist as the chemotherapy was failing by my blood test results.

Attached is the receipt from the hospital. As you can see this was a very expensive procedure. Why was this not covered by the BC medical? This procedure has been around for 15 years or so. I believe BC Medical should be covering this type of procedure as it is critical for life!
