#### Achieving results and delivering more MRI exams

VICTORIA – People throughout B.C. will continue to get improved access to magnetic resonance imaging (MRI) exams as government adds 15,000 more exams in the second year of the B.C. Surgical and Diagnostic Imaging Strategy after exceeding its first year targets.

"I'm proud to say that we have surpassed our bold MRI targets in year one of our plan, performing s.13 more exams compared to 2017-18," said Health Minister Adrian Dix. "Our Surgical and Diagnostic strategy has improved services for patients, through capitalizing on existing public health resources, and adding new capacity where required. We are now taking further action to expand services and reduce waits by adding another 15,000 MRI procedures to this past year's success."

In the first year of the strategy the number of MRIs performed reached s.13

In 2017-18, <sub>S. 13</sub> 189,376 exams were performed.

In 2019-20 a further \$5.25 million is being added to complete s.13 exams annually.

Under the strategy launched last year, government invested \$11 million of ongoing funding to substantially increase this number of exams.

"Our government has been very clear that the commitment announced last March to improve access to MRIs was not a one time effort, but part of a multi- year strategy to reduce waits and leverage solutions and capacity in the public health-care system. We have seen some great results in just the first year, which we will continue to build off in year two so more and more patients can receive faster and more appropriate care. Simply put, we are just getting started," added Dix.

Reaching and exceeding the 2018-19 MRI targets involved in part running existing machines longer by adding evening, s.13 weekend and/or statutory holiday shifts to the existing MRI units. At the start of 2019, of the 33 MRIs across B.C, 10 were running 24/7 compared to one in August 2017, 17 more than 19 hours a day.

s.13 Fraser Health purchasing two private MRI outpatient clinics in September 2018, as part of government's Surgical and Diagnostic Imaging Strategy. An MRI machine also began operating at Kootenay Boundary Regional Hospital in Cranbrook. s.13 s.13

Since October 2018, Vancouver Coastal Health, Fraser Health and Providence Health Care have processed MRI requests through a central intake system, which is helping streamline the MRI referral process,

eliminate duplicate referrals and reduce missed appointments. The combined benefits gives patients more options of where and when they can undergo a procedure.

In addition to increasing capacity, the Ministry of Health continues to work with health authorities to find ways to make sure referrals for MRI are the most appropriate test, and that the quality of exams are consistently high to ensure patient safety and reduce the need to repeat them and take up more valuable time.

MRI is one of the tools used to diagnose a number of medical conditions, including abnormalities of the brain, as well as tumours, cysts and soft-tissue injuries in other parts of the body. An early diagnosis can lead to early treatment, which can positively impact people's quality of life and return them to being contributing members of their communities and the economy.

#### Mail out to Parents/Guardians

IHA has mailed out 130,000 letters to parents/guardians providing information about the Measles Immunization Catch-Up Program, and is preparing consent packages for distribution to students in Grades 1-12. Expected approximately 20,000 children are not up-to-date for age. Circulation of consent packages is expected week of April 22, 2019.

#### School Clinic Immunizations

- There are over 400 schools in IHA. School clinics will occur over approximately an 8 week period, with an average of about 50 school clinics each week.
- Routine grade 6 & 9 immunization clinics have been ongoing throughout the year using personalized consents, which
  allows for MMR catch up of school kids who are not up to date with two MMR doses as per BC Immunization Schedule.
- Public Health Nurses have started to book their school clinics as the timing of consent package availability has been
  determined. School clinics require the personalized consent to be distributed to children/ families at least 1 week in
  advance of the scheduled clinic.
- Students who do not attend a physical school e.g. home schooled, have been identified. These students will be directed to their local health centre for immunization.

 All unimmunized/under-immunized kindergarten students will be immunized in health centres and offered all catch-up vaccines including a measles-containing vaccine

#### Community Health Centre Immunizations

- · Interior Health will provide measles containing vaccine through more than 40 community health centres.
- Drop in immunizations for the target population (5-18 years of age) are available at all IH health centres.
- Clinics are running Mon-Fri during business hours across the region at all IHA public health locations. Normally, IHA
  would require appointments, however, IHA has staffed the clinics to be able to accommodate drop-ins as part of the
  measles catch up program.

 Island Health plans to send approximately 26,000 letters to parents/guardians providing information about the Measles Immunization Catch-Up Program the week beginning April 15, 2019.

#### **Northern Health Authority**

#### Mail out to Parents/Guardians

- On March 29<sup>th</sup>, NHA sent letters via all public school superintendents and independent school authorities to all parents/guardians of K-12 students, informing them of the upcoming campaign.
  - Consent packages will be sent April/May to the estimated 10,380 parents/guardians of children that have no record or require one or two doses of measles vaccine prior to scheduled school clinics.

#### School/Community Clinic Immunizations

- NHA has asked for their Campaign related doses to be delivered from BCCDC from April 29<sup>th</sup>. Following that
  vaccine drop and consent packages provided, NHA will begin their school and community clinics.
- Quesnel School District (19 public schools; 3 independent), immunizations will be provided primarily within
  the school setting. Children also have the option to attend a clinic, which operates Monday through Friday from
  0900-2000. Ongoing assessment of uptake via school clinics will occur to determine whether there are any
  additional needs.
- Prince George School District (45 public schools; 9 independent schools) will offer school clinics as well as
  evening/weekend clinics to provide options to access immunization further to this campaign. Prince George
  operates a regular drop-in clinic Monday through Friday from 0830-1600. Appointments can also be booked
  with the booster clinic which operates twice weekly, Monday mornings 0830-1200 and Friday afternoons at
  1300-1600.

#### Achieving results and delivering more MRI exams

VICTORIA – People throughout B.C. will continue to get improved access to magnetic resonance imaging (MRI) exams as government adds 15,000 more exams in the second year of the B.C. Surgical and Diagnostic Imaging Strategy after exceeding its first year targets.

"I'm proud to say that we have surpassed our bold MRI targets in year one of our plan, performing s.13 more exams compared to 2017-18," said Health Minister Adrian Dix. "Our Surgical and Diagnostic strategy has improved services for patients, through capitalizing on existing public health resources, and adding new capacity where required. We are now taking further action to expand services and reduce waits by adding another 15,000 MRI s.13 to this past year's success."

In the first year of the strategy the number of MRIs performed reached **s.13** s.13 In 2017-18,

s.13 189,376 exams were performed.

In 2019-20 a further \$5.25 million is being added to complete s.13

s.13 exams annually. Under the strategy launched last year, government invested \$11 million of ongoing funding to substantially increase this number of exams.

"Our government has been very clear that the commitment announced last March to improve access to MRIs was not a one time effort, but part of a multi-year strategy to reduce waits and leverage solutions and capacity in the public health-care system. We have seen some great results in just the first year, which we will continue to build off in year two so more and more patients can receive faster and more appropriate care. Simply put, we are just getting started," added Dix.

Reaching and exceeding the 2018-19 MRI targets involved in part running existing machines longer by adding evening, **s**.13 weekend and/or statutory holiday shifts to the existing MRI units. At the start of 2019, of the 33 MRIs across B.C, 10 were running 24/7 compared to one in August 2017, 17 more than 19 hours a day.

s.13 Fraser Health purchasing two private MRI outpatient clinics in September 2018, as part of government's Surgical and Diagnostic Imaging Strategy. An MRI machine also began operating at s.13 Hospital in Cranbrook. s.13 s.13

Since October 2018, Vancouver Coastal Health, Fraser Health and Providence Health Care have processed MRI requests through a central intake system, which is helping streamline the MRI referral process, eliminate duplicate referrals and reduce missed appointments. The combined benefits gives patients more options of where and when they can undergo a procedure.

In addition to increasing capacity, the Ministry of Health continues to work with health authorities to find ways to make sure referrals for MRI are the most appropriate test, and that the quality of exams are consistently high to ensure patient safety and reduce the need to repeat them and take up more valuable time.

MRI is one of the tools used to diagnose a number of medical conditions, including abnormalities of the brain, as well as tumours, cysts and soft-tissue injuries in other parts of the body. An early diagnosis can lead to early treatment, which can positively impact people's quality of life and return them to being contributing members of their communities and the economy.
