### **Families and seniors receive more help to pay rent**

NEW WESTMINSTER – Low-income families and seniors in British Columbia needing help to pay rent in the private market will benefit from enhancements under two provincial rental assistance programs.

As part of the British Columbia government's 30-point housing plan, the Province is expanding eligibility and increasing benefits under the Rental Assistance Program (RAP) and Shelter Aid for Elderly Renters (SAFER).

"Too many British Columbians still aren't able to enjoy the peace of mind that comes with having secure rental housing," said Selina Robinson, Minister of Municipal Affairs and Housing. This is one of the significant steps our government is taking to make housing more affordable for low-income families and seniors in communities throughout the province." DRAFT

Effective Sept. 1, 2018, as a result of increased rent ceilings across the province, low-income families and seniors will be eligible for additional cash assistance to help with their monthly rent payments in the private market.

The average monthly payment for SAFER recipients will increase by approximately \$78 (from \$187 to \$265).

Under the Rental Assistance Program, the maximum gross household income is being increased from \$35,000 to \$40,000, and the average monthly subsidy for recipients is increasing by approximately \$67 (from \$405 to \$472).

These enhancements will benefit 35,000 B.C. households, which includes an estimated 3,200 newly eligible low-income households.

"Many of the seniors we work with are having a tough time meeting ends meet. The increase to SAFER subsidies is great news for seniors on a fixed income across the province who have been struggling to pay their rent."

#### **Quick Facts:**

- The Province is providing \$116 million over three years to expand eligibility and increase the average benefits under the Rental Assistance Program and Shelter Aid for Elderly Renters (SAFER).

- The enhancements include increasing the maximum rent ceiling and adding a third rental zone for both programs (see backgrounder).
- This funding is part of Budget 2018, which launched the most significant investment in housing affordability in B.C. history – more than \$7 billion over 10 years.
- The rental assistance programs reimburse part of the difference between 30% of income and the household rent (up to maximum rent ceilings).
- The Rental Assistance Program provides eligible working families earning up to \$40,000 a year (effective Sept. 1, 2018), direct assistance to help them in meeting monthly rent payments in the private market. Currently, approximately 9,250 families receive assistance.
- SAFER provides direct cash assistance to eligible residents who are age 60 or over to assist them in meeting their monthly rent payment in the private market. Currently, approximately 23,200 senior households receive assistance through SAFER.

Thanks Gurbrinder! The topic is vaccinations for seniors and the meeting would be with myself and Dan Kennedy the Director of Government Relations for Sanofi. Sanofi Pasteur is a vaccine manufacturer and they are in the process of preparing for the upcoming fall influenza season. This season is expected to hit seniors particularly hard (there was a fair bit of media about this last week you may have seen <https://globalnews.ca/news/5496436/flu-season-ontario/>) so Sanofi is in the process of briefing government and other stakeholders on the various vaccine options available specifically for seniors (i.e. different than a regular flu shot) well in advance. This would be an informational/courtesy briefing for Anne in light of her Parliamentary Secretary for Seniors role and we'll also be meeting with officials and staff at the BC Centre for Disease Control, health authorities, ministry staff, etc. I am in Victoria and Dan is in Vancouver so either side of the water would work for us (I also work for Helijet! ☺) – whichever works best. If Anne is planning to be in Victoria at any point in the coming few weeks that would be ideal, otherwise Burnaby is fine too. Would sometime August 5 – 16 be an option? Next week is also a possibility if that is better on your end. Thanks – if you'd like any further details or info just let me know!

### **More choices, stronger protection for people in assisted living**

SURREY— People in assisted living residences, including supportive recovery homes, will have access to more care options and added protection as amendments to *Community Care and Assisted Living Act* come into force.

Effective December 1, 2019, changes to the *Community Care and Assisted Living Act*, and new regulations, will give seniors and other residents the flexibility and independence to stay and age in their home community, while still ensuring that they get level of care they need.

"Many seniors in the past have had to make the difficult decision to leave their assisted living residence, which is their home, due to previous restrictions," said Health Minister Adrian Dix. "That's why we are empowering seniors and other residents with more independence to make choices about where and how they live and receive care."

The amendments address the challenges of being to transfer to long-term care sooner than necessary because of the existing rules which limited assisted living residences to providing no more than two of the following prescribed services: assistance with the activities of daily living; managing medication; provision of and monitoring therapeutic diets; behaviour management; psychosocial supports; and safekeeping of money and personal property.

As a result, seniors who required more than two prescribed services were unable to continue living in assisted living residences, even though they may have been safe and may not have needed the more intensive care provided by long-term care homes. The amendment removes this restriction, creating more choices and opportunities for seniors to exercise their independence.

"We applaud this amendment, as we have heard from many seniors who wish to live independently, in a secure, safe and home-like environment," said Anne Kang, Parliamentary Secretary for Seniors. "We are glad to be able to make this positive change happen for them."

Additional amendments increase regulatory oversight for assisted living residences including supportive recovery homes. Previously an assisted living residence could only be inspected when a complaint was received. Now the Province will have enhanced oversight powers to conduct routine and monitoring inspections in response to a complaint – and as general monitoring of a residence for compliance with the regulations. The Province can also now take immediate action, such as the suspension of a registration of an assisted living residence, attaching conditions to the registration, or vary conditions of that registration, without notice, if there is an immediate risk to the health or safety of a resident. With additional oversight, resident's health and safety will be better protected.

"When people and their families turn to supportive recovery homes for help, they have the right to receive safe, quality care," said Judy Darcy, Minister of Mental Health and Addictions. "With these new regulations, the Province is working to ensure that the health and safety of people on their recovery journey is front and centre when receiving the services they need."

As well, new regulations will also increase accountability and oversight of supportive recovery homes throughout B.C. by ensuring employees have necessary skills and training, providing programs and policy information to people and families, supporting transition to connect to services and supports when leaving recovery homes, and developing a personal service plan for each resident's recovery.

The legislation also responds to reports from the B.C. Seniors Advocate and the Ombudsperson to improve service options for those individuals in assisted living residences. Consultation on regulations took place over the winter and spring with assisted living and supportive recovery home operators.

### Helping seniors live well

VANCOUVER – New funding will provide seniors better transportation options to help them maintain meaningful social connections and independence in their hometowns and neighbourhoods.

The Province is providing approximately \$1.23 million to 13 community organizations across British Columbia for projects that improve transportation services for seniors.

“Lack of access to transportation can increase social isolation, undermine an individual’s ability to complete daily activities ranging from grocery shopping, health appointments, and engaging in community programs that improve mental and physical wellbeing. That’s why we are taking steps to resolve this barrier,” said Adrian Dix, Minister of Health.

Community groups will purchase 12 buses and vans, and make other improvements to existing transportation services for seniors, with the funding.

“Healthy aging and maintaining independence are priorities for seniors. As part of our government’s multiyear seniors’ strategy supported by Premier John Horgan, through the health authorities, the Ministry of Health is supporting non-profit organizations throughout B.C. to provide seniors better access to services within the community they live through improved transportation options,” said Dix.

“Seniors are the hearts of our communities and they deserve to get the support they need to live their healthiest lives,” said Anne Kang, Parliamentary Secretary for seniors and multiculturalism. “By increasing transportation within the community, seniors will better be able to live independent lives and stay physically and socially active.” **[NOT APPROVED]**

In addition to improving transportation programs, the Province will also support seniors with projects that address social isolation, nutrition needs and active movement services, to help maintain independence, functionality and quality of life. That support includes \$300,000 provided through Northern Health to three local organizations, which were also announced today.

“Something’s always missing until you share it with someone else,” said Dix. “There’s a difference between living, and living well, and we are looking forward to announcing additional projects for seniors in the future.”

Supporting seniors’ transportation and social programs is part of government’s commitment to strengthen the supports and services available to seniors. Government is investing \$1.018 billion over three years to improve care for seniors, including investments in primary care, home health, long-term care and assisted living. This includes \$75 million over the next three years to expand respite care and adult day programs and \$240 million over three years to increase staffing levels in long-term care homes, with the goal of achieving 3.36 direct care hours per resident day – on average – across all health authorities by the end of 2020-21.
