This report provides a summary of initiatives undertaken by the N95/PPE Supply Management Sub Working Group.

Beginning on June 15, this report will be compiled every 2 weeks to coincide with the meeting frequency of the COVID-19 IPAC/WHS Provincial Working Group.

Sub Working Group: Scope & Deliverables

- 1. Continue to source and secure regular N95 respirator models.
- 2. Identify and secure a supply of appropriate alternative respiratory protection including alternative N95 respirator models and reusable respirator models. Identify and share strategies for controlling department access and distribution.
- 3. Create provincially-coordinated and consistent implementation strategies for alternative respiratory protection.
- 4. Develop an enhanced provincial respirator supply status report, with appropriate metrics and analysis, for the Provincial Coronavirus Coordination Committee.
- 5. Develop a long-term plan for creating and sustaining a provincial respiratory protection pandemic stock.

Refer to the <u>Supply Chain COVID-19 Dashboard</u> for PPE quantities on hand, daily usage, incoming inventory shipments, consumption, and health authority shipments.

- <u>Alternative N95 Reviews Completed</u>. This section provides an overview of the assessments completed for Alternative N95s models (defined as any filtering facepiece respirator model other than the N95 models regularly used in BC health authorities) to determine their appropriateness for use.
- <u>Deployed Alternative Respiratory Protection</u>. To mitigate demand on regular N95 respirators, alternative respiratory protection deployment began in Health Authority departments in February and continues as appropriate devices in required quantities are received. This section provides an overview of the locations targeted, the type of alternative respiratory protection utilized, and the status of deployment.
- <u>Alternative PPE Assessment Inspection</u>. PPE supply that meets the following situations will be assessed and inspected. Regular PPE from known supplies does not go through this process.
 - Alternative PPE (Health Authority Sourced)
 - Unknown (New) Products from Known Suppliers
 - Products from Unknown Suppliers
 - Donated PPE (non-Health Authority Sourced)
 - Fabricated PPE

N95 Fit-Test Equivalencies

On May 28th, updates were applied to the *WorkSafeBC Guidelines Section G8.40(2.1)(c) Single-use respirators and fit test equivalency*. WorkSafeBC removed the requirement for them to approve model equivalencies and placed the responsibility on the employer. The updated language reads:

'For WorkSafeBC to consider the respirator models to be equivalent for the purpose of fit testing, the respirators will need to have been produced by the same manufacturer. Also, there will need to be a statement from the manufacturer that is available to employers stating that the respirators are identical for fit purposes, and that the manufacturer recognizes that a fit test for one of the respirators is suitable evidence of adequate fit for the other respirator.

It is the employer's responsibility to consult with the manufacturer of the respirator to obtain this information and to note this in its respirator program.'








