The COVID-19 pandemic has created unprecedented challenges for our public health system and we are always looking at ways we can use additional data to inform how we support people who are most vulnerable to severe illness. We recently hired hundreds of new contact tracers to prepare for increasing transmission in the fall and winter, but the rapid transmission surge in recent weeks – and the high number of contacts for some people who test positive – is stretching our capacity.

Transitioning our systems to accommodate the additional data collection in the new federal form would create logistical challenges and require developing protocols to ensure the responsible use of this kind of the new information — and ultimately is not feasible right now. We continue working with our national counterparts to move towards more race-based data collection in B.C., and support other methods, including public engagement and surveys, to collect disaggregated data to help determine the impact on different populations — but our primary resources have to be directed to managing the pandemic at this time. We urge all British Columbians to reduce their social contacts outside of work and school so we can bend the curve down again.
