At the bilateral meeting with the BC IMC team, you provided an update on priorities and your responsibilities related to COVID-19. Given this, Bob and I thought it was important to keep you in the loop on Pfizer's communications with Minister Dix. This email is just for your information with no action required on your part.
In April and July Cole Pinnow, President, Pfizer Canada sent meeting requests to Minister Dix regarding Pfizer's support of the BC's COVID-19

priorities. Perhaps the lack of response could be attributed to timing. Regardless as there have been further advancements toward a medical solution and meetings have taken place with a number of provinces, Cole felt it was important revisit his offer of a meeting. Dear Minister:

Congratulations on your re-appointment as Minister of Health. There are many challenges facing the health care system, and your experience and commitment to patient care will provide continued confidence to stakeholders.

On April 9 and July 23, I wrote to inform you of Pfizer's progress to develop a medical solution against COVID 19 and extended an offer to virtually meet with you to discuss confidential details of our COVID 19 vaccine candidate in order to assist British Columbia plan with their immunization strategy. We are now in advanced discussions with the federal government and other provincial Ministers of Health (including Alberta, Saskatchewan, Manitoba, Ontario and Quebec) to help them establish readiness for administration of a vaccine, should it be approved by Health Canada.

My offer to meet with you remains. Given the role that government decision makers will have in securing access to a COVID 19 vaccine, awareness and knowledgeable of the medical and logistical details of the vaccine candidates are essential. Please let me know if you would like to arrange virtual a meeting with you and/or your ministry officials.
