Hi Brian – thank you for your willingness to look at this – it is very much appreciated. Our deadline for finalizing capacity limits is early December. We need to land them by then to open our website and reservation reservations in December and January.

I believe Jim forwarded you the specific question with regards to our capacity limits on double sites. We used to allow those to be divided and sold in halves to separate unconnected camping parties. This year and going forward, we are renting them as one unit for one connected party of campers but need to land the max. number of occupants. I'm not sure if Jim mentioned our group camping sites – we repurposed those this year for extended families/bubbles of 16. We plan to keep that in place for the coming year with a slightly revised capacity limit of 20 + 5 daytime guests.



As part of the exploration of travel restrictions (as reported in media today) BC Parks has been asked to take a decision to the COVID DM committee next week on the restriction/limiting camping opportunities to BC residents as we attempted last year. A key piece of the analysis will center on health drivers. I understand that there has been advice provided that speaks against interprovincial travel restrictions for COVID reasons and I am looking to get your thinking/advice/direction regarding whether there might be a valid COVID benefit to restricting camping opportunities to BC residents. We are on a very tight timeline so any advice you can provide today will be incorporated into the draft DN. Sorry for the rush request but we were given little lead time and your advice will be invaluable in advising on the potential for continuing these measures.

Hello, Brian,

Thanks for providing the background and map to help with thinking about what might be an appropriate loading of people on a double campsite.

Some assumptions:

- Develop the maximum number of campers, N, that could be safely accommodated in a double campsite during the COVID pandemic.
- Base this number N on the most congested use of space during a camping event.
- Highest and most congested use would likely be around one of the two campfires, with all parties from the double campsite around the single fire. (Clearly use would depend on age of campers, frequency of camping at that campground etc. There may be another fire in the other pit for people of a certain age (teens, young adults), so the campers may not all gather around one fire. They may also go to another campsite.) For the purpose of estimating safe numbers, the highest level of congregation is used.
- Care should be taken not to assume 14, 16 or 20+ people are in the same bubble. We are speaking of the safe 6, and if 20 people were to camp together (and have guests) there are times when congregation would be likely to occur. Most of the campers are unlikely to be in the same bubble.
- Gathering around the campfire is likely to include some consumption of alcoholic beverages which tends to reduce inhibitions and may result in reducing physical distancing without masks.

Some data and formulas:

- V=Venue area, or the total area in which people could gather, and includes encumbrances on which people could not gather.
- V is assumed to be the entire area hatched on the plan, plus the small 35 degree wedge, plus the 1 m ring on the outside of the semicircle, (see left hand campsite in the double campsite-this would be a full half circle of radius of at least r=5.3m+1 m=6.3 m^2 .
- Total venue area that would be most likely be used would be $V=\pi r^2/2$, i.e. half circle.
- E= Encumbered area would be based on picnic table(s), fire pit, other encumbrances such as chairs, other tables, cooking, cooler and other supplies, toys etc.
- Picnic table with built in benches assumed to be about 4m² (for purposes of this example), assume two tables.
- Area of the fire pit estimated as 3.1m², using a radius of the fire pit of say 0.75m plus 0.25m from edge of pit to people, to get encumbrance from the pit),
- Cooler, assumed to be on the ground, could consume an estimated 0.35m²
- Cooking equipment could consume an estimated 1.5m²
- Park staff may see some regular encumbrances- sporting equipment, air mattresses etc., so should consider adding these when making a decision about how much space in available.
- A= Area on which campers could be together while safely distancing, e.g. a campfire. A=V-E.
- C= Area campers need to maintain physical distance, i.e. 2m separation, C=5m²/person
- N= Number of campers that can be safely accommodated in a double campsite, N= A/C.

Some calculations:

Let's calculate how many people can be in the campsite.

First we need the unencumbered area on which people can meet, at the most congested event.

So A= Venue area, V, minus the area of the Encumbrances. A=V-E.

Assuming all campers are in the half circle on the plan, which includes the fire pit would be A= V-E, or around the fire pit

Venue area, $V=\pi r^2/2=\pi \times 6.3^2/2=62.3 \text{ m}^2$ (this would be larger if the 6.1m radius were used instead of the 5.3 m radius-see plan of campsite- choosing the most conservative approach in this example).

Encumbered area = $[2 \times (A \text{ of table})] + [A \text{ of firepit}] + [A \text{ of cooking equipment}] + <math>[3 \times (A \text{ of coolers})] = (2 \times 4m^2) + (1 \times 3.1m^2) + (1 \times 1.5m^2) + (3 \times 0.35m^2) = 8m^2 + 3.1m^2 + 1.5m^2 + 1.05m^2 = 13.65m^2$

So area for campers A= V-E= $62.3 \text{ m}^2 - 13.65 \text{ m}^2 = 48.65 \text{ m}^2$.

The Camper area, C, is the area needed for each camp to maintain physical distance of 2m from other campers, i.e. C= 5m²/person.

Maximum number of campers that could physically distance $=A/C=(48.65m^2)/(5m^2/camper) = 9.73$ campers, i.e. here, use 10 campers.

So let's explore:

Given that people will be outdoors, with fresh air, could the space per camper be reduced? Possibly, if all conditions were perfect. The nature of campsites is that they are not gym floors, with smooth surfaces. Campers are there for fun and adventure and are not likely to walk around with arms outstretched to ensure 2m of physical distancing.

If a group of 14 people were to camp in a double campground, we can assume that there would be 3 or more families or groups together. IF there were four groups of say 4, 4, 3, and 3, then there could be some economy of space, and the 10 campers could increase IF the people also stayed in their family groups.

The key question is, however, how likely are people to stay in their family groups if they went to the same campground to be together? Not terribly likely.

How likely are campers to wear masks if the PD of 2 m were not possible to maintain? Consider that they would be eating smores and consuming some alcoholic beverages in the outdoors in front of a fire at night.

If a double campsite required the campers to be split into groups so there would be two campfires, then the site could accommodate 20 people who physically distanced. Would people naturally segregate? Depends on the demographics. Teens might be happy to have their own fire; young adults would most likely seek one fire so they could socialize- that's why they chose to hike and camp together; families with children would not be likely to want to have young children out of sight at night in a campground.

This campground scenario is somewhat reminiscent of the vacation rental accommodation scenario. People are essentially moving into the campground as vacation accommodation, so current requirements for spacing in rental vacation accommodation (i.e. family and no visitors) or less stringent requirements of 5m²/person might be considered in setting limits.

While many daytime activities would likely take place out of doors, with lots of space, bad weather could see many of the campers congregating in one area, such as an RV or large tent or tarped area for games etc. By allowing more people on the double campsites than is currently allowed under COVID conditions, there could be increased risk of exposure to the SARS-CoV-2 virus.
