Q10. The BC NDP promised free contraception if elected. Why is this important?

- Government is committed to improving access to prescription drugs for British Columbians.
- Cost should not prevent individuals, particularly young people, from their right to make choices about their reproductive health.
- While condoms can be easily found for little or no cost, and vasectomies are covered under MSP, prescription contraception is not universally covered.
- Contraception providers identified cost (which falls disproportionately on women, trans and non-binary people) as the key barrier to access.
- Prescription contraceptives give people who need it more control over their reproductive health.

Q11. When will we see this enacted and what has been done so far?

- B.C. is committed to improving the health of women, trans and non-binary people, and has already taken steps to make prescription medication including contraceptives more affordable.
- PharmaCare fully covers a number of contraceptives including oral hormonal pills, hormonal injectables, and some
 intrauterine devices (IUDs.) Steps were taken to improve access to contraception through the major changes made
 to Fair Pharmacare in 2019.
- In January 2019, government invested \$105 million into Fair PharmaCare to reduce or eliminate deductibles, plus
 co-payments for 240,000 lower-income British Columbians for the first time in 15 years. Under these changes,
 individuals earning up to 30,000 net income no longer have a deductible, and thus can start to receive coverage for
 prescription medicines right away; those with a net income of up to 45,000 will start getting coverage sooner.

- Under these changes, lower income women, trans and non-binary people, which would include those in school and starting their careers, will have improved access to contraception. In addition, different clinics operated by Fraser Health and Vancouver Coastal Health provide access to low/ free contraception, as does the Options for Sexual Health clinics which are supported by the Provincial Health Services Authority.
- But we know there's more we can do to deliver better, more affordable access to health care in B.C. and we'll have more to say about making prescription contraception free soon.

TITLE: Universal Access to Free Prescription Contraception (UAFPC)

PURPOSE: To confirm scope and outline proposed work to make prescription

contraception free for all, while integrating GBA+ and anti-racism lenses

BACKGROUND:

The 2020 Minister of Health Mandate Letter includes a commitment to 'make prescription contraception free for all' BC residentsⁱ, to uphold all British Columbians' right to make informed choices about their sexual and reproductive health. The letter also directed the Ministry of Health (the Ministry) to address anti-Indigenous racism and discrimination in the health care system, including in reproductive health care as outlined in the recent "In Plain Sight" report. ii,iii A further commitment was made to apply Gender Based Analysis Plus (GBA+) to all health policy and budget decisions to ensure that all British Columbians have access to services and programs and benefit from investments.

While cost has been identified as the main barrier to accessing prescription contraception, additional barriers include lack of access to the full range of contraceptive methods available in Canada, lack of culturally safe, trauma informed and gender affirming contraceptive care, and/or lack of access to a trained contraceptive provider close to home. These barriers disproportionately impact Indigenous peoples, people of colour, immigrants and newcomers, trans and non-binary peoples, and those impacted by violence, including sexual assault. Addressing these barriers will ensure that the Ministry meets the diverse needs of BC residents to access contraception, and ensure that prescription contraception is truly available to all.

TITLE: Free Prescription Contraception

PURPOSE: To assess options and future considerations for providing fully-paid

coverage of prescription contraception.

BACKGROUND:

The Minister of Health's 2020 mandate letter includes the commitment to make prescription contraception free for all British Columbia residents. PharmaCare currently covers some oral contraceptives, certain hormonal intrauterine devices (IUDs) and hormonal intrauterine contraceptives, and an injectable product as regular benefits under Fair PharmaCare (Plan I), Recipients of Social Assistance (Plan C), and the First Nations Health Benefit Plan (Plan W). Fair PharmaCare coverage is income-based and PharmaCare only contributes to the cost of eligible medications after a family has paid their annual deductible. Additionally, some non-hormonal copper IUDs are covered only for First Nations Health Authority (FNHA) clients under Plan W.

Providing universal access to free prescription contraception represents a significant new cost to the PharmaCare program, although a robust academic study by the UBC-led Contraception and Abortion Research Team (CART) from 2018 forecasts that this upfront cost will be balanced by other reduced health system costs by the third year after implementation.
