Hi all.

I was just in the middle of responding. Here is my summary:

Our cluster related to Prespatou is continuing but slowing down considerably. We still have a large (for us) number of people in ICU related to that cluster. We just found out that one of those clients unfortunately is likely to be made palliative soon which would be the first covid related death in NH.

The cluster related to the exposure at the religious event in Deadwood Alberta is essentially over.

The very small cluster related to the funeral s.22 is also very quickly winding down, I think we had 4 cases related to that initial exposure and some close contacts to those cases test positive.

We have an emerging cluster now in Fort St. James/Nak'azdli (5 cases). We don't understand all the risks yet but it sounds like there were multiple events including a funeral that 2.2 or more cases attended. We are working with FNHA and local teams on this.

There are a handful of cases that are popping up with no clear exposure, almost entirely in the NE. I suspect there is some community spread in the Fort St. John area that could possibly be from the Deadwood and Prespatou clusters.

The support we most urgently need is for case/contact management, we are furiously training people to support this team so we will be better soon.

Thanks for checking, Bonnie. Let me try a quick summary, and check with the team.

We are having a few small groups of epi-linked cases, including in Nak'azdli community, as well as random cases particularly in NE.

They are adding up, while each group or case does not have significant cluster/outbreak potential at this point. Prespatou is still going on but more stable with less new cases outside close contacts. Nisgaa valley has no active cluster. Their SOLE is expected to end tomorrow.

No need for urgent provincial support for cluster management right now.

We are currently working hard to add capacity to NH's covid-19 case and contact team. As part of that, we will

collaborate with provincial plan.

Just following up to make sure you got this, and to let you know that I just heard from legal counsel that they are wanting the information by Jan 22 so that it can be compiled into one or more affidavits for submission to the court by Jan 29.

If that will not be possible the sooner we know the better, in case we have to ask for an extension. As I expect you might have to reach out to health authorities for information I anticipate that could be a delay.

I can confirm that Naomi will be doing the literature review, but as I said if someone at BCCDC has familiarity with the literature that would be good to know.

Also on another topic, who has taken over from Trevor wrt the international travel exemption file? We are getting requests that he was handling so wanting to redirect those requests to the appropriate public health physician at BCCDC.




