Dear CCMOH colleagues

Please advise if you have vaccinated all:

- 1. Provincial staff: yes, we had several outbreaks so offered all corrections staff vaccine a few weeks ago. Started with AZ when it became available and finished with Moderna
- 2. Federal staff: yes, as above, they have been eligible. Our understanding was that they were to be immunized by the province.
- 3. Provincial inmates and across all ages or as per age cut off: only by age/risk as they come in and out of provincial facilities so rapidly
- 4. Federal inmates and across all ages or as per age cut off: this is done federally. We had an outbreak in one institution (brought in from the guards) and offered AZ but CSC said no, they would provide Moderna.
- 5. Whether that has been done in anticipation or in response to outbreaks in corrections: They were a higher priority because of risk both personal and due to being in congregated settings and also because we had a series of outbreaks and when that happens they are really isolated and restricted to cells etc. so very difficult.
- 6. How could Astra Zeneca be used ethically and with informed consent in such situations. We suggested in the OB they be offered the choice but CSC made the decision not to

Presently the concerns noted below have only been amplified given the various presentations and commentary. The real risk of a serious AEFI can't be quantified & the clinical team would have real difficulty obtaining an informed consent when balancing the benefits of receiving AZ against the risk of waiting for Moderna, even in the present situation of staff cases. There obviously are going be subsequent decisions/advice by NACI, PHAC and the various other international regulatory authorities, so the decision has been made to not proceed with AZ but wait for the Moderna which CSC should receive April 14th.

Below are the highlights from the FPT ADM Committee on Testing, Contact Tracing and Data Management which took place earlier this afternoon. Actions items have been highlighted in yellow.

Update on Testing – Supply and Procurement: (Monique Frison, HC)

- Regulatory dept has approved extended shelf life for BD Veritor tests, applying to all tests sent to Canada including those received last year and those in inventory. By the end of this week, Canada will get 45,000 additional analyzers, which will help with the deployment those tests.
- Regarding Cepheid, HC has complied all inputs and will do more procurement decision-making but will provide conclusion soon.
- Health Canada will talk to Abbott re: ID Now to ask about extending shelf life from 6 months to one year.

<u>Update on Workplace Screening</u> (Chris Johnstone)

- The GoC is looking into a UK portal.
- Please advise Health Canada if there are plans for testing critical services, including those that serve vulnerable communities (e.g. volunteer firefighters, soup kitchen providers, etc.)
- HC is interested in knowing if PTs are supplying tests for staff at high-contact offices such as dental clinics, ultrasound facilities, or pharmacies.

<u>Update on the COVID Alert App</u> (Marc Fortin, HC)

• Approx 6.2 million people have signed up for the COVID Alert App in Canada. HC is looking to add additional languages on the app (currently it is offered in English and French); increase the metrics (e.g. breakdown by province/territory); and adding in QR codes so that users can use these to scan their location if they wish.

Guidance and Knowledge Sharing: (Nancy Hamzawi, HC)

• TAC is interested in any feedback on how to better engage on the Expert Panel reports (for example, by sharing materials such as rapid evidence reviews earlier).

• HC provided a summary of the guidance on rapid antigen tests: please let Health Canada know if there are any errors or omissions.

Roundtable:
